**AGREEMENT**

R/o..... under .....Tehsil in .....Anadaman (hereinafter referred to as **second Party**) of the other part whereby it is mutually and voluntarily agreed and accepted by and between the parties as follow:-

- 1) That first expression "first Party" and Second Party" shall Include their respective heirs executors, administrators, representative and assigns,
- 2) That first Party is the owner of land measuring an area of.....Sq Mtr.in survey no.....situated at .....village under.....Tehsil in.....andaman district.
- 3) That now the first party is desirous to spare an area of .....sq Mtr(our of the.....sq Mt) bearing survey no.....situated at.....Village under .....Tehsil in ..... Andaman District to the said second Party for Parking his Vehicle ,.....
- 4) That the said land can be used for parking the vehicle bearing No.....till its ownership is with the second Party.

In such event, the second Party shall be furnish alternate Parking area within a Period of three days the dates of termination of the agreement and get it enclosed in the permit.
