### NOTIFICATION

Port Blair, dated the 29th October, 2013

No. 235/2013/F.No. 20-1/Estt.AD(T) 2010.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with Govt. of India, Ministry of Home Affairs, New Delhi, Notification No.14039/2/83-ANL, dated 21st February 1985, and in pursuance of Union Public Service Commission Letter No. 3/30(II)/2013-RR dated 18.07.2013 and in supersession of Notification No. 89/F.No.42-152/85-TR dated 24th January, 1989, the Lieutenant Governor (Administrator), Andaman and Nicobar Islands, hereby makes the following Rules regulating the method of recruitment to the posts of Assistant Director (Transport) borne in the establishment of the Directorate of Transport, Andaman and Nicobar Administration, namely:

## 1. SHORT TITLE AND COMMENCEMENT :-

- These Rules may be called the Andaman and Nicobar Administration (Assistant Director (Transport) in the Directorate of Transport), Recruitment Rules, 2013.
- ii) They shall come into force on the date of their publication in the Official Gazette.

## 2. NUMBER OF POST, CLASSIFICATION AND SCALE OF PAY :-

The number of posts their classification and Pay Band & Grade Pay / Scale of Pay attached thereto shall be as specified in paras 2 to 4 of the Schedule annexed hereto.

# 3. METHOD OF RECRUITMENT, AGE LIMIT AND QUALIFICATIONS: -

The method of recruitment, age limit, qualifications and other matters relating to the said posts shall be as specified in paras 5 to 15 of the said Schedule.

## 4. DISQUALIFICATIONS: - No person —

- a) who has entered into or contracted a marriage with a person having a spouse living, or
- b) who, having a spouse living, has entered into or contracted a marriage with any person; shall be eligible for appointment to the said posts:

Provided that the Lieutenant Governor (Administrator), Andaman and Nicobar Islands, may, if satisfied that such marriage is permissible under the personal law applicable to such persons and other party to the marriage and there are other grounds for so doing, exempt any person from the operation of these rules.



#### 5. Power to Relax :-

Where the Lieutenant Governor (Administrator), Andaman and Nicobar Islands is of a opinion that it is necessary or expedient so to do, he may, by order and for reasons to recorded in writing, and in consultation with the Union Public Service Commission necessary, relax any of the provisions of these rules with respect to any class or category persons.

#### 6. Saving :-

Nothing in these rules shall affect reservation, relaxation of age limit and other concession required to be provided for candidates belonging to the Scheduled Castes / Scheduled Trib and other specified categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

(The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization / department of the Central Govt. shall ordinarily not to exceed three years. The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the date of receipt of application)

Note:- For the purpose of appointment on deputation basis, the service rendered on a regular basis by an Officer prior to 01.01.2006 (the date from which the revised pay structure based on the 6th CPC recommendation has been extended) shall be deemed to be service rendered in the corresponding Grade Pay/Pay Scale extended based on the recommendations of the pay commission except where there has been merger of more than one pre-revised Scale of Pay into one grade with a common Grade Pay /Pay Scale, and where this benefit will extend only for the post(s) for which is the normal /Pay Scale that Grade Pay replacement grade without any up-gradation.
