NOTIFICATION

Port Blair, dated the 4th June, 2010

No. 120/2010/F.No. 20-1/Estt/2009.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with Government of India, Ministry of Home Affairs, New Delhi, Notification No.14/3/60-ANI dated the 11th April, 1960, and in supersession of Notification No. 110/F. No. 42-35/76-TR dated 31st May, 1997, the Lieutenant Governor (Administrator), Andaman and Nicobar Islands, hereby makes the following rules regulating the method of recruitment to the post of Clerk-cum-Checking Inspector borne in the establishment of the Directorate of Transport, Andaman and Nicobar Administration, namely:—

1. SHORT TITLE AND COMMENCEMENT:-

- These Rules may be called the Andaman and Nicobar Administration (Clerk-cum-Checking Inspector in the Directorate of Transport) Recruitment Rules, 2010.
- ii) They shall come into force on the date of their publication in the Official Gazette.

2. NUMBER OF POST, CLASSIFICATION AND SCALE OF PAY:-

The number of post, their classification and Pay Band & Grade Pay/Scale of Pay attached thereto, shall be as specified in paras 2 to 4 of the Schedule annexed hereto.

3. METHOD OF RECRUITMENT, AGE LIMIT AND QUALIFICATION:-

The method of recruitment, age limit, qualifications and other matters relating to the said post shall be as specified in paras 5 to 15 of the said Schedule.

4. DISQUALIFICATION:-

No person-

- (a) Who has entered into or contracted a marriage with a person having a spouse living, or
- (b) Who, having a spouse living has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Lieutenant Governor (Administrator), Andaman and Nicobar Islands, may, if satisfied, that such marriage is permissible under the personal law applicable to such persons and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

POWERS TO RELAX:-

Where the Lieutenant Governor (Administrator), Andaman and Nicobar Islands is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing, relax any of the provisions of those rules with respect of any class or category of person.

6. SAVING:-

Nothing in these rules shall effect reservation, relaxation of age limit and other concessions required to be provided for candidates belonging to the Scheduled Castes, Scheduled Tribes and other specified categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Annexure -I

DUTIES AND RESPONSIBILITIES OF CLERK-CUM-CHECKING INSPECTOR

- To conduct surprise checking in buses, ensure punctuality in schedule trips, check pilferage of revenue / HSD. They shall also check and take remedial action for any type of irregularities in the schedule bus services.
- 2. Clerk-cum-checking Inspector shall maintain checking diary properly and submit the performance report in the prescribed format by the first week of subsequent months.
- To assist the Chief Inspectors/Traffic Inspectors / Station Masters of the station in carrying out the responsibilities of a unit or section under the Directorate of Transport.
- Clerk-cum-Checking Inspector shall perform all skilled as well as unskilled nature of works related to the traffic management.
- 5. Clerk-cum-Checking Inspector shall supervise and ensure proper cleanliness of the bus, correct display of destination boards etc.
- Clerk-cum-Checking Inspector when attached to cash collection counters/ ticket booking counters shall collect tickets, trip sheets and other relevant traffic materials from the ticket store and maintain records pertaining to these.
- Clerk-cum-Checking Inspector shall submit the sale proceeds to the cashier on the same day or the next working day positively.
- 8. Clerk-cum-Checking Inspector shall perform all office works including stocking and issuing the bus tickets either manually or electronically whenever asked to do so by the officer- in-charge.
- Clerk-cum-Checking Inspector shall perform the duty of in-charge of cash collection counter, enquiry counter, ticket booking counter, ticket store, out station units of STS, POL store/Dispening pump as and when entrusted.
- Clerk-cum-Checking Inspector shall be responsible for maintaining all records pertaining to the work they are entrusted with.

- SHORT TITLE AND COMMENCEMENT :-
 - These Rules may be called the Union Territory of Andaman and Nicobar Islands (Clerk-Cum-Checking-Inspector) Recruitment (Amendment) Rules, 2018.
