## NOTIFICATION

Port Blair, dated the 30th September, 2005

No. 276/2005/F.No. 42-594/2005-TR.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with Govt, of India, Ministry of Home Affairs, Notification No. 14/3/60-ANL dated 11<sup>th</sup> April, 1960 and in supersession of this Administration's Notification No. /89/F.No.42-251/89-TR dated 6<sup>th</sup> July, 1989, the Lt. Governor (Administrator), Andaman and Nicobar Islands hereby makes the following rules regulating the method of recruitment to the post of Chargeman borne in the establishment of the Directorate of Transport, Andaman and Nicobar Administration, namely:—

## 1. SHORT TITLE AND COMMENCEMENT:

- (i) These Rules may be called the Andaman and Nicobar Administration (Chargeman in the Motor Transport Department) Recruitment Rules, 2005.
- (II) They shall come into force on the date of their publication in the Official Gazette.

# 2. NUMBER OF POST, CLASSIFICATION AND SCALE OF PAY:

The number of said post, their classification and scale of pay attached thereto shall be as specified in paras 2 to 4 of the Schedule annexed hereto.

## 3. THE METHOD OF RECRUITMENT, AGE LIMIT AND QUALIFICATIONS:

The method of recruitment, age limit, qualifications and other matters relating to the said post shall be as specified in pares 5 to 14 of the said Schedule.

#### 4, DISQUALIFICATION: No persons-

- (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the said post:

Provided that the Lt. Governor (Administrator), Andaman and Nicobar Islands may, if satisfied, that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

## 5. POWER TO RELAX:

Where the Lt. Governor (Administrator), Andaman and Nicobar Islands is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect of any class or category of persons.

#### 6. SAVING:

Nothing in these rules shall effect reservation, relaxation of age limit and other concession required to be provided for candidates belonging to Scheduled Castes, Scheduled Tribes and other specified categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

No. 20-1/Estt./RR/2017.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with the Government of India, Ministry of Home Affairs, New Delhi, Notification No. U-14039/2/83-ANL dated 21st February, 1985, and in pursuance of PoPT's OM No. AB.14017/13/2016-Estt.(RR) dated 9/8/2016, the Lieutenant Governor (Administrator), Andaman & Nicobar Islands, hereby makes the following amendments to the Recruitment Rules to the post of Chargeman, Group -B (Non-Gazetted) borne in the establishment of Directorate of Transport, Andaman & Nicobar Administration published in the A & N Extraordinary Gazette Notification No. 76 dated 23/03/2010.

#### 1. SHORT TITLE AND COMMENCEMENT :-

- (i) These Rules may be called the Union Territory of Andaman and Nicobar Islands (Chargeman) Recruitment (Amendment) Rules, 2018.
- (ii) They shall come into force on the date of their publication in the Official Gazette.

#### **AMENDMENTS**

2. (i) The existing Column 4 of the Schedule appended to the Recruitment Rules (hereinafter called for brevity as the "said Recruitment Rules") shall be substituted as under:-
