**NOTIFICATION**

Port Blair, dated the 4<sup>th</sup> June, 2010.

No. 117/2010/F.No.20-1/Estt/2009.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with Government of India, Ministry of Home Affairs, New Delhi, Notification No. 14/3/60-ANI dated the 11<sup>th</sup> April, 1960, and in supersession of Notification No. 110/F. No. 42-33/76-TR dated 31<sup>st</sup> May, 1977, the Lieutenant Governor (Administrator), Andaman and Nicobar Islands hereby makes the following rules regulating the method of recruitment to the post of **MAZDOOR** borne in the establishment of the Directorate of Transport, Andaman and Nicobar Administration, namely:-

**1. Short Title and Commencement:**

- These rules may be called the Andaman and Nicobar Administration (Mazdoor) in the Directorate of Transport Recruitment Rules, 2010.
- They shall come into force on the date of their publication in the Official Gazette.

**2. Number of Posts, Classification and Scale of Pay:**

The number of post, their classification and Pay Band & Grade Pay/Scale of Pay attached thereto, shall be as specified in paras 2 to 4 of the Schedule annexed hereto.

**3. Method of Recruitment, Age limit and Qualification:**

The method of recruitment, age limit, qualifications and other matters relating to the said post shall be as specified at paras 5 to 15 of the said Schedule.

**4. Disqualification:**

No person

- Who has entered into or contracted a marriage with a person having a spouse living, or
- Who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post ;

Provided that the Lt. Governor (Administrator), Andaman and Nicobar Islands may, if satisfied, that such marriage is permissible under the personal law applicable to such persons and other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

**5. Power to relax :**

Where the Lt. Governor (Administrator), Andaman and Nicobar Islands is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing, relax any of the provisions of the those rules with respect to any class or category of person.

**6. Saving :**

Nothing in these rules shall affect reservation, relaxation of age limit and other concessions, required to be provided for candidates belonging to the Scheduled Castes, Scheduled Tribes and other specified categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

2. To undertake all works of unskilled nature as per the directions of the supervisors in the workshop, store, Bus Terminus, Office etc.
3. Clean and wash the buses regularly.
4. Undertake all other works entrusted by the superiors.
5. Shall undertake all skilled works on the instruction of the superiors which they have learnt by virtue of their experience.

No. 20-1/Estt./RR/2017.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with the Government of India, Ministry of Home Affairs, New Delhi, Notification No. 14/3/60-ANL dated 11/04/1960, and in pursuance of DoPT's OM No. AB 14017/13/2016-Estt.(RR) dated 9/8/2016, the Lieutenant Governor (Administrator), Andaman & Nicobar Islands, hereby makes the following Amendments to the Recruitment Rules to the post of **Mazdoor (Group -C)** borne in the establishment of Directorate of Transport, Andaman & Nicobar Administration published in the A & N Extraordinary Gazette Notification No. 128 dated 04/06/2010.

**1. SHORT TITLE AND COMMENCEMENT :-**

- (i) These Rules may be called the Union Territory of Andaman and Nicobar Islands **(Mazdoor) Recruitment (Amendment) Rules, 2018.**
- (ii) They shall come into force on the date of their publication in the Official Gazette.
