NOTIFICATION

Port Blair, dated the 1st May, 2009

No. 71/2009/F.No.42-170/2007-TR.—In exercise of powers conferred by the proviso to Article 309 of the Constitution of India, read with Government of India, Ministry of Home Affairs, New Delhi, Notification No. U.14939/2/83 dated the 21st February, 1985, and in supersession of the Administration's Notification No. F.No.42-170/94-TR dated 4th April, 1995, the Lieutenant Governor (Administrator), Andaman and Nicobar Islands hereby makes the following rules regulating the method of recruitment to the posts of **Mechanical Engineer** borne in the establishment of the Directorate of Transport, Andaman and Nicobar Administration, namely:-

1. SHORT TITLE AND COMMENCEMENT :-

- i) These Rules may be called the Andaman and Nicobar Administration (Mechanical Engineer in the establishment of the Directorate of Transport) Recruitment Rules, 2009.
- ii) They shall come into force on the date of their publication in the Official Gazette.

2. NUMBER OF POST, CLASSIFICATION AND SCALE OF PAY:-

The number of posts, their classification and the scale of pay attached thereto shall be as specified in paras 2 to 4 of the Schedule annexed hereto.

3. METHOD OF RECRUITMENT, AGE LIMIT AND QUALIFICATION:-

The method of recruitment, age limit, qualifications and other matters relating to the said posts shall be as specified in paras 5 to 14 of the said Schedule.

4. DISQUALIFICATION:

No person-

- (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living has entered into or contracted a marriage with any person, shall be eligible for appointment to the said posts;

Provided that the Lieutenant Governor (Administrator), Andaman and Nicobar Islands, may, if satisfied that such marriage is permissible under the personal law applicable to such persons and the other party to the marriage and there are other grounds for so doing exempt any person from the operation of this rule.

5. POWER TO RELAX :--

Where the Lieutenant Governor (Administrator), Andaman and Nicobar Islands is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing and in consultation with the Union Public Service Commission, if necessary, relax any of the provisions of the those rules with respect of any class or category of person.

6. SAVING :-

Nothing in these rules shall effect the reservation, relaxation of age limit and other concessions required to be provided for the candidates belonging to Scheduled Castes, Scheduled Tribes and otherspecified categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

From amongst the Assistant Engineer of the Department in the scale of Pay of Rs. 6500-10500 (Pre-revised) with 5 years regular service in the grade Diploma least possessing at Engineering/Electrical Mechanical/Automobile Engineering from a recognized institute or equivalent.

Deputation (including short - term contract)

Officers under the Central/State Governments/UTs including State Transport Corporation;

- (i) Holding analogous post on regular basis in the parent cadre/department; or
- (ii) With 5 years service in the grade rendered after appointment thereto on a regular basis in the scale of pay of Rs. 6500-10500 or equivalent in the parent cadre/department; and
- (iii) Possessing the educational qualifications and experience as prescribed for direct recruits under para 8.

The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationist shall not be eligible for consideration for appointment by promotion.

Period of deputation (ISTC) including period of deputation (ISTC) in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Govt. shall ordinarily not to exceed three years. The maximum age limit for appointment by deputation (including short term contract) shall be not exceeding 56 years as on the date of closing date of receipt of application).

(RR) dated 9/8/2016, the Lieutenant Governor (Administrator), Andaman and Nicobar Islands, hereby makes the following Amendments to the recruitment rules to Group 'A' Gazetted, post of Mechanical Engineer borne in the establishment of Directorate of Transport, Andaman and Nicobar Administration, namely published in the A & N Extraordinary Gazette Notification No. 77 dated 01/05/2009 :-

1. Short title and commencement :-

- i. These Rules may be called the Union Territory of Andaman and Nicobar Islands Mechanical Engineer Recruitment (Amendment) Rules, 2020.
- ii. They shall come into force on the date of their publication in the Official Gazette.

From amongst the Assistant Engineer of the Department in the Pay Scale of Rs. 44900-142400 (Level - 7) with 5 years of regular service in the grade and possessing atleast Diploma in Mechanical/Automobiles Engineering/Electrical Engineering from a recognized Institute or equivalent.
