NOTIFICATION

Port Blair, dated the 29th March, 2010

No. 68/2010/F.No. 20-1/Estt/2010.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with Government of India, Ministry of Home Affairs, New Delhi, Notification No. 14/3/60-ANL dated the 11th April, 1960, and in supersession of Notification No. 92/65/F.No. 42-484/99-TR dated 27.05.2005, the Lieutenant Governor (Administrator), Andaman and Nicobar Islands, hereby makes the following rules regulating the method of recruitment to the post of Tyre Repairer borne in the establishment of the Directorate of Transport, Andaman and Nicobar Administration, namely:—

1. SHORT TITLE AND COMMENCEMENT:-

- These Rules may be called the Andaman and Nicobar Administration (Tyre Repairer in the Directorate of Transport) Recruitment Rules, 2010.
- They shall come into force on the date of their publication in the Official Gazette.

2. NUMBER OF POST, CLASSIFICATION AND SCALE OF PAY:-

The number of post, their classification and Pay Band & Grade Pay/Scale of Pay attached thereto, shall be as specified in paras 2 to 4 of the Schedule annexed hereto.

3. METHOD OF RECRUITMENT, AGE LIMIT AND QUALIFICATION:-

The method of recruitment, age limit, qualifications and other matters relating to the said post shall be as specified in paras 5 to 15 of the said Schedule.

4. DISQUALIFICATION:-

No person—

- Who has entered into or contracted a marriage with a person, having a spouse living, or
 - Who, having a spouse living has entered into or contracted a marriage with any person,
- shall be eligible for appointment to the said post:

Provided that the Lieutenant Governor (Administrator), Andaman and Nicobar Islands, may, if satisfied that such marriage is permissible under the personal law applicable to such persons and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

5. POWER TO RELAX:-

Where the Lieutenant Governor (Administrator), Andaman and Nicobar Islands is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing relax any of the provisions of these rules with respect of any class or category of person.

6. **SAVING:-**

Nothing in these rules shall effect reservation, relaxation of age limit and other concessions required to be provided for candidates belonging to the Scheduled Castes, Scheduled Tribes and other specified categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Annexure -I

DUTIES AND RESPONSIBILITIES OF TYRE REPAIRER

1. To carryout all types of tyre repairing works related to repair and maintenance works in the Light as well as Heavy Motor Vehicles under the Motor Transport Department and A&N Administration.
2. To assist the Chargeman/Head Mechanic in carrying out the responsibilities of a workshop under the Motor Transport Department.
3. To perform all skilled as well as unskilled nature of works related to tyre repairing in the workshop.
4. Tyre Repairer shall be responsible for maintenance and upkeep of Air Compressors and other equipments required for repair of tyres.
5. Tyre Repairer shall extract works from the unskilled workers.
6. Tyre Repairer shall maintain Tyre history cards and records pertaining to repair, maintenance, spareparts etc. wherever necessary.
7. Tyre Repairer shall undertake all other works as entrusted by his superiors.
8. Tyre Repairer shall be responsible for the smooth running of the workshop in the absence of JE/Chargeman/Assistant Chargeman.

No.20-1/Estt./RR/2017.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with the Government of India, Ministry of Home Affairs, New Delhi, Notification No. 14/3/60-ANL dated 11/04/1960, and in pursuance of DoPT's OM No. AB.14017/13/2016-Estt.(RR) dated 9/8/2016, the Lieutenant Governor (Administrator), Andaman & Nicobar Islands, hereby makes the following amendments to the Recruitment Rules to the post of Tyre Repairer (Group-C) borne in the establishment of Directorate of Transport, Andaman & Nicobar Administration published in the A & N Extraordinary Gazette Notification No. 72 dated 29.03.2010.

1. SHORT TITLE AND COMMENCEMENT :-

- (i) These Rules may be called the Union Territory of Andaman and Nicobar Islands (Tyre Repairer) Recruitment (Amendment) Rules, 2018.
- (ii) They shall come into force on the date of their publication in the Official Gazette.

AMENDMENTS
