## NOTIFICATION

Transport Department, Andaman & Nicobar Administration is inviting applications for engagement of Apprentices from the eligible candidates under the Apprenticeship Act, 1961 in the following disciplines for the year 2023-2024:

### A. Conditions of Eligibility:

1. Candidate who possess the requisite educational qualifications in

the aforementioned disciplines are eligible for proposed Apprenticeship Training.

2. The candidates who have already gone through apprenticeship training in this Directorate or any other Department under this Scheme or having experience for a period of one year or more in the trade for which application is made shall not be eligible, as per the prescribed rules.
3. The candidates who have already undergone apprenticeship under the Apprenticeship Act/ National Apprenticeship Promotion Scheme of Govt. of India and in whose case the contract of apprenticeship was terminated for such failure on the part of the apprentice, the apprentice or his guardian, the apprentice shall not be eligible.

**B. Period of Training:**

1. The apprenticeship shall be for a period of 01 (one) year only.
2. During the apprenticeship training period, the trainee may be attached to any Workshop/ Bus Terminus maintained by the Transport Department in the A&N Islands.

**C. Rate of stipend payable per month:**

The rate of stipend during the period of apprenticeship of one year shall be as per 70% of minimum wages of Semi-Skilled Workers notified by the respective State or Union Territory as amended from time to time.

**D. How to apply:**

1. The candidates fulfilling the eligibility criteria may apply through <https://www.apprenticeshipindia.gov.in/> under “apprenticeship opportunities”.
2. Before filling the application online, the candidate has to ensure that he/ she is fulfilling all eligibility criteria. The candidate is fully responsible for entering correct particulars and information.
3. All candidates are advised to fill information and upload all relevant documents (Matriculation mark sheet & pass certificate, ITI mark sheet & pass certificate or equivalent, Category certificate in case of ST, SC, OBC, EWS, PWD etc.) while submitting the online application.
4. The candidates are advised to merge all the necessary documents to be uploaded in a single PDF document.
5. Incomplete application shall not be entertained.

**E. Submission of applications:**

No physical applications shall be accepted. Only application

through the aforementioned website will be entertained.

- F. The Director (Transport) reserves the right for final engagement of the candidates as per his discretion, without assigning any further notice or any reason thereof whose decision shall be final and binding on all.
- G. Selected candidates for apprenticeship training in the Transport Department will be guided by the provisions of Apprenticeship Act, 1961 along with its amendments and the candidates shall enter into an Apprentices Training Contract with the NAPS and this Directorate.
- H. By virtue of this apprenticeship engagement alone, the candidate shall have no claim whatsoever in future for regular appointment to the post against which apprenticeship engagement is being made and this shall no bestow upon him/ her any right for future appointment.
- I. The last date for submission of application through online apprenticeship portal shall be 30.09.2023 (till midnight).
- J. Any correspondence in this regard shall be communicated only through online apprenticeship portal (<https://www.apprenticeshipindia.gov.in/>) and Transport Department's official website (<http://transport.and.nic.in/>). The candidates are advised to visit online apprenticeship portal and Transport Department's official website from time to time for getting regular updates.
