## Agenda No. 5

### **Extension of NOC**

a. STA was apprised that **NOC for purchase of Autorickshaw** was issued in favour of Shri J A Inba Raj to ply in all routes of South Andaman which expired on 10.08.2022. The applicant informed that due to covid pandemic and transportation issue, he could not purchase the vehicle within the validity period of NOC and requested to extend the validity of NOC for a period of three months. **STA approved the extension of the validity of NOC for a period of three months.**

b. STA was apprised that **NOC for purchase of Truck** was issued in favour of Shri Murugantoply in all routes of South, North & Middle Andaman which expires on 06.09.2022. The applicant informed that due to delay in getting bank loan, he is not in position to purchase the vehicle within the validity period of NOC and requested to extend the validity of NOC for a period of three months. **STA approved for extension of the validity of NOC for a period of three months.**

c. STA was apprised that **NOC for purchase of Maruti Ertiga** was issued in favour of Shri Sushen Maitra to ply in all routes of South, North & Middle Andaman which expired on 13.08.2022. The applicant informed that due to delay in getting bank loan, he could not purchase the vehicle within the valid period of NOC and requested to extend the validity of NOC for a period of three months. **STA approved for extension of the validity of NOC for a period of three months.**

d. STA was apprised that **NOC for purchase of 12 Tyre plate form Truck** was issued in favour of Shri Haridasan to ply in all routes of South Andaman which expired on 24.08.2022. The applicant informed that due to delay in getting bank loan, he could not purchase the vehicle within the validity period of NOC and requested to extend the validity of NOC for a period of three months. **STA approved for extension of the validity of NOC for a period of three months.**

e. STA was apprised that **NOC for purchase of Maruti Ertiga** was issued in favour of Shri Abhijit Nandi to ply in all routes of South, North & Middle Andaman which expired on 30.09.2021. The applicant informed that due to delay in getting bank loan, he could not purchase the vehicle within the valid period of NOC and requested to extend the validity of NOC for a period of three months. **STA approved for extension of the validity of NOC for a period of futher three months.**

f. STA was apprised that **NOC for purchase of Water Tanker (PC)** was issued in favour of Shri M Indran to ply in all routes of South Andaman which expired on 04.04.2022. The applicant informed that due to health issues, he could not purchase the vehicle within the validity period of NOC and requested to extend the validity of NOC for a period of six months alongwith change in class of vehicle from water Tanker to Tipper. **STA approved for extension of the validity of NOC for a further period of three months and also permitted to change the class of vehicle from Water Tanker to Tipper.**

## Agenda No.6

### **Change of class of vehicle in the NOC**

The request received from Shri Soman Halder is for change of type of vehicle in the NOC issued on 03.08.2022 from Bolero Pick Up (PC) to Maruti Ertiga (CC) to ply in all routes of North,

Middle & South Andaman. Since the criteria fixed by STA for obtaining NOC/ Permit are same for these two categories of permits, **STA approved the request of Shri Somen Halder for change of vehicle from Bolero Pick Up (PC) to Maruti Ertiga (CC) in the NOC granted in the previous STA meeting held on 03.08.2022.**

**Agenda No. 7**

**Release of FD to applicants, who could not purchase vehicles within the validity of NOC issued to them due to various grounds.**

STA was apprised that 02 local unemployed residents of the UT have applied for NOC for obtaining different categories of permits for their livelihood by depositing Security Deposits to the Department. Due to various grounds i.e. financial crisis, non-availability of intended vehicles etc., they are unable to purchase the vehicle and requested to release the security Deposits. **STA decides to release the Security Deposits to both the two applicants.** The list of application is given in Table-10 below:

**Delay in submission of Challan fee for obtaining New Permit:-**

STA was apprised that M/s Goenkas Retail Pvt. Ltd. obtained NOC from STA on 10.12.2020 and got their vehicle bearing registration No.AN01 Q 6749 (Tata Intra V30) registered on 08.07.2021. The firm applied for permit on 07.09.2021 but did not turn up to remit the requisite fee for obtaining permit. Now the firm approached STA on 01.07.2022 vide their letter dated 01.07.2022 i.e. after a gap of 09 months requesting to issue permit for the said vehicle. **STA approves the issuance of PC permit to the applicant with the imposition of fine@Rs.15,000/-.**

**Agenda No. 9**

**Issue of permit for already registered Non- BS VI compliant vehicle.**

- (i) STA was apprised that Smti Richa Singh R/o Aberdeen Bazar applied along with required documents for issuance of NOC to purchase Maruti Ertiga on 27.06.2022. The case was approved in the STA meeting of 03.08.2022 along with other similar cases. Now the applicant intends to use the NOC in her already registered Non-Transport vehicle bearing Regn.No. AN01 P 2703 which is of BS-IV compliant vehicle registered in the RTO, Port Blair on 29.06.2019. Presently STA has mandated the condition of BS-VI for obtaining new NOC / permit and in the instant case, the applicant requested for NOC for conversion of already registered Non-Transport vehicle

which is of BS-IV compliant. **STA has not considered the request of the Smti Richa Singh.**

- (ii) STA was apprised that the firm M/s P Surya Rao submitted application along with required documents for issuance of Public Carrier permit for their vehicle (10 wheeler Transit Mixer) bearing registration No.AN01 G 2018 (BS-III) on 27.01.2022. By mistake, the case was placed before the STA along with the normal new cases of NOC/ permits for Public Carrier vehicles which was approved in the STA meeting of 04.04.2022. STA was further apprised that the said vehicle was registered in the RTO, Port Blair on 29.08.2011 and the firm plied the vehicle without permit till the date of their application for obtaining permit on 27.01.2022 i.e. after a span of more than 11 years.

STA examined the case and observed that the firm violated the MV Laws by plying the vehicle without permit for such a long period of 11 years. **Hence, STA decided to call for an explanation from the firm for such grave violation before taking any decision in this matter. The reply is to be submitted before next STA meeting.**

#### Agenda No. 10

##### **Delay in submission of application for permit after obtaining NOC & registration of vehicle.**

- (i) STA was apprised that Shri Sameer Yousuf M had obtained NOC 08.01.2020 from STA for his already registered Non-transport vehicle (Ford Figo) bearing Registration No.AN01 N 6879 (registered in the RTO, Port Blair on 21.11.2018). After obtaining NOC, the applicant converted the vehicle from 'Non-transport' category to 'Transport' category on 18.08.2021 but applied for permit on 04.08.2022 i.e. after a span of 01 year. STA was further informed that in a similar case in the previous STA meeting on 03.08.2022, STA granted approval for issuance of permit with imposition of fine @ Rs. 2000/-. **Hence, STA approved the case for issuance of permit in favour of Shri Sameer Yousuf M for his vehicle bearing Registration No.AN01 N 6879 with the imposition of fine @ Rs. 2000/-**
- (ii) STA was apprised that M/s Prasure Electrical & Engineering Co. purchased Tipper bearing Regn. No.AN01 L 3708 from Girdharilal Construction Pvt. Ltd. on 25.04.2019. The firm applied for transfer of permit and it was noticed that the vehicle was plying without permit from its registration on 11.08.2016, the registration of the vehicle was suspended for 03 months which was later revoked by imposing fine for Rs.40,000/-.The firm had remitted the fine vide DD No. 241716 dated 03.01.2020. As such STA approved the case for issuance of permit in favour of the firm on 19.03.2020. On approval, the vehicle was transferred in the name of M/s Prasure Electrical & Engg. Co. on 06.11.2020 but the firm had applied for permit on 11.02.2022 i.e after a span of 02 years. STA observed that the firm was penalized earlier for delay applying for obtaining permit and repeated the same offence again. **Hence STA decided to defer the case till the next STA meeting. Further directions were issued to constitute a Committee to standardize the quantum of penal amount for various categories of violations in terms of fixed criteria covering all kinds of violations.** The proposed committee shall have the following composition covering all kinds of violations:-

#### **Temporary Permit to mainland registered Non-BS VI vehicles brought from mainland**

STA was apprised that as per the decision taken in the STA meeting on 03.08.2022 with regard to issuing temporary permits to the Non-BS-VI compliant already registered commercial vehicles brought from mainland, 04 firms were asked to clarification on whether the projects for which these vehicles have been brought, have been completed and the permits are still required or not. In response, only one firm i.e. M/s Vij Engineers & Consultants Pvt. Ltd, registered owner of vehicle (Truck) bearing registration No.HR67C3183 has responded and clarified that the project of constructing 05 bridges awarded to the firm by NHIDCL is expected to be completed by 30.06.2023. STA was further apprised that the said vehicle was brought in this UT in 09.12.2020 and the firm applied for temporary permit on 22.11.2021 i.e. after a span of almost 01 year. No temporary permit was issued for the vehicle.

In this regard, Secretary (STA) informed that as per Section 49 of MV Act 1988, if the owner of a vehicle ceases to reside or have his place of business at the address recorded in the RC of the vehicle, he shall within 30 days of any such change of address intimate to the registering authority by which the RC was issued, or, if the new address is within the jurisdiction of another state, to any registering authority in that state, and shall at the same time forward the RC to the Registering Authority or, as the case may be, to the Registering authority in order that the new address may be entered therein.

In the instant case, the firm did not intimate Registering Authority about the change of place of business within the time frame and violated Section 49 of MV Act, 1988

Secretary (STA) further apprised STA that as per Section 47 of MV Act, 1988, when a motor vehicle registered in one state has been kept in another state, for a period exceeding 12 months, the owner of the vehicle shall, within such period apply to the registering authority, within those jurisdiction the vehicle is, for the assignment of new registration mark and shall present the RC to the registering authority accompanied by NOC obtained under Section 48.

**STA decided to grant Temporary permit for 02 months with the imposition of penalty @Rs.35,000/- and directed the vehicle owner to get the vehicle registered in the RTO, Port Blair in the meantime for consideration of permit for further period.**

### **Agenda No. 12**

#### **Issue of permit for the registered vehicle against the existing NOC issued by STA**

STA was apprised that Shri Rakesh Gharami R/o Swaraj Dweep is the registered owner of vehicle (Maruti Ertiga) bearing Regn. No.AN01 K 3290. He had placed request before STA for issuance of NOC on 20.08.2015 for converting his vehicle from Non-Transport category to Transport category for obtaining permit. The case was approved in the STA meeting held on 04.11.2015 and accordingly NOC was issued by STA on 14.12.2015. Accordingly, the vehicle owner affixed yellow board on his vehicle on basis of NOC but unaware of the rule provision for the

necessity of route permit for its further operation. As such he did not apply for route permit. The vehicle owner is presently bed ridden due to severe health issue and his wife informed that as and when she became aware of the necessity of permit to ply the vehicle, she stopped the operation of vehicle. The vehicle is presently kept idle and she is facing financial hardship to maintain her family and to give proper treatment to her bed ridden husband as earning from the vehicle is the only source of income for her family and requested to issue permit for the vehicle against the NOC issued by the STA. **STA considered the request and on humanitarian ground approved the case of Shri Rakesh Gharami R/o Swaraj Dweep for grant of permit for the vehicle bearing Registration No. AN01 K 3290 with the imposition of penalty @ Rs. 1000/-.**

### Agenda No. 13

#### **Fare revision of Autorickshaw**

The STA in its previous meeting held on 03.08.2022 had decided to constitute a committee under the chairmanship of Dy.SP (Traffic) to analyse the present market rate of all the components responsible for operation of Autorickshaw and propose revision of fares in respect of Autorickshaws in the UT of A & N Islands.

The Committee has furnished a detailed report in which the committee recommended to revise the base fare from Rs. 25/- to 30/- for first 1.2 KM and after 1.2 KM, the fare to revise from Rs.13/- to Rs. 15/- per KM. The Committee also proposed to revise the waiting charges from Rs.7/- to Rs.9/- for every 10 minutes halt.

**STA accepted the proposed revised fare structure & other recommendations of the committee mentioned in the report dated 01.09.2022 and directed Transport Department to initiate proposal for obtaining approval from the competent authority for issuance of notification.**

### Agenda No. 14

#### **Cases of Swaraj Dweep & Shaheed Dweep**

It was apprised that many applications were received for issuance of NOC/ permits and other permit related transactions for the jurisdiction of Swaraj Dweep and Shaheed Dweep which were placed in the STA meeting held on 03.08.2022 wherein STA deferred the all cases to the next meeting with a direction for Transport Department to initiate a proposal and devise a policy after taking the approval of competent authority. In addition to those cases, more applications have been received during 08/2022 for issuance of NOC/ permits. The details of old and new cases are as under:-

STA was further apprised that the Transport Department has already initiated a proposal in this regard and sent to Administration for obtaining approval, which is still awaited. It was informed that DBRAIT, which was appointed to submit a report on the issue, has been asked to submit its final report with carrying capacity number of vehicles in the two Islands (Swaraj Dweep & Shaheed Dweep) as well as Port Blair respectively. **Hence, STA decided to defer all the above cases till the next STA meeting.**

## Agenda No. 15

### **Other cases of Swaraj Dweep**

#### **(i) Issue of Permit & License (Two wheeler)**

STA was apprised that Shri Shayamal Das, R/o Swaraj Dweep had obtained NOC on 04.12.2017 for purchase/ registration of 10 two wheeler vehicles which he had purchased in 2018 and got it registred on 26.03.2018. After registering the above said vehicles in transport category, Shri Shyamal Das applied for permit on 08.07.2021 i.e. a span of almost 3 years. Since he was plying these vehicles without permit & License, the registration of all the above said vehicles were suspended for a period of three months vide Order No. 2317 dated 30.06.2022. The case was then placed in the STA meeting held on 04.04.2022 wherein STA decided to impose penalty of Rs. 15000/- per vehicle for violating the MV Laws and consider for issuance of permit & license after making payment of fines. Shri Shyamal Das had paid the penalty amount of Rs.1,50,000/- vide TR No. 0339011, dated 20.07.2022. STA observed that the vehicle have already been converted into Transport category and the applicant has also paid the fine amount as imposed by STA. **Hence STA, decided to grant permits for the 10 two-wheelers as listed in Table 11 given below and thereafter issue license under the Rent-a-Motorcycle Scheme for renting out the two-wheelers.**

Tapash Mistry, R/o Shaheed Dweep had obtained NOC for purchase of Maruti Ertiga to ply in all routes of Shaheed Dweep on 20.11.2020 which expired on 20.05.2021. **STA observed that the NOC expired more than 01 year back and hence, decided not to consider the case.**
- (b) STA was apprised that Shri. Vinod Kumar KP had obtained NOC purchase of Pickup Van to ply in all routes of Swaraj Dweep on 26.11.2020 which expired on 25.05.2021. **STA observed that the NOC expired more than 01 year back and hence, decided not to consider the case.**

## Agenda No.16

### **Fixation of fares for the cabs and commercial two-wheelers operating in Swaraj Dweep**

STA was apprised that due to the absence of any fare regulation for the cabs and commercial two wheelers plying in Swaraj Dweep and Shaheed Dweep, regular reports on fleecing of tourists by the


commercial vehicle drivers have been cropping up. This is not only creating inconvenience for the visiting tourists but also detrimental in the promotion of tourism activity in the Island. In order to maintain a check on the excess fare charging and to eliminate the chances of unhealthy practice by the vehicle owners, STA decided to fix the fares of cabs and commercial two wheelers plying in Swaraj Dweep and Shaheed Dweep as provided under section 67 of MV Act 1988. STA further decided to constitute a Committee consisting of the following officers to recommend a suitable fare structure:

The Committee shall take into account all the factors like cost of operation, maintenance, fuel expenses, cost of living, tourist footfall, need of the transportation facility, distance travelled, availability of vehicles and other factors related to the commercial vehicle operation and after analysing all the factors should submit a recommendation for fixation of fares in respect of cabs and commercial two wheelers plying in Swaraj Dweep and Shaheed Dweep. The fare structure may include destination based fare per trip, duration based as well as for keeping the vehicle exclusively with the guests for the whole day. There should be provision for incremental increase after the expiry of the duration based fare structure. The Committee shall hold stakeholder consultations wherever required and furnish its report by 19.09.2022.
