1. Grant of NOC/Permit:-

As per section 74 of Motor Vehicle Act 1988, STA has prescribed the following conditions for obtaining a Contract Carriage permit/ NOC:-

1. Vehicle to be owned by the applicant.
2. Should submit driving license of the driver.
3. Should submit address.
4. Requirement of parking place would be compulsory for all kinds of commercial vehicles.
5. Affidavit showing that the applicant is unemployed.
6. Should submit Parking area certificate.
7. NOC of the tenant if the applicant does not possess own parking area, and Photo of parking area, and copy of record of rights and Map of land.
8. Copy of Local Certificate/Islander Card/Voter ID Card/Aadhar Card/Ration Card and,
9. Character & Antecedent report of the applicant.

Initially, the bus bearing Regn.No. AN01F 9095 having Stage Carriage Permit was granted in the route from Mohanpura Bus stand to Tsunami Shelter Calicut via Lal Mitti and vice versa but later it was informed by the permit owner that the narrow road leading to Lal Mitti village was not motorable and it was difficult to operate the bus on the said route.

Accordingly, inspections were carried out by the Department to assess the factual positions and it was found that the road was really not suitable for bus operation and so an alternate route from Mohanpura Bus stand to Tsunami Shelter Calicut via Bird Line, Calicut Pump House, Calicut School, Pema and vice versa was given temporarily.

In the meantime, regular inspections of the Lal Mitti road was carried out and in the latest inspection also it was found that the road towards Lal Mitti village was not motorable.

Therefore, it has been proposed to regularize the temporary route permit to the bus bearing Reg.No. AN01 F9095 as also requested by the permit owner i.e. Mohanpura Bus stand to Tsunami Shelter Calicut via Bird Line, Calicut Pump House, Calicut School, Pema and vice versa.

Decision:-

STA has approved to regularize the Temporary route permit of the bus bearing Regn. No. AN 01 F 9095 for the route Mohanpura Bus stand to Tsunami Shelter Calicut via Bird Line, Calicut Pump House, Calicut School, Pema and vice versa as it has been observed for a long time that the road to Lal Mitti village has not yet been made motorable.

c. Change of Contract Carriage Permit to Stage Carriage Permit.

Shri Sarat Kirtonia, S/o Sudhir Kirtonia, R/o Collinpur the permit holder of CC permit of Jeep bearing Registration No. AN 01 D 8570 having route permit to ply in all routes of South Andaman has placed a request before STA to grant permission to change the Contract Carriage permit to Stage Carriage Permit.

There are many jeeps plying with contract carriage permits concentrated in the localities like Tushnabad, Bathu Basti, Ferrargunj, Wimberlygunj and Bambooflat. It has been alleged that these contract carriages ply as Stage Carriage Vehicles which is violation of permit conditions. Violators have been penalized by the Transport Department as well as Police on numerous occasions. They have also been advised to convert their vehicles into Stage Carriages by the STA. So far **41** Jeeps have converted their Jeeps into Stage Carriages in Tushnabad and Bambooflat area. In similar lines, the instant applicant has also applied for converting his Jeep to Stage Carriage.

Decision:-

STA has approved the request of the applicant for converting his Jeep bearing Regn.No. AN 01 D 8570 from

Contract Carriage to Stage Carriage permit. STA further directed to go for special drive to check violation of permit conditions by such contract carriage jeeps and take action as well as advise them to obtain Stage Carriage permits if the vehicles are being used as Stage Carriages.

d. Transfer of ownership of more than 15 years old vehicle and transfer of permit.

Shri B V Karunagaran, S/o Late Venkatesan, R/o Junglighat has placed a request before STA to grant permission for transfer of ownership in respect of the Stage Carriage Bus bearing Registration No. AN 01 B 2035 which is more than 15 years old and having route permit to ply between "GB Pant Hospital to Chatham and vice versa purchased from Shri M Kalai Selvam, S/o K Mari Muthu, R/o Bathu Basti.

The permit was initially issued on 13.12.1994 and the present owner is Shri M Kalai Selvam. Now, Shri B V Karunagaran has purchased the same Bus and requested for transfer of ownership of bus as well as permit.

Decision:-

STA has rejected the case as the vehicle involved is more than 15 years old.

3. Change of jurisdiction of existing permit from South Andaman to Swaraj Dweep through Transfer of Ownership.

Shri Jugal Sarkar, S/o Jawaharlal Sarkar, R/o Krishna Nagar, Swaraj Dweep had purchased a vehicle Bolero Camper (Cargo) bearing Registration No. AN 01/F-7372 having route permit to ply in all routes in North, Middle & South Andaman from Shri N Siva Shankar in the year 2017 and placed a request before STA on 30.01.2018 for transfer of route permit alongwith change of route from North, Middle & South Andaman to Swaraj Dweep as the applicant is a permanent resident of Swaraj Dweep.

As Shri Jugal Sarkar took the vehicle to Swaraj Dweep without obtaining prior permission from STA, a penalty of Rs.40,000/- was imposed as fine which was remitted vide TR No. 300290, dated 09.03.2020. The reason for imposing penalty was that STA was not issuing new permits for Swaraj Dweep and the applicant plied the vehicle in Swaraj Dweep without changing the route of the permit.

Now, he has requested for a special consideration for transferring the permit from North, Middle & South Andaman to Swaraj Dweep. He has produced the necessary parking area details of Swaraj Dweep and other documents required for obtaining permit in Swaraj Dweep.

Hence, decision may be taken with regard to change of jurisdiction of existing permit from South Andaman to Swaraj Dweep through Transfer of Ownership.

Decision:-

STA has approved for change of jurisdiction from North, Middle & South Andaman to Swaraj Dweep for the vehicle bearing Regn. No. AN 01 F 7372. It is presumed that the owner must have plied the vehicle without permit though a penalty was imposed upon him once earlier.

However, taking a lenient view and to regularize the action as a one time measure, STA has decided to impose a penalty of Rs. 20,000/- and directed to issue permit after remittance of penalty amount.

4. License under Rent a Motorcycle Scheme for Two wheelers

a. Replacement of vehicle through condemnation

M/s Karishma Tours and Travels has placed a request before STA for condemnation of 19 two wheeler vehicles stating that the vehicles have become old and not suitable for renting out. The Firm further stated that as of now electric two wheelers are not available in Port Blair and they require two wheelers for replacing the old two wheelers covered under the License immediately. The license granted to M/s Karishma Tours & Travels covers 35 two wheelers and it is operated in Port Blair. Details are as under:-

The two wheelers on Rent are predominantly used by Tourists and new vehicles in good condition are better suited for such purposes considering the safety of the riders as well as other road users.

In the previous meeting, STA desired to know the plan of action by the license holder in respect of the proposed condemnation of the vehicles. The applicant has now stated that he would dispose off all the 19 two wheelers by condemning it and requested for replacing these condemned vehicles with new and good two wheelers.

Decision:-

STA has permitted the replacement of 19 old two wheelers (Petrol) with the new zero emission vehicles like e-bikes as Administration has also come up with a draft EV policy for reducing the polluting effects of fossil fuel vehicles.

b. Inclusion of 05 more two wheelers in the existing Rent a Motorcycle license.

Shri Ashish Mondal, S/o Milan Mondal, R/o Govinda Nagar, Swaraj Dweep is the license holder of 15 two wheelers with permits to ply in all routes in Swaraj Dweep under Rent a Motorcycle Scheme has placed a request before STA for inclusion of 05 new two wheelers in his existing license. He has already purchased these 05 two wheelers and also obtained permits for these vehicles.

STA has not considered the request of the applicant and decided that only zero emission two-wheelers will be allowed to be included in the existing license under Rent a Motorcycle Scheme.

c. Issue of license under Rent a Motorcycle Scheme:-

- (a) Smti. Dheepika, W/o L M JayaKumar, R/o Near Ganesh Mandir, Mazar Pahad has placed a request before STA for issuance of license for the following two-wheeler vehicles under Rent a Motorcycle Scheme to ply in all routes of South Andaman:-

Shri Abdul Hamid Mallick has obtained permit for the above said two wheeler vehicles in January 2019 and applied for license under Rent a Motorcycle Scheme on 12.08.2021 i.e. after a span of more than 02 years stating that he has already sold the vehicles.

STA observed that in both the above cases the applicants have obtained permits in the year 2018 & 2019 but applied for license under Rent a Motorcycle Scheme in 2021 & 2022. It can inferred that they must have operated these vehicles by violating the provisions. Hence, STA decided to consider issuance of license under Rent a Motorcycle Scheme if the applicants fulfil all the requirements for the license and by imposing suitable penalty on case to case basis.

5. Issuance of Permit & License under Rent a Motorcycle Scheme:-

Shri Shyamal Das, S/o Nirmal Das, R/o Radha Nagar, Havelock has placed a request before STA for issuance of Permit & license under Rent a Motorcycle Scheme for the following 10 two-wheeler vehicles:-

3. AN 01/ N 0543

4. AN 01/ N 0538
5. AN 01/ N 0534
6. AN 01/ N 0533

Shri Shyamal Das had obtained NOC from STA on 04/12/2017 for purchasing/ registration of 10 two-wheelers to ply in all routes in Swaraj Dweep and accordingly registered the vehicles in the year 2018 and had applied for permit on 08.07.2021 after a gap of more than 03 years. Meanwhile, the applicant was plying these two wheelers without obtaining permit and subsequent license under Rent a Motorcycle Scheme thus violating Section 66 & 74 of MV Act 1988.

Accordingly, for violating the provisions, the registration of above mentioned 10 two wheelers were suspended for a period of three months in the month of March 2022.

STA observed that the applicant registered the vehicles in the year 2018 but applied for permit in August 2021 and during this period the applicant must had used the vehicles for commercial purpose thereby violating the provisions of law.

Hence, STA decided to impose penalty of Rs. 1,50,000/- @ 15,000/- per vehicle (10 Nos.) for violating the permit conditions and then issue permit & license accordingly after payment of fine.

6. Replacement of vehicle through condemnation and transfer the permit in lieu of existing permit.

Shri R Bhominathan, S/o V Ramu, R/o Rangat, the permit owner of Truck bearing Registration No. AN 01 D 6318 having route permit to ply in all routes in North and Middle Andaman has placed a request before STA to grant permission for condemnation of his existing vehicle. He has further requested to transfer the permit of the condemned vehicle for his new vehicle which he intends to purchase in future.

STA has approved the case as replacement of vehicle is permissible under Section 83 of MV Act, 1988.

7. Imposition of penalty on:-

1. Plying commercial vehicle without obtaining permit

- (a) Shri K Srinivas, S/o K Sampath Rao, R/o Calicut; the registered owner of vehicle Tata Venture bearing Regn.No. AN 01/ J3641 has placed a request before STA for cancellation of permit.

As per the records of STA, it has been observed that the applicant did not apply for permit since its registration on 16.04.2014 and was plying the vehicle without permit till then thus violating Section 66, 74 & 192 (A) of MV Act 1988.

Decision:-

STA has directed to impose penalty of Rs. 15,000/- for violating the permit conditions for operating six seater passenger vehicle.

- (b) Shri B. Loganathan, S/o K Bhakta Vachalam, R/o Haddo is the registered owner of the vehicle bearing Regn.No. AN 01 D 3729 & AN 01 D 3795 which were registered in the year 18.12.2006 and after registering both the vehicles, Shri B Loganathan did not apply for permit and was plying the vehicle without obtaining permit till date. Meanwhile, he had sold one of his Tata Truck vehicle bearing Reg.No. AN 01 D 3795 to M/s Ravi Realcon Pvt. Ltd.

Decision:-

STA observed that both these vehicles (one LGV & one HGV) were registered in the year 2006 but plied without permits though these vehicles were commercial vehicles by default. The owner never applied for permit and the matter was brought to the notice of the STA when effort was made to sell one of the vehicle to another person. During enquiry, it has been revealed that Shri B Loganathan is also owning another commercial vehicle bearing Regn.No. AN 01 D 3729

Hence, STA decided to impose penalty of Rs. 1,00,000/- @ 50,000/- per vehicle (02 Nos.) for violating the permit conditions and then issue permits after remittance of penalty amount.

2. Plying vehicle under the influence of Alcohol

Total 38 permit owners were issued SCN for plying the vehicle under the influence of alcohol. Details are given below:-

The above-mentioned permit owners have been challaned by the District & Sessions Court, Port Blair and the Driving License of the violators have also been suspended for a period of three months by the Transport Department.

STA observed that for driving these commercial vehicles under the influence of liquor, the drivers of the vehicles have been penalized by the Court and their driving licenses have also been suspended by the Licensing Authority.

Hence, STA decided to impose penalty on the owner of the vehicles who have the moral responsibility for employing these violators in the following manner:-

- (i) For 3 wheeler – Rs. 1000/-***
- (ii) For LMV – Rs. 5,000/-***
- (iii) For HGV – Rs. 20,000/-***

8. Issuance of permit for already registered commercial vehicles brought from mainland.

As per the decision taken in the STA meeting held on 24.12.2021 for issuance of NOC/ permit for mainland registered vehicle, the STA had decided to obtain emission norms standard from the applicants before considering the case.

The following cases were placed in the STA meeting held on 24.12.2021 and the emission norms thus submitted is detailed below:-
