c) ISSUE OF NOC/ PERMIT TO ALREADY REGISTERED NON BS-VI COMPLIANT VEHICLES (PASSENGER)

i. **Shri. Satyajeet Mondal** purchased the vehicle (Nissan) and registered in the RTO, Port Blair on 14.12.2018. Being a local unemployed youth, the applicant applied for NOC for his vehicle bearing registration No. **AN01/N-7573** (Nissan **BS IV**) on 19.07.2019 to ply in all routes of **Shaheed Dweep**. The case was placed in the STA meeting held on 04.04.2022 wherein STA decided not to consider the case and directed to apply afresh.

The applicant vide his application dated **16.08.2023** again **applied for grant of permit to ply in all routes of Shaheed Dweep** for the said vehicle. The case was placed in the STA meeting held on 30.08.2023 wherein STA after examination of the case decided that since the applicant had made their application prior to the imposition of mandatory condition regarding BS VI emission norms, decided to get the vehicle inspected thoroughly for vehicle fitness and resubmit the case with fitness status in the next STA meeting.

Complying with the STA's decision, a letter was issued to the applicant informing the same. The applicant has produced his vehicle before the Committee/ Inspecting Authority on 01.11.2023 and the Committee/ Inspecting Authority inspected the vehicle and found that the vehicle complies with all the parameters related to fitness of the vehicle satisfactorily vide its report dated 06.11.2023.

Since the request of the applicant is for fossil fuel driven in Shaheed Dweep, STA decided to defer the case till the next STA meeting.

- ii. **Shri. K Laxman** purchased the vehicle (Maruti Ertiga **BS IV**) and registered in the RTO, Port Blair on 01.07.2019 vide registration No. **AN01/P-3346** after which he applied for NOC on 19.10.2020 to purchase a vehicle to ply in all routes of **North, Middle & South Andaman**. DOT approved the case for NOC on 17.01.2022. No restriction was mentioned in the NOC in respect of emission norms. By the time of making application on 19.10.2020, the BS-VI emission norms came in force for new vehicles. The NOC was issued on 24.03.2022 which was valid upto 16.01.2023. The case was placed in the STA meeting held on 13.02.2023 wherein STA did not consider his case.

The applicant vide his application dated **16.06.2023** again **applied for grant of permitto ply in all routes of North, Middle & South Andaman** for the said vehicle. The case was placed in the STA meeting held on 30.08.2023 wherein STA after examination of the case decided that since the applicant had made their application prior to the imposition of mandatory condition regarding BS-VI emission norms, decided to get the vehicle inspected thoroughly for vehicle fitness and resubmit the case with fitness status in the next STA meeting.

Complying with the STA's decision, a letter was issued to the applicant informing the same. The applicant has produced his vehicle before the Committee/ Inspecting Authority on 30.10.2023 and the Committee/ Inspecting Authority inspected the vehicle and found that the vehicle complies with all the parameters related to fitness of the vehicle satisfactorily vide its report dated 01.11.2023.

STA decided to approve the request of the applicant.

- iii. **Shri. D. Paul Raj** purchased the vehicle (Mahindra Bolero Plus BS-IV) and registered in the RTO, Port Blair on 17.05.2017 vide registration No. **AN01/M-1714** after which the applicant applied for NOC on **15.03.2022** to ply in all routes of **North, Middle & South Andaman**. The case was placed in the STA Meeting held on 14.10.2022 wherein STA approved for NOC 04.05.2022.

The applicant vide his application dated **21.06.2023** again **applied for grant of permitto ply in all routes of North, Middle & South Andaman** for the said vehicle. The case was placed in the STA meeting held on 30.08.2023 wherein STA after examination of the case decided that since the applicant had made their application prior to the imposition of mandatory condition regarding BS-VI emission norms, decided to get the vehicle inspected thoroughly for vehicle fitness and resubmit the case with fitness status in the next STA meeting.

Complying with the STA's decision, a letter was issued to the applicant informing the same. The applicant has produced his vehicle before the Committee/ Inspecting Authority on 30.10.2023 and the Committee/ Inspecting Authority inspected the vehicle and found that the vehicle complies with all the parameters related to fitness of the vehicle satisfactorily vide its report dated 14.12.2023.

STA decided to approve the request of the applicant.

- iv. **Shri. Manimohan Sarkar** vide his application dated 15.12.2023 has requested to reconsider his application for issuance of route permit to ply in all routes of Shaheed Dweep for his already registered vehicle bearing registration number AN01/P-3795. The applicant has stated that due to unawareness, NOC to ply in all routes of Shaheed Dweep was applied in the name of his sone namely Shri Manojee Sarkar vide application dated

25.07.2019. The applicant had again applied for grant of NOC to ply in all routes of Shaheed Dweep vide his application dated 29.07.2022 which was deferred by the STA in its subsequent meetings.

Further, to apprise that the case of Shri. Manimohan Sarkar was placed in the STA meeting held on 30.08.2023 wherein **STA observed that since the applicant had applied for NOC after the imposition of the condition of BS-VI emission norms, STA decided to reject the request of the applicant as the vehicle is non BS-VI compliant which is a mandatory condition prescribed by STA applicable as on date.** The applicant Shri. Manimohan Sarkar has requested to consider the matter on sympathetic grounds.

STA after examining the case decided to reject the request of the applicant.

d) Strong Hybrid Electric Vehicles (SHEVs)(CC-4W)

STA was apprised that 07 applications as mentioned in the **TABLE: 08** have been received for grant of NOC to purchase 07 Hybrid vehicles to ply in the jurisdiction of Swaraj Dweep. The details are as under:

STA ratified the approval of the Secretary (Transport) for grant of NOCs for the above 03 electric vehicles mentioned in TABLE: 09 as contract carriages in Swaraj Dweep & Shaheed Dweep.

f) Change of Permit from Contract Carriage Permit (CC) to Stage Carriage Permit (SC)

Smti. Ruchi Tiwari, W/o. Sudhir Kumar, R/o. Haddo, Port Blair vide her application dated 23.11.2023 has requested for conversion of route permit from contract carriage to stage carriage for her vehicle (LP 1312 TC/52, Bus) bearing registration number AN01/A-9919.

The applicant has further stated that she intended to ply the said vehicle in the below mentioned routes:

- Chatham to Medical via JNRM or
- Chatham to Calicut (Pema Junction) or
- Chatham to Garacharma via Goalghar.

It is to apprise that the vehicle bearing registration number AN01/A-9919 was registered in the year 21.10.1998 and has completed more than 25 years of its useful life.

STA observed that the bus is more than 25 years old and not suitable for issuance of fresh stage carriage permit. Hence, STA decided to reject the request of the applicant.

1.2 CONTRACT CARRIAGE PERMITS (2-W)

a) Fossil Fuel Two Wheeler (CC-2W)

1. TWO WHEELER- SOUTH ANDAMAN

STA was informed that 04 (Four) applicants have applied for NOC to purchase 20 fossil fuel driven Two wheelers for obtaining Contract Carriage (2-W) permits under Rent a Motorcycle Scheme.

However, to promote E- Vehicles in the UT, STA in its previous meetings, decided that the number of a maximum of five fossil fuel driven two wheelers shall be permitted in the License under Rent a Motor Cycle Scheme as the minimum number of two wheelers to obtain the license is five. Any additional requirement would have to be with EVs only.

As contract carriage permits are a pre-requisite to apply for license to rent out Two wheelers under Rent a Motorcycle Scheme 1989, the applications have been considered by STA and approvals are given on case to case basis as mentioned in the TABLE:10 below:

1.3 AUTORICKSHAW PERMITS

As per section 73 of Motor Vehicle Act 1988, STA has prescribed the following conditions for obtaining a Particular Contract Carriage permit/ NOC:-

1. Type of the vehicle to be mentioned in the application
2. Vehicle to be owned by the applicant.
3. Should possess own driving license to drive LMV/ 3 Wheeler.

- 4. Only one autorickshaw permit will be issued to one person.
- 5. Should submit address proof.
- 6. Requirement of parking place would be compulsory for all kinds of commercial vehicles.
- 7. Affidavit showing that the applicant is unemployed.
- 8. Should submit Parking area certificate.
- 9. NOC of the land owner if the applicant does not possess own parking area. Photo of parking area, copy of record of rights and Map of land.
- 10. Copy of Local Certificate/Islander Card.
- 11. Proof of age showing that the age of applicant is below 60 yrs.

a. Various applications as mentioned in the below table have been received for the period from 01.11.2023 to 29.12.2023 under Section 73 of the MV Act in the STA for grant of NOC/Permit for plying Particular Contract Carriage (PCC) Autorickshaw. The route wise details are as under: (13)

As regards to issuance of NOC for Autorickshaw permit / NOC, it is to apprise that in order to ensure proper implementation of the decisions taken by the STA in its meeting dated 09.06.2023 decided that the applications received for grant of NOCs / Permits for passenger Autorickshaw may be got verified independently by two level Committees i.e. 1st Committee at STS Unit level and 2nd Committee at Directorate of Transport level. Accordingly, the two level Committees were constituted vide Order No. 2498, dated 03/07/2023. **147 applications** (101 South Andaman + 43 North & Middle Andaman + 03 Little Andaman), which were received till 07.06.2023 were placed in the meeting held on 09.06.2023 wherein STA decided to get it verified by 2nd level committee. Complying with the direction of STA, the 2nd level Committee examined all the 147 cases of fresh NOCs along with other Transfer cases and kept all the cases pending for issuance of proper clarification on certain points of the guideline frames in 2007.

Accordingly, STA decided to obtain legal opinion from the Law Department by framing specific query as raised by the Committee pertaining to the guidelines/ conditions mandated by the STA vide its minutes of the meetings dated 2007, 2017, 2018, 2021 & 2023.

Complying with the decision of STA, the matter was taken up with Law Department and on the point of “unemployed” the Law Department opined that the word unemployed has not been defined/ explained by the Department. On the other two points i.e. “whether person having permits for other categories of commercial vehicle should be given NOC / permits for passenger Autorickshaw or not?” and “whether the additional conditions would also be applicable in the case of transfer of vehicle / permit of passenger autorickshaw where fresh permits are issued in his / her name for a old purchased vehicle”, the Law Department opined that being administrative in nature, a policy decision may be taken at Administrative level.

MINUTES OF THE STA MEETING SCHEDULED ON 05.01.2024 (AGENDA: 01/2024)

To have a specific explanation/ definition on “unemployed”, the Labour Department was requested vide letter dated 15.12.2023 and the Labour Commissioner vide letter no. 13/MIS/2010-20/LC&DET/(PF)/1264 dated 27.12.2023 stated that according to the Report on Youth Employment-Unemployment Scenario Vol-II, 2015-16, Govt. of India, Ministry of Labour & Employment, Labour Bureau, Chandigarh the definition of the term “unemployed” means **“Persons, who are owing to lack of work, had not worked either sought work through employment exchanges, intermediaries, friends or relatives or by making applications to prospective employers or expressed their willingness or availability for work under the prevailing condition of work and remuneration are considered as those who are ‘seeking or available for work’ (or unemployed)”**. Further, the LC advised that STA may obtain “Unemployment Certificate” issued by Tehsildar from the applicants at the time of making applications for NOC to subordinate the proof of “unemployed”. Also, an undertaking from the applicant may be obtained stating that they are neither employed in the Government/ Private Sector nor Self-Employed before processing the applications for issuance of NOC/ Permits for passenger autorickshaws

STA was further apprised that in the absence of proper clarification as sought by the 2nd level Committee, all the cases of fresh NOCs and Transfer cases received till 31.10.2023 were deferred in the STA meetings held on 09.06.2023, 30.08.2023 & 03.11.2023. During the period from 01.11.2023 to 29.12.2023, 61 more applications for issuance of NOC/permit and 26 transfer cases have been received in respect of passenger Autorickshaw. The details of pending applications of fresh NOC and Transfer of ownership in respect of passenger Autorickshaw are mentioned as detailed under:

STA decided to get all the applications 423 cases of Fresh NOCs & 119 transfer cases mentioned in the above Table:14&15 examined by the Directorate Level Committee constituted vide Order No. 2498 dated 03/07/2023 in light of the clarification obtained from Labour Commissioner and furnish recommendation in the next STA meeting for taking a decision.

b. Application for replacement of autorikshaw after condemnation and transfer of permit.

Smti. Muthuamma vide her application dated 14.11.2023 has applied for the transfer of permission memodated 03.03.2023 in her son's namely Shri. R. Tulukanam for the vehicle bearing registration No. **AN01/B-4768** (Auto) having route permit to ply in all routes of South Andaman.

It is to submit that the vehicle was condemned vide Letter of Intent No. MVD/SCR/2022/106 dated 10.11.2022 and accordingly permission memo was issued on 03.03.2023 to purchase of new Autorickshaw for commercial purpose in favour of Smti. Muthuamma. The case was earlier placed in STA meeting held on 03.08.2022 and the same was approved for condemnation& replacement of existing vehicle.

Further applicant stated that the permit holder Smti. Muthuamma had applied for loan for the purchase of new autorickshaw but the bank has rejected her request on account of her overage i.e. above 60 years.

Now, Smti.Muthuamma requested to transfer the condemnation memo in her son's name, Shri. R. Tulukanam so as to avail loan from bank for the purchase of new autorickshaw.

STA after examining the case of the applicant, decided to obtain the following:

- a. Willingness of Shri R. Tulukanam to purchase the Autorikshaw against the permission memo issued to his mother against the condemned Autorikshaw (AN01/B-4768).
- b. Copy of Local Certificate / Islander card of Shri R. Tulukanam
- c. Undertaking from Shri R. Tulukanam mentioning that he is an unemployed youth.

1.4 PUBLIC CARRIER PERMITS (GOODS PERMIT)

a. ISSUE OF NOC/ PERMIT FOR PUBLIC CARRIER

SP (Traffic) for examination and to furnish report before the next STA meeting for further consideration. In compliance to the decision of the STA, a letter dated 16.11.2023 was sent to the Dy. SP (Traffic) with the request to ascertain the feasibility of route and timing for movement of 24 ft. Trailer (TATA Signa 2823.T BS-VI). The Dy. SP (Traffic) vide his letter dated Dy. SP (Traffic)/2023/477 dated 21/11/2023 examined the case and submitted his report on the above subject with the recommendation to restrict the movement of the above mentioned vehicles to the mentioned timings i.e. 07:30 Hrs to 09:00 Hrs, 13:00 Hrs to 14:30 Hrs and 17:00 Hrs to 19:30 Hrs.

Later, the firm M/s. Shakthi Shipping Logistics Pvt. Ltd. vide their application dated 29.11.2023 requested to allow the registration of the above mentioned 04 vehicles stating that at the time of application for NOC, they had wrongly mentioned the said trucks as trailers due to which the registration of the said vehicles are pending. The said vehicles (04 vehicles, TATA Signa 2823.T BS-VI 24 ft.) are not trailers and comes under trucks category. Few other 24 ft goods vehicles have already been registered earlier in the RTO, Port Blair and normal PC permits have been issued by STA, considering these facts, Secretary (Transport) / Chairman (STA) has given in-principle approval in this case and allowed the vehicles for registration in the RTO, Port Blair and obtain permit from STA. **The case is proposed for ratification.**

Further, the said trucks are of longer length i.e. 24 Ft., the PC permits may be issued with the recommended timings by the Traffic Police.

STA ratified the approval of Secretary (Transport) / Chairman (STA) for registration of the four 24 Ft goods vehicles. STA further approved the request of the applicant for issuance of permits complying with the recommendation of the Dy. SP (Traffic).



2. CONSIDERATION OF RESIDENT CERTIFICATE INSTEAD OF ISLANDER IDENTITY CARD/LOCAL CERTIFICATE FOR GRANT OF NOC FOR PLYING AUTORICKSHAW -PCC

It is to inform that applications have been received by the STA wherein, the applicants who do not possess the Local Certificates/ Islander Identity Cards have requested to consider the Resident Certificates and Election Identity Cards issued in their name as they have been living in the Islands for many years instead of Local Certificates.

In the above context, it is to submit that in order to control the increasing number of vehicular traffic and to streamline the auto rickshaw operation in the town, STA in its meeting held on 23.04.2007 mandated the following conditions mentioned below for issuance of NOC to ply an auto rickshaw:

1. The permit will be issued only to the local unemployed people below 40 years of age.
2. Vehicle should be owned by the applicant.
3. Should submit his /her own driving license.
4. Should submit **Islander Identity Card or Local Certificate**.
5. However the condition of driving license may be exempted in case of physically handicapped and Tsunami affected people.
6. Not more than one permit to be issued to one person.

As such, the NOC/ Permits for auto-rickshaws are only granted to the applicants who possess Islander Identity Card or Local Certificate in their name.

It is seen that applications have been received by the STA wherein, the applicants who do not possess the Local Certificates or Islander Identity Cards have requested to consider the Resident Certificates issued in their name by the Tehsildar in place of Local Certificates/ Islander Identity Cards as they have been living in the Islands for many years instead of Local Certificates. In some cases, it is mentioned in the Resident Certificate that the applicant has been staying in the UT for 30 years.

In this regard, the Deputy Commissioner, South Andaman has been requested vide this Directorate's 'Note' dated 25.07.2023, Letter dated 09.10.2023, 11.12.2023& 01.01.2024, to clarify that whether the applicant possessing Resident Certificate issued by the District Administration can be treated equivalent to Islander Identity Card or Local Certificate. The clarification from District Administration in this regard is still awaited.

STA decided to seek clarifications from the District Administration, South Andaman as to whether the resident certificate can be considered along with Islander Card/ Local Certificate for grant of NOC for plying autorickshaw and clarify the matter without further delay to dispose off the applications wherein the applicants, possessing Resident Certificate in place of Local Certificate/ Islander Card, have requested to consider permit for autorickshaw.



3. CONSIDERATION OF REQUEST TO PLY AUTORICKSHAW THROUGH A DRIVER

a. Shri. K. Somesh Rao, S/o. K. Pottaiah, R/o. Dairy Farm vide his application dated 18.12.2023 has requested to permit him to ply his autorickshaw bearing Registration No. AN01/Q-2026 having permit to ply in all routes of South Andaman through a driver.

The applicant has stated in his letter that he had purchased the said vehicle by availing loan from State Bank of India, Prothrapur in the year 2020. Due to his health issues, he is unable to drive his autorickshaw for the last 2 months which he used to do on a part time basis as he is employed as a Daily Rated Mazdoor. He has further stated that in order to support his and his sister's (who is a widow and a single mother) family, he had given his autorickshaw to another driver named Shri. Jishu Debnath having Driving License No.WB51 2010 0048022 to ply his autorickshaw.

It is submit that the autorickshaw bearing registration number AN01/Q-2026 was registered on 22.09.2020 in the name of Shri. K. Somesh Rao having valid permit vide no. PCC/STA/20/257 dated 23.10.2020 to ply in all routes of South Andaman.

Further, Shri. K. Somesh Rao has requested to permit to him to ply his autorickshaw through the said driver by entering his name in the permit till his health condition is improved and his sister is financially stable.

STA after examining the case decided to obtain Local Certificate/ Islander Identity Card of the driver who will be driving the said autorickshaw and put up in the next STA meeting for taking a decision.

b. Smti. Rajeshwari, D/o. Late. Kurma Rao, R/o. Dollygunj vide her application dated 19.12.2023 has requested to permit her to ply his autorickshaw bearing Registration No. AN01/P-9713 having permit to ply in all routes of South Andaman through a driver, Shri Subrata Ghosh, S/o. Shyamal Ghosh, R/o. Dollygunj, Port Blair.

The applicant has stated in her letter that she is a local, unemployed disabled/ handicapped person and she has purchased autorickshaw bearing registration number AN01/P-9713 for her survival as she has no other source of income. Since, she is a handicapped person, she is not in a position to driver her autorickshaw. To ply her autorickshaw, she has engaged a driver named Shri. Subrata Ghosh, S/o. Shayamal Ghosh, R/o. Dollygunj having valid Driving License No. AN01 20140002238.

It is submit that the autorickshaw bearing registration number AN01/P-9713 was registered on 20.03.2020 in the name of Smti. Rajeshwari having valid permit vide no. TSR/STA/20/225 dated 24.06.2020 to ply in all routes of South Andaman.

Further, Smti. Rajeshwari has requested to consider her case on humanitarian and sympathetic ground and allow her to ply her autorickshaw through a driver, Shri Subrata Ghosh by entering his name in the permit.

It is further to apprise that as per the conditions mandated by the STA in its meeting held on 23.04.2007, the condition of driving license may be exempted in case of physically handicapped and Tsunami affected people.



STA after examining the case decided to obtain Local Certificate/ Islander Identity Card of the driver who will be driving the said autorickshaw and put up in the next STA meeting for taking a decision.

4. VIOLATION OF PERMITS

- i. It is to apprise that in the matter of unauthorized aggregation for passenger Autorickshaw, STA in its meeting dated 09.06.2023 had directed to Traffic Police to conduct enforcement drive against any kind of violation of permit conditions and submit fortnightly report to STA. Accordingly, DySP (Traffic) conducted enforcement drive and report furnished vide letter dated 25.07.2023 stating that during the enforcement drive conducted on 05.07.2023, 07.07.2023 and 09.07.2023, 11.07.2023, 15.07.2023 and 19.07.2023, 54 passenger autorikshaws were found violating the condition of permits as the vehicles were not driven by the person whose name is entered in the permit.

Accordingly, as decided by STA in its meeting held on 30.08.2023, Show Cause Notices under Section 86 of MV Act, 1988 were issued to all the 54 permit holders dated 20.10.2023 for violation of permit conditions. Out of the 54 permit holders, 03 persons had responded.

The cases were placed in the STA meeting held on 03.11.2023 wherein STA decided the following:

- a. **Secy, STA to check each case to verify whether the permit was issued prior to/ after framing of guidelines/ additional conditions in the year 2007.**
- b. **In case, the permit has been issued prior to framing of guidelines/ additional conditions, the permit holder shall be asked to furnish details of driver to be entered in the permit.**
- c. **In case, the permit has been issued after the date of framing guidelines/ additional conditions and the permit holder responded to the SCN, a stringent warning may be issued with the direction to furnish details of driver to make entry in the permit.**
- d. **In case, the permit has been issued after the date of framing guidelines/ additional conditions, and the permit holder did not repond to the Show Cause Notice, permit may be suspended for 02 months with the liberty to the permit holder to make representation against the suspension order. The permit holder may be further asked to furnish details of driver to enter in the permit.**
- e. **Traffic Police to enforce the suspension order with immediate effect.**

Complying with the decision of the STA, records were preliminary scrutinized and observed in the 54 cases, 08 permits were issued prior to framing of guidelines in 2007. One (01) permit holder of Autorikshaw (AN01J8005) had applied for transfer of permit in the name of Shri. V Vijay Kumar a local Islander having DL No.AN01 20120001073. On verification of the report of DySP (Traffic), it was observed that Shri V Vijay Kumar was driving the vehicle though his name has not entered in the permit yet. 03 permit holders have responded to the Show Cause Notice, hence warning has been issued to the 03 permit holders with the direction to furnish the details of person who will be driving the Autorikshaw. Moreover, 37 permits have been suspended with the liberty to the permit

holders to make representation to STA against the suspension order. Suspension of Permits in respect of 05 left out Autorikshaws could not be issued as the concerned files of these vehicles were missing. Now all the files have been traced out and action has initiated to suspend the permits.

STA was apprised that in the cases of 37 suspended permits, 02 permit holder whose Autorikshaws are presently kept in Police Station, approached STA with the request to revoke the suspension orders as they have sold out their Autorikshaws and the purchasers have applied for transfer of permits. On scrutiny of records it has been observed that applications of the two permit holders bearing Regn. No. AN01D 8862 & AN01 D5773 have been received in the STA for transfer of permits and both the cases have been deferred along with other cases of transfer cases. The persons driving at the time of enforcement of Police are the purchasers of these 02 two autorikshaws.

STA examined the request of the permit holders of two Autorikshaws bearing Regn. No. AN01D 8862 & AN01D 5773 and observed that the details of drivers (purchasers in the case) have already been disclosed to STA by the permit holders. Hence STA decided to revoke the two suspension orders issued against vehicle bearing Regn. No. AN01D 8862 & AN01D 5773.

- ii. It is to apprise that the DySP (Traffic) vide their two letters dated 20.10.2023 and 01.11.2023 had furnished the list of 39 and 248 Passenger Autorickhaws wherein the autorikshaws were found driven by some other persons whose name is not entered in the permit thus violating the permit condition of passenger Autorickhaw. The matter was placed in the STA meeting held on 03.11.2023 wherein STA decided the following:
 - a. **Secy, STA to check each case to verify whether the permit was issued prior to/ after framing of guidelines/ additional conditions in the year 2007.**
 - b. **In case, the permit has been issued prior to framing of guidelines/ additional conditions in 2007, the permit holder shall be asked to furnish details of driver to be entered in the permit.**
 - c. **In case, the permit has been issued after the date of framing guidelines/ additional conditions, a “Show Cause Notice” may be issued and put up such cases in the next STA meeting for taking decision.**

Complying with the decision, STA section scrutinized the cases and in the first instant it has been observed that out of the total 287 cases, repeated name and vehicle numbers were found in 49 cases. Moreover in 07 cases, the vehicles are not Autorikshaws as per Vahan application. In 07 cases, the permit owners have already applied for transfer by disclosing the name purchasers name and the vehicles were found driving by the purchasers. Hence, records of all the remaining 224 cases were verified in which 34 permits were found to be issued prior to framing of guidelines in 2007. Further, Show Cause Notices have been issued to the remaining 190 permit holders for the violation of permit condition in which 86 permit holders have responded so far. The details of 190 Autorikshaw permit holders to whom show cause notices have been issued are as under:

STA was also apprised that during preliminary verification, in 07 cases mentioned in the above table, permit holders have sold out their Autorikshaws and the purchasers have applied for transfer of permits. During the enforcement drive by Police, the purchasers were being driving the autorikshaws instead of the permit owner whose name is presently entered in the permit.

STA meeting after examining the 190 cases, decided the following:

- a. The permit holders who have responded to the Show Cause Notices, the representations may be referred to the Directorate Level Committee constituted vide Order No. 2498 dated 03/07/2023 for examination and recommendations of committee may place in the next STA meeting for taking a decision.
 - b. In cases, where the permit holder has not responded to the Show Cause Notices, the permit may be suspended for 02 months with the liberty to the permit holders to make representation to STA against the suspension order if he willing so. The permit holder may be further asked to furnish details of driver to make entry in the permit.
 - c. Traffic Police to enforce the suspension order with immediate effect.
- 5. MATTER RELATED TO SUSPENSION OF PERMITS / CANCELLATION OF NOCS OF AUTORICKSHAW (PCC)**

- a. **Suspension of Permits & cancellation of NOCs as per the decision taken by STA in its meeting 09.06.2023:**

In compliance with the decision of STA in its meeting held on 09.06.2023 in the matter of plying multiple autorickshaws by single person after obtaining permits in the name of different eligible persons, STA suspended 27 permits passenger Autorickshaw and cancelled 07 NOCs. The individuals were given opportunity to make representation before STA with proper evidence that the vehicle is self financed and operated by him / her and that the vehicle is a single vehicle which is owned by them in these category, within a period of 15 days from the date of issuance of the individual orders.

Aggrieved by the decision of STA for suspension of 27 permits, 21 permit holders filed writ petitions before Hon'ble High Court at Calcutta in which the Hon'ble Court set aside all the 21 suspension orders with the direction to STA to give the petitioners an opportunity to hear in person and consider or reject their representations in accordance of law.

Complying with the above direction, all the petitioners were heard in person and given opportunity and after careful examination of records, submissions of petitioners in their representations dated 07.08.2023, 08.08.2023 & 09.08.2023, oral & material evidences produced by individual petitioners during their personal hearing on 16.08.2023, evidence furnished by the petitioners against the final opportunity vide orders dated 18.08.2023 and consideration of all the facts & circumstances of the case as per the provisions under Section 86 of MV Act, 1988, the brief of individual 21 cases were placed in the STA meeting held on 30.08.2023. STA in the said meeting examined all the 21 cases carefully and

decided to cancel 07 permits with immediate effect as the allegation of misusing the guidelines prescribed by STA for issuance of autorickshaw permit and given it to unauthorised person for driving the vehicle was clearly established.

To take appropriate decision in respect of the remaining 14 cases, STA decided to obtain additional information from the dealer, Financier and Traffic Police on each case. The matter was placed in the STA meeting held on 03.11.2023 wherein STA decided to suspend the permits of 07 permit holders for a period of 2 months and also obtain the details of the driver to enter in the permit. For the remaining 07 cases, STA directed to obtain report from the Traffic Police.

Complying with the decision, DySP was requested vide letter No.10602 dated 04.12.2023 to inspect and verify the driver presently driving the above 07 Autorikshaws. DySP (Traffic) informed that out of 07 vehicles, 01 Autorikshaw could only be intercepted so far during enforcement drive which was found to be driven by some other person whose name is not entered in the permit thus violating the condition of permit.

The 07 cases were placed before STA and the decision taken by STA in each case is detailed in the TABLE: 27 below:

STA desired that the Committee constituted vide Order No. I/2359/2022 dated 03/11/2022 shall examine all the cases mentioned at TABLE: 33 and submit specific recommendation with regard to current availability of public transport in the area, requirement of commuters in the area, viability for the operators, impact on the residents of the area in the event of change of route etc.

It appears that Shri. Ram prosad Gharami has **rented the motorcycles without having valid license** and thereby violation of the provision contained under rent-a-motorcycle scheme 1997/MV Act. Though, **no penalty clause** exists in the Scheme for penal action for renting motorcycle without having valid license but the STA can suspend the permits of the vehicles or can impose mutually agreed penalty as the vehicles were rented without License under the scheme. Now, the applicant vide his letter dated 18.12.2023 has requested for change of type of vehicle in the Letter of Intent from Electric Two Wheeler to Fossil Fuel Two Wheeler. As per records, the applicant has not purchased the 05 fossil fuel two wheelers so far.

STA decided to reject the request of the applicant in order to promote E-vehicles in the UT.

17. PRODUCTION OF VEHICLES AT THE TIME OF REGISTRATION

It is to apprise that a letter has been received on 16.12.2023 from Federation of Automobile Dealers Associations (FADA) regarding physical inspection of new vehicles.

In the said letter, it has been stated that considering the road safety, Transport should discontinue the physical inspection of new vehicle as after the implementation of VAHAN, the vehicle details are uploaded by the manufacturer once the vehicles are billed from the plant. After invoicing of vehicles by OEMs an e-waybill is generated by them in which the transportation details from the plant to their dealer location is clearly mentioned along with the invoice details which clearly provides details that the vehicles have reached the dealer point. The e-waybills and invoices of few OEMs have been enclosed for reference.

Further, it has been requested to discontinue the physical inspection so as to reduce congestion and provide better road safety for the public.

In the above context, it is to apprise that, as per Section 44 of the MV Act, 1988 and Section 48B of the Motor Vehicle Rules, 1989, **"a motor vehicle sold by an authorised dealer shall not require production before a Registering Authority for**



the purposes of registration for the first time if it is a fully built motor vehicle. However, an officer not below the rank of Motor Vehicle Inspector of the Motor Vehicles Department may randomly inspect any vehicle in the inventory at the premises of the dealer.”

In this regard it is to apprise that the physical inspection of the vehicles including commercial vehicles at the time of registration are carried out by the Transport Department through the Motor Vehicle Inspector to ensure that the vehicles are physically reached in the Islands.

From the Invoices generated by OEMs and e-way bills thereof, in which the transporter enters the details, the location of vehicles can be seen. If the e-way bills mentions the entry of reaching point at Port Blair, it can be ensured that the vehicles have been reached Port Blair and in such cases, the vehicles can be registered at Port Blair RTO. There would be any requirement of further physical verification at RTO, Port Blair.

STA observed that the physical inspection of the vehicles including commercial vehicles at the time of registration are carried out by the Transport Department to ensure that the vehicles have physically reached the Islands as earlier, there were instances wherein the dealer of the vehicle had registered the without bringing the vehicle in the islands in order to evade taxes.

However, with the present system in force wherein the transporter enters the details of the location, where the vehicle is to be transported, in the e-way bills and invoices generated by OEMs which ensures the physical presence of the vehicle in the particular location.

STA decided to accept the request of the FADA to discontinue the physical inspection of the ready built vehicles at the time of its initial registration and the dealer needs to furnish e-way bills and invoices generated by OEMs.

18. CUSTOMIZATION OF PERMIT MODULE OF VAHAN SOFTWARE

It is to apprise that the State Transport Authority is the constitutional body responsible for issuing NOCs/ Permits for all the transport category vehicles plying in the Union Territory of A & N Islands.

Even though, the Transport Department has implemented the permit module of VAHAN 4.0 software to digitize the entire process of issuing of NOCs/ Permits etc, some of the processes are still carried out in the offline mode and as such the same cannot be tracked in the online flow in the software.

In the present system, the application for grant of NOC is initially entered in the permit module and the applicant is being provided with an acknowledgement generated from the VAHAN software. After scrutiny of documents submitted by the applicants, all such applications are then placed in the meeting of the STA. On getting approval of STA and subject to parking verification, an intimation letter is being sent manually to the applicant with the request to furnish PG for issuance of NOC. The PG varies for different

categories of vehicles. The said letter is being dispatched through postal service to the address mentioned by the applicant. However, many instances have come to light wherein the said letter does not reach the applicant and the submission of security deposit by the applicant gets delayed. On submission of the security deposit, the No Objection Certificate/ Letter of Intent is prepared manually in the offline mode with the validity of one year from the date of signing of minutes. The applicant after purchasing and registering the vehicle in the RTO, Port Blair applies for grant of permit by making application which enters separately in the permit module without linking the earlier application of NOC. The application is then processed further and after obtaining approval of the Competent Authority, the applicant is informed to remit the requisite fees through SMS from the VAHAN portal. The applicant then submits the fees and then the permit is generated from the VAHAN portal which is informed to the applicant through SMS after necessary approval. In order to prevent delay, an option of one more SMS has been introduced in the VAHAN software wherein the applicant would receive SMS informing him/her to submit his/her security deposit once the STA approves his / her application for NOC.

However, in order to enhance transparency and complete digitization of the permit process, it is proposed to carry out the below mentioned processes through the Permit module of VAHAN software:

1. Generation of NOC/ LOI with the provision of modifying the validity period in the case of extension of NOC/ LOI.
2. Change of vehicle in the NOC/ LOI.
3. Change/ inclusion of route/ jurisdiction in the NOC/ LOI.
4. Cancellation of NOC/ LOI on the request of applicant.
5. Provision of generating acknowledgment at the time of making application for permit.
6. Fine for delay in apply of permit if any (vehicle plied without permit) as per Order No. I/8619/2023 dated 12.01.2023 along with the permit fee while applying for permit.

Subject to approval, NIC shall be requested to customize the permit module.

STA after examination of the proposal, decided to accord approval for customization of the permit module of VAHAN Software and introduce a system of issuing SMS at every stage for the information of the applicant.

19. CASES OF SWARAJ DWEET & SHAHEED DWEET

A. CONSIDERATION OF CASES FOR GRANT OF PERMITS FOR SWARAJ DWEET AND SHAHEED DWEET

- (i) Considering the recommendations in the study report received from DBRAIT and to meet the immediate requirement of commercial vehicles for the tourism activities of the two Islands of Swaraj Dweet and Shaheed Dweet, the STA in its meeting held on 30.08.2023, in the first instance, decided to grant NOC/ permit in respect of M2 and M3 category of vehicles.

Based on the above decision, 15 applications for M2 category vehicles pertaining to SwarajDweet and 09 applications pertaining to ShaheedDweet had been taken for consideration for grant of NOC/ Permit for different categories of vehicles to ply in SwarajDweet and ShaheedDweet respectively in the meeting of the STA held on 30.08.2023. However, before granting NOCs, STA decided to obtain willingness/

requirement of the applicants as on date and to place the same in the next meeting as the applications in these cases had been made 1-5 years back.

Complying with the above decision, letters were issued to all the 24 applicants with the request to furnish the willingness/ requirement as on date for the NOC to purchase different M2 categories of vehicles.

Accordingly, 10 applicants pertaining to SwarajDweep and 06 applicants pertaining to Shaheed Dweep have furnished their willingness/ requirement as on date. For the remaining 05 applications for SwarajDweep and 03 applications for ShaheedDweep, STA in its meeting held on 03.11.2023 decided to send reminders to the applicants who have not responded and to submit all the cases in the next meeting for taking a decision.

Complying with the above decision, letters were issued to all the remaining 08 applicants with the request to furnish the willingness/ requirement as on date for the NOC to purchase different M2 categories of vehicles. Out of the 08 applicants, 01 applicant each from Swaraj Dweep & Shaheed Dweep submitted his willingness. The present statuses of all 24 applications are as under:

Pramukh/PBPS/2023/140 dated 26.12.2023 has requested to give one time relaxation to the local unemployed youths of Shaheed Dweep to get permit for fossil fuel driven two wheelers to ply in Shaheed Dweep.

She has raised some issues to run electric scooty at Shaheed Dweep which are detailed as under:

1. The condition of main roads of Shaheed Dweep is so poor that the electric vehicle needs regular maintenance.

2. No workshops are available at Shaheed Dweep for carrying out the repair works which has compelled the youths who have purchased electric scooty to stop their business.

STA decided to defer the case till the next STA meeting for taking a decision.


