These e-Cars were already reached Port Blair and awaiting for commercial registration in the RTO, Port Blair. As per the decision of STA in previous meetings for encouraging and promoting electric vehicles for commercial purposes in Shaheed Dweep, Secretary (Transport) / Chairman STA has accorded in-principle approval to issue NOC/Permit for registration of e-Cars of both the applicants to ply in all routes of **Shaheed Dweep.**

In Order to promote E-mobility and non polluting vehciles in Shaheedj Dweep, STA ratified the decision of Chairman STA for issue of CC permits to the above two e-Cars to ply in all routes of Shaheed Dweep.

1.2 CONTRACT CARRIAGE PERMITS (2-W)

JRUISDICTIONS:

a) South Andaman

STA was informed that 10 (Ten) applicants have applied for NOC for purchase of 88 (Eighty Eight) fossil fuel diven Scooters / Motor cycles for obtaining Contract Carriage (2-W) permits under Rent a Motorcycle Scheme.

However, to promote E- Vehicles in the UT, STA decided that the number of fossil fuel driven two wheelers may be restricted and minimum requirement to obtain a License under 'Rent-a-Motorcycle' Scheme i.e 05 two wheelers of fossil fuel driven each may be allowed for all the applicants, rest of the two wheelers applied may be taken as Electric Two wheelers.

On the basis of the above decision, STA approved the cases of 10 applicants is given in <u>TABLE 6</u> below for issuance Contract Carriage (2-W) Permits subject to the condition that the applicant shall parallelly apply for license under "Rent a Motorcycle Scheme" and shall not operate the Two Wheelers on hire without obtaining License under 'Rent a Motorcycle Scheme'.

STA further decided that in order to promote electric vehicles for commercial purposes, henceforth no NOC/Permits shall be issued for purchase of fossil fuel 2-W to those applicants who are already having fossil fuel 2-W with a license under Rent a Motor Vehicle Scheme.

c) 40 ft Low Bed Trailer (TATA Make BS-VI)

STA was appraised that the firm M/s A&N Logistics Pvt. Ltd. earlier applied for NOC for purchase of 40 Feet Low Bed Trailer-Tata BSVI trailer without specifying route and time. During the STA meeting held on 02.12.2022, the applicant's request was not considered, and STA decided to obtain clarification from the firm about the route and the timing in which the firm intend to ply the vehicle. After being informed of the decision, the firm requested issuance of NOC for 40 Feet Low Bed Trailer-Tata BSVI Trailer to ply in a

praticular route in between **Haddo wharf to Jirkatang** and vice versa with its operation **during day/night except during school time**.

STA in its meeting dated 13/02/2023 directed to refer the case to DySP (Traffic) for their assessment on the route and timing and furnish report before the next meeting of STA. Dy.SP (traffic) in his report dated 10.03.2023 recommended to issue NOC for 40 ft. trailer specifying the route between **Haddo Wharf to Jirkatang** and vice versa within the operated timing between **09.00 PM to 05.00 AM**.

STA has examined the recommendation of DySP (Traffic) in this matter and decided to approve the route and timings as recommended for issuance of NOC.

d) 40 ft Low Bed Trailer (TATA Make BS-VI)

STA was appraised that the firm **M/s RDS Project Ltd.** has obtained NOC from STA on 16.02.2021 for purchase of TRAILER with the validity 15.08.2021 to ply the vehicle in NMS route. The firm purchased the Trailer and **got registered on 17.09.2021 with Regn.**No. AN 01 Q 8137 (BS-VI). But the firm applied for permit only on 14.02.2023 after 01 year and 4 months. The firm also applied for change in the route from NMS to ply in a particular route in between **Haddo wharf to Jirkatang and vice versa** with its operation timing **09.00**PM to **05.00** AM for the said vehicle.

Hence, STA has examined the request and directed to send the proposal to DySP (Traffic) to review the matter on the basis of number of 40 ft. low bed trailers plying in that specified route and timing to avoid traffic congestion, also to comment on the status of the vehicle whether it had been plied between 17/09/2021 to 14/02/2023.

2. NOC RELATED MATTERS

2.1 ISSUE OF NOC FOR OBTAINING BANK APPROVAL FOR VEHICLE PURCHASE

Request has been received from M/s Pristine Andaman to issue NOC for the above fleet to enable the firm to get the Banker's approval for the purchase of vehicle.

STA was appraised that **M/s Pristine Andaman** is a registered vendor for providing vehicles on hire to the Govt. organizations. The firm has maintained a fleet of 20 vehicles presently and planning to add another 22 vehicles in their fleet, out of which they intend to purchase 20 Sedan (Maruti Dzire Tour S/Honda Amaze) and 02 Premium Sedan (Honda City/ Maruti Ciaz) vehicles.

STA was also informed that in the previous STA meeting held on 03.08.2022, STA approved 25 vehicles (20 SUV + 05 Pr. SUV) to this firm. The instant request for 22 vehicles from the firm is in addition to the approved 25 vehicles.

STA has examined the request and decided to seek clarification from the firm as to whether they have purchased & registered the 25 vehicles against the NOC granted earlier by STA.

5. ISSUE OF NOC FOR TRANSFER OF COMMERCIAL VEHICLES PURCHASED IN AUCTION PROCESS

5.1 PURCHASED FROM FINANCIER

STA was appraised that in the below **02** cases, the vehicles were registered under Transport Category with Hypothecation to various Financiers. The vehicle owners became defaulters due to non-payment of EMIs of loan. As such, the Financiers reposed the vehicles and sold the vehicles to the highest bidders through auction process. As per the request of Financiers, these cases have been initiated to transfer the vehicle in the name of financier after giving an opportunity to the registered owner for submitting his representation within 07 days as per Rule 51 (5) and 61 (3) of CMVR, 1989. Being Transport Category vehicles, NOC from STA would be required for transferring these vehicles. The Society has condemned the vehicle when it outlived its useful life and became unserviceable. The unserviceable vehicle was sold / autioned by the Society treating it as 'Scrap' and permitting the vehicle compromising the safety of other road users, for its furher usage for commercial purpose may not be appropriate.

Moreoever, STA was also appraised that Ministry of Road Transport has recently issued a Notification to scrap all the Government vehicles which have completed 15 years of its life span from 01.04.2023.

Considering the above factors, STA decided not to consider the request of the applicant to use the vehicle for commercial use.

6. APPLICATIONS FOR RENEWAL & CHANGE OF ROUTE IN THE EXISTING PERMIT

6.1 CHANGE OF ROUTE

STA was informed that **03 applications** have been received for change of route in existing permits. **STA approved the case as given in <u>TABLE</u>** for change of jurisdiction in existing permits:

STA was appraised that at the time of issuing the permit of the above said vehicle, STA was issuing permit to 10 wheeler goods vehicle to ply with in a specialised area with timing. Off late, STA has considered the 10 wheelers as normal goods vehicles and started giving permits with normal route as being given to other goods vehicles without restricting the time in the permit. The routes and timing is now restricted only in the case of 40 ft. Trailers because of its extra long length that requires more space on the road to negotiate the curvy roads which it is not feasible in the day time when traffic movement is more.

As such, STA approved the case for minor change of route in existing permit.

- 7. APPLICATIONS FOR REPLACEMENT WITH NEW VEHICLE AFTER CONDEMNATION OF THE EXISTING VEHICLE
 - 7.1 STA was informed that 14 applications have been received from permit owners for replacement with new vehicle after condemnation of the existing vehicle which have become old and the owners are willing to dispose it by condemning.

As replacement of vehicles after condemnation is permissible under Section 83 of MV Act, STA approved all the 14 cases subject to condition that the proposed vehicle for replacement should be of BS-VI compliant. List of applications is given in <u>TABLE</u> below:

7.2 STA was appraised that Mr. Santosh Soyal have applied for issue purchase memo for purchase of new vehicle against the condemned vehicle of similar class and nature.

STA was informed that the applicant had applied on 03/03/2022 for replacement of old vehicle with new vehicle after condemnation of old vehicle. As per the record, the case had been approved by the Director (Transport) and NOC had been issued for replacement. Now, the applicant after disposing the vehicle, approached STA with the request to issue purchase memo for purchase of new vehicle of similar class and nature:

STA was also informed that prior to the STA meeting dated 03.08.2022, the deicision on all the cases related to condemnation of old vehicles and replacement with new vehicles were being considered by the Director (Transport).

As such, STA approved the request of the applicant for purchase of new vehicle against the condemned vehicle of similar class and nature.

7.3 STA was appraised that **Shri. Manik Sikder** has applied for issuance of PCC (Autorickshaw) Permit or CC Permit for purchase of new vehicle against the condemned vehicle bearing registration No. ANO1 C1745 to ply in all routes of **Swaraj Dweep**.

STA was informed that the applicant was earlier applied on 28.07.2020 for replacement of his vehicle bearing registration No. ANO1 C1745 (Autorickshaw) with new vehicle after condemnation of the existing vehicle to ply in **Swaraj Dweep**. As per the record, the case had been approved by the Director (Transport) on 21.10.2020 and the applicant had informed to submit the requisite fee amount including delay fine of **Rs.17899.00** for issuance of permission memo for condemnation. However, the applicant failed to do so.

Now, on **15.03.2023** the applicant submitted that due to financial issue he failed to deposit the money on time and now he is willing to deposit the fee for permission memo with the request to **issue NOC** for purchase of new **Autorickshaw or Maruti Ertiga.**

 $$\operatorname{As}$$ such, STA approved the request of the applicant for replacement of old vehicle with the new vehicle of same nature to ply in all routes of Swaraj Dweep subjet to remittance of all the pending fines.

7.4 STA was appraised that Shri. Abul Kaish has applied for issuance of CC Permit to the new vehicle against the condemned vehicle bearing registration No. ANO1H 9222 (Chevrolet Enjoy) having permit to ply in all routes of Swaraj Dweep.

STA was informed that the applicant has earlier applied on 29/12/2019 for replacement with new vehicle after condemnation of his old vehicle bearing registration

No. ANO1 H9222. Accordingly, the applicant was granted permission on 14/02/2020 to condemn the old vehicle and to replace the same with new Maruti Ertiga Tour.

Now, the applicant approached STA on 14/12/2022 after condemnation of vehicle No. ANO1 H9222 on 02/12/2022. Applicant submitted the reason for delay that he has booked the vehicle Maruti Ertiga in Maruti Agency House but due to COVID 19, the dealer failed to deliver the same on time.

Now, the applicant has purchased a new vehicle Maruti Ertiga on loan and requested on 23.03.2023 to issue permission memo for registering it in Transport Category for obtaining route permit for all routes in Swaraj Dweep. He has stated that he had been paying the EMI amount since last 05 months. This case was placed in the STA meeting dated 13.02.2023 and STA deferred it.

STA has examined the matter and approved the request of the applicant for replacement of Old vehicle with the new vehicle.

7.5 STA was appraised that **Shri. Parimal Mondal** earlier applied on 15/05/2019 for Transfer of Ownership and permit of the vehicle bearing registration No. **ANO1 C 9041** (TATA SE 1613 Tipper) to ply in **Swaraj Dweep r**oute. Accordingly, with the approval of Director (Transport) on **05/12/2019**, transfer Memo dated 20/12/2019 was issued to the applicant for transfer of ownership and permit. As such, the applicant transferred the RC of the vehicle in his name but did not apply for Transfer of permit on the basis of Memo and plied the vehicle till date having permit in the name of previous owner.

Now, the applicant submitted his application dated **04/04/2023** mentioning that the said vehicle is in dilapidated condition and intending to scrap the said vehicle. Further, the applicant requested to grant permission for replacement of the said vehicle with new **Tipper** to ply in all routes of **Swaraj Dweep**.

STA has examined the matter and approved the case subject to remittance of applicable penalty.

7.6 STA has also examined all the 08 cases of replacement of vehicles against condemnation in respect of Swaraj Dweep and Shaheed Dweep which were deferred in the previous STA meetings and as mentioned in TABLE (A) & TABLE 20(B) and decided to approve the cases mentioned at Sl. No 1-4 of Swaraj Dweep and Sl. No. 1 & 2 of Shaheed Dweep as the requests of the applicants in these cases are for purchase of new vehicles (BS-VI) after condemening the existing old vehicles. Further STA decided to defer the cases mentioned at Sl. No 05 of Swaraj Dweep and Sl. No. 03 of Shaheed Dweep as the requests of applicants are for transfer of permits to Non-BSVI complaint vehicles after condemning the existing old vehicles.

Shri. Abhishek Sarkar has applied for issuance of CC Permit to the vehicle bearing registration No. ANO1 L5256 (Mahindra KUV 100) (**BS-IV Compliant**) against the condemned vehicle bearing registration No. ANO1 E0713 having permit to ply in all routes of **Shaheed Dweep**.

The applicant, on 11/10/2019, has earlier applied for replacement with new vehicle bearing registration No. ANO1 L5256 (Mahindra KUV 100) after condemnation of his old vehicle bearing registration No. ANO1 E0713. Accordingly, the applicant was granted permission on 06/01/2020 to condemn the old vehicle and replace the same with ANO1 L5256 (Mahindra KUV 100).

Now, the applicant approached STA on 07/11/2022 after condemnation of vehicle No. AN01 E0713 i.e. after a period of 03 years approx. from the date of issuance of condemnation memo.

The vehicle bearing registration No. ANO1 L5256 (Mahindra KUV 100) is presently registered under **Non-Transport Category**.

7.7 SWAPPING OF VEHICLE IN ROUTE PERMIT/NOC:

STA was appraised that **M/s Coral Reef Resort Pvt.** applied on 09/12/2022 for transfer of permit to a new vehicle to ply in all routes of **Swaraj Dweep** and to issue NMS permit to their old vehicle bearing registration No. ANO1 M1679 (having route permit of Swaraj Dweep) with validity of route permit till **06/08/2027** which develops repair most of the time causing difficulties for the smooth operations to their guests in Swaraj Dweep.

STA was informed that the firm had applied for NOC on 08/04/2022 for purchasing new vehicle to ply in all routes of **Swaraj Dweep** but till date NOC has not been issued by STA due to which they are facing difficulties in running their hotels in Swaraj Dweep. The firm has also obtained a NOC from STA on 17.05.2022 for a new vehicle i.e. Mahindra Marazzo for plying in all routes of North, Middle and South Andaman. The firm is intending to bring back their existing vehicle bearing registration No. ANO1 M1679 from Swaraj Dweep and in place of this vehicle, they want to put a new vehicle by transferring the permit of AN 01 M 1679 against the NOC issued for NMS route. The case was earlier deferred in the STA meeting held on 13.02.2023.

STA examined the proposal, decided to consider the request of the applicant for swapping of vehicle route permit/ NOC.

8. REQUESTS OF TAXI OWNERS/ UNIONS

8.1 REVISION OF TAXI FARES:

STA was appraised that an application dated 12/01/2023 received from the General Secretary, Andaman & Nicobar Taxi Union for revising the taxi fare as per the latest market price. The fare proposed by the Taxi Union is mentioned as under:

Rs. 45/- for first one kilometre.

Rs. 2000/- for one day booking (i.e. 08 hours & 80 KMs minimum and additional

Rs. 20/- per KM extra charge).

Rs. 200/- for waiting charge for one hour.

As such, the case was placed in the STA meeting held on 13/02/2023, wherein STA decided to constitute a committee to analyse the expenditure on all factors for the operation of taxis and to submit its report on fare structure.

Accordingly, a committee has been constituted vide Order No. 14460 dated 09/03/2023 with the direction to submit its report before next STA meeting. Accordingly, the committee has submitted the following recommendations vide report dated 03.04.2023. As per the Committee recommendation, the fare detail is briefed as under:

- 1. Fare: Rs. 40 for first fall of 01 KM (upon downing the meter) for and thereafter Rs.20 per KM for Non-AC taxis and Rs.22 (10% higher) per KM for AC taxis for every additional Kilometre.
- 2. Night Charges: 40% extra over the normal fare (9 PM to 3 AM).
- 3. Waiting charges per 10 minutes: Rs. 10/- for 10 minutes of halt i.e 11th minute onwards.

As such, STA has decided to accept the recommendation of the Committee and directed to initiate proposal for issuance of Notification in this regard with the approval of the Hon'ble Lt. Governor.

8.2 STA was appraised that in the meeting held on 13.02.2023, STA has decided to constitute a committee with the composition of Dy. SP (Traffic), Sr. Accounts Officer (Transport), Assistant Director (Civil Supplies & Consumer Affairs), Assistant Engineer (Purchase – Transport Department), Transport Officer (Transport Department) for recommending the fare revision of Taxi in the UT of A&N Islands. Accordingly, an order vide No.I/14460/2023 dated 09.03.2023 was issued. Later, it was learnt that the process regarding calibration of fare-meter and other technical matters comes under the supervision of Assistant Controller (Legal Metrology). In the meantime, the Transport Officer has also been promoted to the post of Assistant Director (Transport). Being so, it was decided to revise the composition of the committee by replacing Assistant Director (Admn.) with Assistant Director (Legal Metrology) of Civil Supplies & Consumer Affairs and Transport Officer with Assistant Director (Transport) of Transport Department.

Accordingly, the revised order has been issued with the approval of Secretary (Transport)/ Chairman (STA). The amendment made in the order needs to be ratified by STA.

As such, STA ratified the revised Order approved by Secretary-cum- DoT.

8.3 AMENDMENTS IN ANIMV RULES FOR MODIFICATION IN COLOUR CODING FOR NEW TAXI:

STA was appraised that an application dated 13/01/2023 received from the General Secretary, Andaman & Nicobar Taxi Union for modification in colour coding for new taxis. The Taxi Union has requested to change the colour coding of the new taxi. They have proposed the colour two coding:

- 1. Entire vehicle body is in white colour and the LHS & RHS Body shall have a navy blue stip mentioning TAXI at the centre.
- 2. Entire vehicle body is in blue colour and the LHS & RHS Body shall have a yellow stip mentioning TAXI at the centre.

As per rule 70 (5) (a) of ANIMVR 2006, existing colour of taxi: colour of the hood should be in cream yellow and rest of the body in black.

As such, the case was placed in the STA meeting held on 13/02/2023, wherein STA decided to constitute a committee to analyse the colour coding of taxis plying in other states and UTs and as per suitability of colurs in term of MV Acts and submit the recommendation.

Accordingly, a committee has been constituted vide Order No. 14459 dated 09/03/2023 with the direction to submit its report before next STA meeting. The committee has submitted its report dated 01/04/2023 recommending that the car body could be white colour with a horizontal band in purple colour of appropriate height and proportion. At the end of the horizontal band, there would be three dots/squares/boxes inpurple to depict the continuously/flow/movement.

STA has accepted the color patten for Taxis recommended by the Committee and directed to initiate the proposal to obtain necessary approval of Hon'ble Lt. Governor for making amendment in the Andaman & Nicobar Islands Motor Vehicle Rules, 2006.

GRANT OF PERMIT TO TOURIST VEHICLES IN SHAHEED DWEEP AND SWARAJ DWEEP

STA was appraised that a meeting of PRIs and Officers of A&N Administration was convened at Shaheed Dweep on 13/01/2023 under the Chairmanship of the Chief Secretary in the Community Hall, Neil Kendra to discuss on various issues of Shaheed Dweep, The point raised in the meeting related to Transport Department is "Issue of permit of commercial vehicles- It was informed that commercial vehicle permit for 46 vehices purchased by the unemployed by availing bank loans in Shaheed Dweep are yet to be

- fre

considered by Transport Department. Elected representatives demanded for one time relaxation and issue of permits. Transport Department to examine".

STA was further apprised that the same matter was discussed in the review meeting held on 18/03/2023 under the chairmanship of Chief Secretary. The Point No.27 of the minutes of meeting is "Registration of tourist vehicles- Transport Department / STA to review the registration of tourist vehicles operating in in Swaraj Dweep and Shaheed Dweep to allow non electric vehicles considering non-availability of solar power station facilities and to facilitate unemployed youths".

STA examined the cases and observed that since 2018, no permits were issued for Swaraj Dweep and Shaheed Dweep. Since then several applications have been received from applicants of Swaraj Dweep and Shaheed Dweep and out of which, 43 applications have been received from Shaheed Dweep for issue of permit for already registered vehicles. The charging infrastructure in these Islands has not established so far for charging of light motors and above class.

It was further brought to the notice of the STA that many applicants have purchased the vehicles by availing bank loans and due to non-issuance of permits, they are not able to ply the vehicles for commercial purposes to pay their EMIs. The details of vehicles already purchased are in TABLE-21 (A) as under:

12.2 DECISION OF SECURITY DEPOSIT

STA was appraised that State Transport Authority has been conferred with the power under Section 67 of MV Act to issue direction in respect of transport Vehicle as

such it was decided during earlier meetings regarding submission of Security Deposit prior to issuance of NOC. As per the present practice, State Transport Authority issues No Objection Certificate for purchase/registration of vehicles only after obtaining Security Deposit in favour of Revenue Officer amounting to Rs. 5000/-, Rs. 10000/-, Rs. 20000/- and Rs. 250000 for Autorickshaw, LPV/LGV, HGV and Stage Carriage respectively.

Now, while releasing the Security Deposit amount, Sr. Accounts Officer has mentioned that at present there is no Revenue Officer in this Directorate since, November 2022. Hence, if Security Deposit is mandated as per rule, then the same may be drawn in favour of Secretary (STA).

As such, STA decided to accept the suggestion of Sr. Accounts Officer (T) to receive Security Deposit in favour of Secretary (STA) instead of Revenue Officer and the same may be informed to the applicants.

STA was appraised that as per the record of PMB, the applicant has brought the vehicle in Jan'2020 i.e. before 23.05.2022 on which the Press release issued by Transport Department, to undertake Restoration & Rehabilitation of Road from Km 21.00 to km 28.00 on NH-4 (old NH-223) in the UT.

STA further informed that the firm has obtained Temporary Permit for the vehicles mentioned at Sl. No. **02** to **04** with the validity upto **22/07/2021**. The fitness validity of all the vehicles has **expired** and the firm has applied for permit.

STA was appraised that **Shri. Sushil Kumar Kerketta** has applied on 12.12.2022 for renewal of permit of 10 two wheelers along with renewal of license. The applicant has obtained route permits for **24 wheelers and License under RAMS** to ply in all routes of **SwarajDweep.**

While scrutinizing for renewal of permit and license, it has been observed that out of 24 two wheelers, the permit and fitness of 10 two wheelers have been expired. It appears that the firm has **rented the motorcycles without having valid permitand license** and thereby violation of the provision contained under rent-amotorcycle scheme 1997/ Section 66 of MV Act.

Though, there is **no penalty clause** exists in the Scheme for penal action for renting motorcycle without having valid license but STA can suspend the permits of the vehicles or can impose mutually agreed penalty as the vehicles were rented without License under the scheme.

In similar cases, STA in its meeting held on 13/02/2023 has decided to impose penalty @Rs.1000/- per vehicle per year for delay in renewal of License under RAMS.

As such, STA considered the request for renewal of license and permit by imposing applicable penalty as per Order No. I/8619/2023 dated 12/01/2023 for plying without permit and penalty @Rs.1000/- per vehicle per year for delay in renewal of License under the Scheme.

20.3 DELAY IN RENEWAL OF LICENSE UNDER RENT A MOTOR CYCLE SCHEME

STA was appraised that below **04 vehicle owners** have been penalized for violation of various permit condition as per order No. I/8619/2023 with the approval of STA. Now, the applicants have submitted their grievances for relaxation/waiving off of the penal amount:

STA was appraised that the firm rented all the 15 vehicles without including the same in the license after the date of issuance of permit on 30.04.2019, thereby violated the provision of Rent a motorcycle scheme. As such, a penalty of Rs.1000/year/vehicle was imposed.

Submission of firm:

Due to COVID 19 restriction during the beginning of February 2020 my entire business of leading two wheelers on rental basis was shut down for almost 24 months resulting in zero revenue. Now, requesting to give relaxation on the penalty amount.

Later he obtained NOC for inclusion of 10 more two wheelers on 05.12.2016 against which the applicant purchased 10 two wheelers and got registered under Transport Category in the year 2017 but obtained permits for 08 vehicles only. The applicant did not apply for permit for the 02 two wheelers and plied the vehicles without obtaining permits. STA imposed penalty for 72 months on each vehicles @Rs.1000/- permonth.

Records further shows that the owner of the vehicle has applied for duplicate permits for these two vehicles on 18.04.2019 against which a SCN was issued to him. The owner has replied on 19.06.2019 stating that he lost the NOC of these vehicles and requested to issue permits.

The applicant submitted that permits have not been issued for these two vehicles and he is facing financial crisis and requested to relax the fine amount.

The applicant stated that neither at granting of permits nor while renewing the permits, he was informed to apply for liense under RAMS.

When the owner of the firm visited STA, one of the staff of STA section told him to fill the application for license on the spot without specifying further information.

The firm further submitted that due to covid pandemic, the business was completely shut down, and now when the firm tried to recover the business, he got the penalty notice. As such, the firm has requested to take a lenient and cancel the penalty fine order.

Decision taken:

STA did not consider the request of the applicant for waiving off of penalty of Rs.25,000/- for 06 Two wheelers imposed vide order No. 701 dated 27.02.2023.

21. RATIFICATION OF THE CASES OF FINE EXEMPTION

STA was appraised that several requests were received from owners of Autorikshaw for exemption of fine imposed for the period from January 2022 to March 2023 as per order No. I/8619/2023 for delay applying for permit after its registration. During the month of January & February, 2023, the sealing and calibration of fare meter was not done by the Civil Supplies Department on account of the Notification issued for revision of fare of Autorikshaw. Transport Department was not accepting permit application for new vehicles in the absence of fare meter sealing and calibration certificate. As such these vehicle owners could not submit the application for issuance of new permit after the registration of their Autorikshaws. The ground for delay was found to be genuine and as such permits were issued with the approval of Secretary (Transport) / Chairman (STA) after exempting late fine in those cases in which the vehicles were registered in the month of January & February, 2023 and permit application submitted after calibration of fare meters in March, 2023. The details are as under:

STA ratified the decision of Chairman STA for fine exemption to autorickshaw owners.

22. FIXATION OF FARES FOR THE CABS AND COMMERCIAL TWO WHEELERS OPERATING IN SWARAJ DWEEP

STA was appraised in the meeting dated 02/09/2022 that due to absence of any fare regulation for the cabs and commercial two wheelers plying in SwarajDweep and ShaheedDweep, regular reports on fleeing of tourists by the commercial vehicle drivers have been cropping up. This is not only creating inconvenience for the visiting tourists but also detrimental in the promotion of tourism activity in the Island. In order to maintain a check on the excess fare charging and to eliminate the chances of unhealthy practice by the vehicle owners, STA has decided to fix the fares of cabs and commercial two wheelers plying in SwarajDweep and ShaeedDweep under Section 67 of MV Act. A committee has been constituted vide order No. 3557 dated 14/09/2022 with the mandate of recommending fares for the cabs and commercial two wheelers plying in SwarajDweep and ShaheedDweep.

The committee after analysing the present market rates, expenditure involved in operation of these commercial vehicles in these two Islands, demand of vehicles, tourists requirement etc has furnished its report/ recommendation for further examination & recommendation of STA.

STA in its meeting dated 14/10/2022 directed to send back the proposal to the Committee to re-examine the fares with reference to the discussion held in SOM chaired by Chief Secretary. Accordingly, two reminder letters dated 10/11/2022 and 10/02/2023 have been forwarded to the Chairman of the committee.

Further, as per STA decision in its meeting dated 13/02/2023, a DO letter has also been sent on 20/03/2023 for early submission of recommendation and **the reply is awaited.**

STA has examined the matter and directed to obtain the report of Committee without any further delay.

23. ISSUE OF NOC FOR CARAVAN VEHICLES

It is to submit that an application has been received before STA for obtaining NOC for the registration and operation of Caravan Vehicles in this UT.

As per Rule 2 (za) of CMVR 1989, a Motor Caravan is a "Special Purpose" M Category vehicle and therefore, if the same is registered under Transport Category, it should be covered by a Contract Carriage Permit under Section 74 of MVA 1988.

The case was placed before STA in its meeting held on 14/10/2022 wherein STA observed that there is no SoP or guidelines framed for operating caravan vehicles in this UT. As such, STA decided to obtain opinion from Tourism & Police Department and requested them to prepare SoP for operation of caravan vehicles for incorporation in the permit conditions.

Accordingly, letter No. MT/2-1/STA Meeting/2021/9168 dated 10.11.2022 submitted to Director (Tourism) and Dy.SP (Traffic) followed by a reminder letter No.M-17067/7/2022-STA/4505 dated 30.11.2022.

In response, the Tourism Department has submitted vide letter dated 13.12.2022 that the Department does not have any Policy/registration and technical expert for framing of SOPs for operation of Caravan vehicle in A&N Islands. Hence, they have informed No Objection for framing SOPs for operation of Caravan vehicle.

Dy. SP (Traffic), vide letter dated 04/01/2023 commented that the owner of caravan vehicle shall be directed to abide by all MV Rules and to provide the details of their parking spaces and to park the vehicle in their designated parking area.

The case was deferred in the STA meeting held on 13/02/2023.

The matter for issuance of permits to the Caravans was discussed in the meeting chaired by Chief Secretary on 18.03.2022 and the Transport Department was directed to prepare SOPs for operation of Camper Vans/ Caravans/ RVs in line with other states/ countries.

It was informed that during the review meeting under the Chairmanship of Chief Secretary held on 08/04/2023, Tourism Department has been directed to prepare SOPs for operation of Camper Vans/ Caravans/ RVs in line with other states/ countries.

As such, STA directed to intimate the matter to Tourism Department for submission of SOP before STA in the next meeting so as to consider issuance of Contract carriage applicable for Caravan Vehcicles incorporating the SoP in the terms & condictions of operation.

24. CASES OF SWARAJ DWEEP & SHAHEED DWEEP

Many applications were received for issuance of NOC/ permits and other transactions for the jurisdiction of Swaraj Dweep and Shaheed Dweep which were placed in the STA meeting held on 03.08.2022, 02.09.2022, 14.10.2022 & 02.12.2022 wherein STA deferred the cases and decision shall be taken after the approval of competent authority. Some more applications have been received for issuance of NOC / Permits to ply the vehicles in these two Islands. The details are as under:-
