MINUTES OF THE 2ND MEETING OF STATE TRANSPORT AUTHORITY FOR THE YEAR 2025 HELD ON 12/02/2025 AT 10:00 AM IN THE CHAMBER OF SECRETARY (TRANSPORT), A & N SECRETARIAT, SRI VIJAYA PURAM

At the outset, the Chairman, STA welcomed all those present in the meeting and emphasized the vision of the Administration to have a safe, environment friendly, sustainable and reliable road transport system in the UT.

Thereafter, the following agenda points came up for discussion in the STA:

1. CASES OF SHAHEED DWEEP

1.1. MATTERS OF LITIGATION PERTAINING TO SHAHEED DWEEP

1.1.a. It is to apprise that Shri. Bablu Biswas has filed a writ petition being WPA/467/2024 {Shri. Bablu Biswas (Petitioner)-vs-The Secretary (Transport) & Ors.} before the Hon'ble High Court Calcutta, Circuit Bench at Port Blair.

The Hon'ble High Court at Kolkata, Circuit bench at Port Blair after hearing the matter on 04.09.2024 passed an order dated 04.09.2024 stating that "the grievance of the Writ Petitioner is that the Petitioner's prayer for grant of No Objection Certificate for plying his vehicle in all routes of Andaman and his application for change of route made on 09/06/2022 is not yet considered by the Secretary, State Transport Authority.

Upon considering the facts of the case and upon hearing the learned Advocates, this Court is of the view that no fruitful purpose will be served by keeping the Writ application pending. Thus this Writ application is disposed off by directing the Respondent No. 3 to consider and decide the representation made by the Petitioner with regard to the issue of No Objection Certificate dated 16/08/2019 within six weeks from the date of communication of this order upon giving the Petitioner an opportunity of being heard. The decision shall be by a reasoned order and to be communicated to the Petitioner."

In the above context, it is to submit that Shri. Bablu Biswas, S/o. N. N. Biswas, R/o. Shaheed Dweep, Ph. No. 9474212810 applied for Transfer of Ownership and Permit for his Contract Carriage vehicle bearing registration number AN01/J-8808 on 09/06/2022 which he



purchased from Shri. Amitosh Biswas, S/o. Sreedam Biswas, R/o. Garacharma, Sri Vijayapuram, South Andaman, Ph. No.: 9476020171.

The case was placed in the STA meeting dated 03/08/2022 wherein STA decided to defer the case till the next meeting for consideration.

Shri. Bablu Biswas vide his application dated 03/10/2023 again applied for Transfer of Ownership and Permit for the said vehicle which was placed in the STA meeting held on 03/11/2023.

STA after examining the case in the said meeting decided to defer the case.

It is to submit that the said vehicle i.e. AN01/J-8808 (BS-IV) was registered in the RTO, Sri Vijayapuram on 21/11/2014 and is having route permit vide Permit No. PCT/STA/14/1528 dated 05/12/2014 to ply in all routes of North, Middle and South Andaman (Except Shaheed Dweep, Swaraj Dweep and Little Andaman) with the validity upto 04/12/2024.

Complying with the decision of Hon'ble High Court, the petitioner i.e. Shri. Bablu Biswas was heard in-person on 14/10/2024 and after consideration of all the facts and circumstances of the case, Shri. Bablu Biswas was informed vide O/o No. 2534 dated 14/10/2024 that his case will be placed before the Committee constituted by the State Transport Authority (STA) to examine and suggest measures on the issuance of commercial permits in the Islands of Swaraj Dweep and Shaheed Dweep and subsequently before the State Transport Authority (STA) for consideration of the case. The outcome of the meeting of STA will be intimated by Secretary (STA) to Shri. Bablu Biswas.

Decision:

STA observed that the applicant has purchased and operated the vehicle in Shaheed Dweep for commercial purposes without the approval of STA for transfer of permit along with change of route.

STA after examining the case decided to dispose-off the case and approve the request of Shri. Bablu Biswas for Transfer of Ownership and Permit along with change of route for his Contract Carriage vehicle bearing registration number AN01/J-8808 by imposing prescribed penalty for operation of vehicle without permit.

STA was further apprised vide Point No. 1.10 that 06 more similar cases have been received by the STA wherein the applicants have purchased and operated the vehicles in Shaheed Dweep for commercial purposes without the approval of STA for transfer of permit along with change of route.

1.1.b. It is to apprise that Shri. Nityananda Saha has filed a writ petition being WPA/468/2024 {Shri. Nityananda Saha (Petitioner)-vs-The Secretary (Transport) & Ors.} before the Hon'ble High Court Calcutta, Circuit Bench at Port Blair.

The Hon'ble High Court at Kolkata, Circuit bench at Port Blair after hearing the matter on 04.09.2024 passed an order dated 04.09.2024 stating that "the grievance of the Writ Petitioner is that his application for changing the route mentioned in route permit made on 01/03/2022 before the Respondent No. 3 is still pending for consideration. Upon hearing the



learned Advocates and considering the facts of this case, this Court is of the view that no fruitful purpose will be served by keeping the Writ application pending.

Thus, this Writ application is disposed of by directing the Respondent No. 3 to consider and decide the application of the petitioner for transfer/ change of route made on 01/03/2022 being annexure P-3 of the petition in accordance with law upon giving the petitioner an opportunity of being heard within a period of 6 weeks from the date of communication of this order. The decision shall be by a reasoned order and to be communicated to the Petitioner.

In the above context, it is to submit that Shri. Nityananda Saha, S/o. Late Nikunja Saha, R/o. Shaheed Dweep, Ph. No. 9474212840 applied for Transfer of Ownership and Permit for his Contract Carriage vehicle bearing registration number AN01/L-7623 on 01/03/2022 which he purchased from G. M. Pharmaceuticals, Prop. Hitansu Mazumder, R/o. Nayagaon Junction, Shadipur, Vijayapuram, South Andaman, Ph. No.: 9434281275.

Shri. Nityananda Saha vide his application dated 03/10/2022 again applied for Transfer of Ownership and Permit for the said vehicle which was placed in the STA meeting held on 14/10/2022.

STA in the said meeting decided to defer the case for transfer of ownership and change of jurisdiction from North, Middle and South Andaman (Except Shaheed Dweep, Swaraj Dweep and Little Andaman) to Shaheed Dweep to next meeting and decision shall be taken after obtaining approval of the competent Authority on the proposal initiated by the Transport Department.

It is to submit that the said vehicle i.e. AN01/L-7623 (BS-IV) was registered in the RTO, Sri Vijayapuram on 27/07/2016 and is having route permit vide Permit No. PCT/STA/16/1456 dated 17/08/2016 to ply in all routes of North, Middle and South Andaman (Except Shaheed Dweep, Swaraj Dweep and Little Andaman) with the validity upto 16/08/2026.

Complying with the decision of Hon'ble High Court, the petitioner i.e. Shri. Nityananda Saha was heard in-person on 14/10/2024 and after consideration of all the facts and circumstances of the case, Shri. Nityananda Saha was informed vide O/o No. 2535 dated 14/10/2024 that his will be placed before the Committee constituted by the State Transport Authority (STA) to examine and suggest measures on the issuance of commercial permits in the Islands of Swaraj Dweep and Shaheed Dweep and subsequently before the State Transport Authority (STA) for consideration of the case. The outcome of the meeting of STA will be intimated by Secretary (STA) to Shri. Nityananda Saha.

Decision:

STA observed that the applicant has purchased and operated the vehicle in Shaheed Dweep for commercial purposes without the approval of STA for transfer of permit along with change of route.

STA after examining the case decided to dispose-off the case and approve the request of Shri. Nityananda Saha for Transfer of Ownership and Permit along with change of route for his Contract Carriage vehicle bearing registration number ANO1/L-7623 by imposing prescribed penalty for operation of vehicle without permit.



1.2. Shri. Bikas Mistry, R/o. Shaheed Dweep has requested to consider his old pending case for issuance of tourist permit and release his vehicle bearing registration number ANO1/P-8706 from PS Shaheed Dweep.

In the said letter, the applicant has stated that before purchasing the vehicle bearing registration number AN01/P-8706, he was issued with No Objection Certificate by the Department vide CA. NO. 50256 dated 28-08-2017, which was extended from time to time (Copy enclosed), as he was financially very poor and could not afford to purchase the vehicle.

However, with the support of the Administration and Bank, he gathered some courage and purchased the vehicle and got it registered on 08-11-2019. He had to take a loan of about Rs 16 lakhs from SBI for purchase of the vehicle. All the required formalities like fitness, Road Tax and Insurance also done for time to time and he is ready comply with all required formalities if any.

The applicant has further stated that unfortunately he could not pursue it after purchase of the vehicle due the unfortunate incident of COVID-19, where his entire family was affected and he lost his mother during the COVID period. The vehicle was lying idle and could not be operated due to COVID-19 condition.

After COVID, he was under tremendous pressure for repayment of loan, for which he had to operate the vehicle at Shaheed dweep for maintaining his family as it is the only source of my livelihood. He could not pursue the matter for issuing Tourist Permit from the Department due to his innocence and lack of knowledge despite having all records.

Recently, he was given a Show Cause Notice vide No. MT/STA/AN01/P-8706/2024/4325 dated 26-07-2024 and Order vide no. 2018 dated 20-08-2024, whereby my registration has been cancelled for three months and the vehicle also surrendered to SHO, Shaheed Dweep.

In the above context it is to submit that the applicant had been issued NOC vide no. MT/STA/NOC4/2017/2051 dated 28/08/2017, CANO-50256 to ply Contract Carriage Vehicle (Tempo Traveller) in all routes of Shaheed Dweep. Against the said NOC, the applicant has purchased and registered the vehicle Force Tempo Traveller Mini Bus-26 Str in the RTO, Sri Vijayapuram on 08/11/2019.

Since, the registration, the applicant has been plying the vehicle without obtaining route permit.

Furthermore, the said vehicle was found plying at Shaheed Dweep without valid permit during the inspection carried out by the Transport Department on 13/07/2024 and 14/07/2024 violating Sectio 192A (1) of MV Act, 1988. Taking strict action against the violation, the Registration Certificate of the said vehicle was suspended vide Order Nos. 2018 dated 20/08/2024 with the direction to surrender the vehicle at PS Shaheed Dweep.

The said vehicle has been detained and kept at PS Shaheed Dweep since then.

Now, the applicant vide his letter has requested to consider his case sympathetically for issuing permit being an old case i.e. before COVID-19 and release his vehicle vide Registration No. ANO1/P-8706, which is presently under the custody of SHO, Shaheed Dweep.

Decision:

STA was apprised that the suspension orders pertaining to the vehicle bearing registration number AN01/P-8706 had been revoked.

STA observed that Shri. Bikas Mistry purchased the vehicle against the issued NOC in the year 2019 but did not apply for route permit. He operated the vehicle in Shaheed Dweep for commercial purposes without obtaining route permit.

Therefore, STA after examining all facts, decided to grant of route permit to Shri. Bikas Mistry for his vehicle bearing registration number AN01/P-8706 to ply in all routes of Shaheed Dweep by imposing prescribed penalty for operation of vehicle without permit.



1.3. Shri. Satyajeet Mondal, S/o. Late Ashim Mondal, R/o. Ram Nagar, Shaheed Dweep vide his application dated 08/10/2024 has requested to reconsider his application for issue of permit.

In the said letter, the applicant has stated that he had purchased a vehicle Nissan Datson Go Plus bearing registration number ANO1/N-7573 by borrowing loan from Mahindra & Mahindra Finance Services Ltd., Sri Vijaya Puram intended to ply the said vehicle for commercial purposes on all routes of Shaheed Dweep. Accordingly, he submitted his application in the STA Section dated 19/07/2019.

The applicant has further submitted that due to COVID-19 pandemic, he had no income due to which he could not pay the EMI of the borrowed loan. Consequently, his vehicle was reposed by Mahindra & Mahindra Finance Services Ltd., Sri Vijaya Puram and was put on auction.

However, the applicant has stated that he managed to raise some amount and repurchased the said vehicle to use it for commercial purposes to earn his livelihood. The applicant has further requested to consider his application for issue of permit.

In the above context, it is to submit that Shri. Satyajeet Mondal, S/o. Late Ashim Mondal, R/o. Ram Nagar, Shaheed Dweep is registered owner of the vehicle bearing registration number AN01/N-7573 (Datson Go Plus, BS-IV) registered in the RTO, Sri Vijaya Puram dated 14/12/2018 under Non-Transport Category. He applied for grant of NOC to ply his already registered Contract Carriage vehicle (Datson Go Plus AN01/N-7573, BS-IV) in all routes of Shaheed Dweep vide his application dated 19/07/2019. The case was placed in the STA Meeting dated 04/04/2022 wherein STA directed to inform the applicants seeking NOC/Permits to apply afresh.

It is to apprise that the case of Shri. Satyajeet Mondal is one among the 43 cases which was placed in the meeting dated 13/01/2023 under the Chairmanship of the worthy Chief Secretary. The case was placed before the STA in its meeting dated 10/04/2023 wherein STA decided to consider the case for grant of NOC/ Permit in which the applicants have already purchased the vehicles for obtaining route permits.

Shri. Satyajeet Mondal again applied for grant of NOC to ply Contract Carriage vehicle (Maruti Ertiga) in all routes of Shaheed Dweep vide his application dated 16/08/2023.

The case was placed in the STA Meeting held on 30/08/2023 wherein STA observed that since the applicant made his application prior to the imposition of mandatory condition regarding BS-VI emission norms, STA decided to get the above mentioned vehicle inspected thoroughly for vehicle fitness and resubmit the case with fitness status in the next STA meeting.

Accordingly, a letter dated 03/10/2023 was issued to the applicant informing the same. The applicant has produced his vehicle before the Inspecting Authority on 01.11.2023 and the Inspecting Authority inspected the vehicle and found that the vehicle complies with all the parameters related to fitness of the vehicle satisfactorily vide its report dated 02.11.2023.

The case was placed before the STA in its meeting dated 05/01/2024 wherein STA decided to defer the case till the next STA meeting.

The case was again placed before the STA in its meetings dated 08/07/2024 and 27/09/2024 wherein STA after examining the case, decided to defer the case and examine it on the basis of the outcome and findings of the Committee constituted vide Order No. I/131710/2024 dated 14/08/2024 by the STA to consider issuance of permits in Swaraj Dweep and Shaheed Dweep vide its meeting dated 08/07/2024.

Now, the applicant has again requested to consider his application for grant of permit to ply his Contract Carriage vehicle (Datson Go Plus, BS-IV) in all routes of Shaheed Dweep.

Decision:

Ail Ail

STA observed that Shri. Satyajeet Mondal has purchased the vehicle in the year 2018 and submitted application for grant of permit in 2019. In the meantime, he operated the vehicle for commercial purposes in Shaheed Dweep without the approval of STA.

Therefore, STA after examining all facts, decided to grant route permit to Shri. Satyajeet Mondal as a special case for his vehicle bearing registration number ANO1/N-7573 to ply in all routes of Shaheed Dweep by imposing prescribed penalty for operation of vehicle without permit.

1.4. Shri. M. Raja Ram, R/o. Shaheed Dweep vide his application dated 08/10/2024 has requested to reconsider his application for issue of permit.

In the said letter, the applicant has stated that before COVID 19, he had applied for NOC for purchase of vehicle (Maruti Ertiga) to ply in all routes of Shaheed Dweep vide his application dated 23/04/2019 and accordingly he purchased the said vehicle meant for commercial use but after pressing hard for registration of vehicle by the dealer, the said vehicle got registered in the RTO, Sri Vijayapuram on 24/02/2020 and awarded vehicle number i.e. AN01Q-6955. Thereafter, the COVID 19 spread all over the India including these Islands and his application has been kept in hold along with others.

Later on, when he approached the STA Section regarding the issuance of NOC, he was directed to re-submit the application and accordingly he re-submitted fresh application for issuance of NOC vide his application dated 15/07/2022. Thereafter, he was issued a Letter to produce his vehicle before the Committee/Inspecting Authority to inspect the condition of the vehicle and accordingly he produced his vehicle for the same before the Inspecting Authority on 15/11/2023 and his vehicle was found fit.

Further, the applicant has stated that the applications for issuance of NOC of other applicants who had submitted earlier have been considered and issued NOC except him.

In the above context, it is to submit that Shri. M. Raja Ram, R/o. of Shaheed Dweep applied for grant of NOC to ply Contract Carriage vehicle (Maruti Ertiga) in all routes of Shaheed Dweep vide his application dated 23/04/2019. The case was placed in the STA Meeting dated 04/04/2022 wherein STA directed to inform the applicants seeking NOC/Permits to apply afresh.

In the meantime, the applicant purchased the vehicle (Maruti Ertiga BS-VI) and registered in the RTO, Sri Vijayapuram on 24/02/2020 under Non-Transport Category.

Complying with the decision of the STA, Shri. M. Raja Ram again applied for grant of NOC to ply Contract Carriage vehicle (Maruti Ertiga) in all routes of Shaheed Dweep vide his application dated 15/07/2022 without mentioning the registration number of the already purchased vehicle.

The case was placed in the STA Meeting wherein STA deferred the case.

The applicant vide his application dated 14/07/2023 applied for grant of permit for his already registered vehicle bearing registration number AN01/Q-6955 to ply in all routes of Shaheed Dweep.

The case was placed in the STA meeting held on 30/08/2023 wherein STA observed that since the applicant made his application prior to the imposition of mandatory condition regarding BS-VI emission norms, STA decided to get the above mentioned vehicle inspected thoroughly for vehicle fitness and resubmit the case with fitness status in the next STA meeting.

Accordingly, a letter dated 03/10/2023 was issued to the applicant informing the same. The applicant has produced his vehicle before the Inspecting Authority on 15.11.2023 and the Inspecting Authority inspected the vehicle and found that the vehicle complies with all the parameters related to fitness of the vehicle satisfactorily vide its report dated 25.07.2024.

Now, the applicant has again requested to consider his application for grant of permit to ply his Contract Carriage vehicle (Maruti Ertiga BS-VI) in all routes of Shaheed Dweep.



Decision:

STA observed that Shri. M. Raja Ram has submitted application for grant of permit in 2019 and purchased a BS-VI complaint vehicle in the year 2020. In the meantime, he operated the vehicle for commercial purposes in Shaheed Dweep without the approval of STA.

STA after examining the case decided to consider the case of Shri. M. Raja Ram as a special case and approved his request for grant of route permit for his vehicle bearing registration number AN01/Q-6955 to ply in all routes of Shaheed Dweep by imposing prescribed penalty for operation of vehicle without permit.

1.5. Shri. Manimohan Sarkar, S/o. Late Mahendranath Sarkar, R/o. of Shaheed Dweep is the registered owner of the vehicle bearing registration number AN01/P-3795 (Maruti Ertiga, BS-IV).

The said vehicle i.e. AN01/P-3795 is a Contract Carriage vehicle (Maruti Ertiga) and is registered in the RTO, Sri Vijaya Puram on 06/08/2019 under Non-Transport Category. The said vehicle is BS-IV emission norms compliant.

It is to apprise that State Transport Authority (STA) vide its press release dated 23/05/2022 had imposed restriction in the plying of non BS-VI vehicles for commercial purposes in order to protect the ecology and environment of the A & N Islands.

It is to submit that Shri. Mani Mohan Sarkar applied for grant of NOC to ply Contract Carriage vehicle (Maruti Ertiga, BS-IV) in all routes of Shaheed Dweep vide his application dated 29/07/2022. At the time of making application, the applicant did not furnish any information pertaining the above mentioned vehicle.

Accordingly, the case was placed as a fresh case in the STA Meeting dated 03/08/2022 wherein STA deferred the case.

Shri. Manimohan Sarkar again applied for grant of NOC to ply his already registered Contract Carriage vehicle (AN01/P-3795, Maruti Ertiga, BS-IV) in all routes of Shaheed Dweep vide his application dated 01/08/2023.

The case was placed before the STA in its meeting dated 30/08/2023 wherein STA after examining the case observed that since the applicant applied for NOC after the imposition of the condition regarding BS-VI emission norms, STA decided to reject the request of the applicant as the vehicle is non BS-VI compliant which is a mandatory condition prescribed by the STA applicable as on date.

Decision:

STA observed that Shri. Manimohan Sarkar has purchased a BS-VI complaint vehicle in the year 2019 and submitted application for grant of permit in 2022. In the meantime, he operated the vehicle for commercial purposes in Shaheed Dweep without the approval of STA.

STA after examining the case decided to consider the case of Shri. Manimohan Sarkar as a special case and approved his request for grant of route permit for his vehicle bearing registration number ANO1/P-3795 to ply in all routes of Shaheed Dweep by imposing prescribed penalty for operation of vehicle without permit.



1.6. GRANT OF NOC/PERMIT

1.6.a. STRONG HYBRID ELECTRIC VEHICLES (SHEVs) (CC-4W) SHAHEED DWEEP

STA was informed that the below mentioned application has been received by the STA Section for grant of NOC/ Permit to **Strong Hybrid Electric Vehicle (SHEV)** for plying in all routes of **Shaheed Dweep**. The detail is as under:

Decision:

STA was apprised that the report of the Committee constituted by the STA vide Office Order No. I/131710/2024 dated 14/08/2024 to examine and suggest measures on the issuance of commercial permits in the islands of Swaraj Dweep and Shaheed Dweep is still awaited.

Therefore, STA decided that the examination of commercial vehicle permits vis-à-vis the exisiting commercial vehicles, daily tourist footfall, requirement for tourist mobility, traffic congestion, availability of road, parking space, allied activities and other factors etc for the islands of Swaraj Dweep and Shaheed Dweep will be done in-house by Transport Department instead of the Committee. Dy. SP (Traffic) has also been advised to furnish the carrying capacity of vehicles in the two Islands.

In view of the above, STA decided to consider the cases pertaining to Strong Hybrid Electric Vehicles (SHEVs) for the jurisdiction of Shaheed Dweep after examination of various factors as mentioned above.



1.6.b. ELECTRIC VEHICLES (EVS) (CC-4W) SHAHEED DWEEP:

STA was informed that a total of 23 applications have been received by the STA Section for grant of NOCs to purchase and ply the vehicle as **Contract Carriage-4W**, **Electric Vehicles** (**EVs**) in all routes of **Shaheed Dweep**. Out of the 23 applications, 04 applications have been submitted by a single applicant.

Decision:

STA after examining the applications received for grant of NOCs to purchase and ply Electric Vehicles (EVs) as Contract Carriage-4W decided to approve the following 20 applications as mentioned in Table: 03 below:

The registration certificates and permits of the vehicles appearing at S. No. 2, S. No. 3, S. No. 4 and S. No. 5 in the above **TABLE: 12** were suspended for 3 months for violation of permit conditions. As on date, the registration certificates and permits of the 3 vehicles have been revoked by imposing a penalty of Rs. 10000/- and an undertaking stating that the said vehicle will neither be plied in any other route/ jurisdiction other than route specified in the permit nor violate any rule provisions as prescribed under MV Act, 1988.

Decision:

STA observed that the applicants mentioned in the above TABLE: 12 have purchased and operated the vehicles in Shaheed Dweep for commercial purposes without the approval of STA for transfer of permit along with change of route.

STA after examining the cases decided to dispose-off the cases and approve the requests for Transfer of Ownership and Permit along with change of route for the vehicles mentioned in the above TABLE: 12 by imposing prescribed penalty for operation of vehicle without permit.

1.11.b. Smti. Kannagi Santosh, W/o. K V Santhosh Kumar, R/o. Shaheed Dweep vide her application dated 19/12/2024 has requested for issuance of NOC to replace her exisiting vehicle bearing registration number AN01/J-7090 having route permit to ply in all routes of Shaheed Dweep with a new vehicle (Maruti Ertiga Smart Hybrid) and allow the change of route of the vehicle bearing registration number AN01/J-7090 (Maruti Swift Dzire) to ply in all routes of North, Middle and South Andaman.

Water is the basic need for the local residents, restaurants and hotels and to cater the water requirements, presently transportation of water is done illegally through normal trucks and vans compromising the safety of other road users. In the said application, the applicant has also stated that in one of the meeting of STA, a resolution was passed in which permits for water tanker to ply in Swaraj Dweep will be issued to such applicants, who possess Licence/NOC for water abstraction from UT Administration . 2.3.ii. Shri. G. Kannan, S/o. M. Govindan, R/o. Austinabad, Sri Vijaya Puram vide his application dated 18/02/2019 applied for transfer of ownership and permit of the vehicle bearing registration number AN01/H-9438 having route permit to ply in all routes of Swaraj Dweep which he purchased from Shri. 3. CONSIDERATION OF CASES FOR GRANT OF PERMITS FOR SWARAJ DWEEP AND SHAHEED DWEEP

3.1. STA was apprised that considering the recommendations in the study report received from DBRAIT and to meet the immediate requirement of commercial vehicles for the tourism activities of the two Islands of Swaraj Dweep and Shaheed Dweep, the STA in its meeting held on 30.08.2023, in the first instance, decided to grant NOC/ permit in respect of M2 and M3 category of vehicles.

Based on the above decision, 14 applications for M2 category vehicles pertaining to Swaraj Dweep and 09 applications pertaining to Shaheed Dweep had been taken for consideration for grant of NOC/ Permit for different categories of vehicles to ply in Swaraj Dweep and Shaheed Dweep respectively in the meeting of the STA held on 30.08.2023.

However, before granting NOCs, STA decided to obtain willingness/ requirement of the applicants as on date and to place the same in the next meeting as the applications in these cases had been made 1-5 years back.

Complying with the above decision, letters were issued to all the 23 applicants with the request to furnish the willingness/ requirement as on date for the NOC to purchase different M2 categories of vehicles.



Accordingly, 13 applicants pertaining to Swaraj Dweep and 08 applicants pertaining to Shaheed Dweep have furnished their willingness/ requirement as on date.



It is to apprise that several complaints had been received by the STA Section alleging that few persons were involved in the racket of purchasing passenger Autorickshaw in the name of eligible person who were in possession of Local Certificate/ Islander Card and leasing out to Non-Islanders Autorickshaw drivers by manipulating the conditions set by STA for obtaining NOC/permits of passenger Autorickshaw.

As regards to the allegation of plying of multiple autos by single person by obtaining Autorickshaws in the name of different persons, existing data base of STA was scrutinized from the VAHAN Portal where the mobile number of owner/ applicant is entered and it has been found that Autorickshaw permit/ NOC has been issued in the name of different owners. No single owner owns more than one autorickshaw as per the records but it is seen that same mobile numbers of the applicant is used to obtain permits in other names. This leads to a conclusion that one person i.e. the owner the of the mobile number may be involved in the purchase and plying of autorickshaw by misusing the guidelines prescribed by STA since 2007 i.e. to provide employment to the local unemployed youth possessing Islander card/ Local certificate.

Accordingly, the STA in its meeting held on 09.06.2023 decided to suspend the permits of such kind in which same contact number has been used for obtaining permits in the name other eligible persons.

The case of Shri. M. Gopi was one among the many cases wherein the route permit were suspended.



Aggrieved by the decision of STA, Shri. M. Gopi filed a case vide No. WPA/828/2023 in which the Hon'ble Court passed an order dated 20/07/2023 that "the order dated 5th July, 2023 passed by the respondent no. 1 is set aside and directed that the petitioner shall submit a representation to the respondent no. 1 within a period of fifteen days from date. In event such representation is submitted, the said respondent shall consider the same, upon granting an opportunity of hearing to the petitioner and take a decision, in accordance with law and communicate the same to the petitioner by 17th August, 2023. In the event the petitioner's representation is rejected, the said order of the respondent no. 1 shall remain stayed for a period of seven days thereafter."



In compliance to the order dated 20/07/2023 of the Hon'ble High Court, Shri. M. Gopi was given an opportunity for personal hearing vide Order No. 7855 dated 14/08/2023 before the Secretary (STA) on 16/08/2023.

The findings were placed before the STA in its meeting dated 30/08/2023 wherein STA after examining the case decided the following:

- i. Accept the tax invoice dated 25.07.2018submitted by the Shri. M Gopi and accept the representation submitted by the applicant with the direction to the permit holder to comply with all the permit conditions mandated by the STA for plying of autorickshaw.
- ii. Dy. SP (Traffic) is directed to verify whether the name of the person driving the autorickshaw is same as entered in the permit or not?
- iii. After collection of the information from the Traffic Police, reasoned order will be issued.

As per the direction of the STA, the Dy.SP (Traffic) vide his letter dated 31/10/2023 informed that the vehicle no. AN01/N-4734 was found driving by N. Vignesh having DL No. TN6520120005195.

The matter was placed before the STA in its meeting dated 03/11/2023 wherein STA decided to suspend the permit for 02 months with the advice to the permit holder to make representation against the suspension order if he wishes to. The permit holder may also be asked to furnish details of driver to enter in the permit.

Complying with the decision of STA, the route permit of the autorickshaw bearing registration number AN01/N-4734 was suspended vide Order No. 4545 dated 13/12/2023 for a period of 2 months with the direction to make representation against the suspension order if he wishes to and furnish details of driver to enter in the permit.

The permit holder Shri. M. Gopi has neither complied nor made any representation against the said suspension order till date.

It is to submit that as on date the route permit of the vehicle autorickshaw bearing registration number AN01N-4734 has expired on 30/10/2023 and the permit holder has applied for renewal of route permit vide his application dated 15/04/2024.

Decision:

STA taking a strict view, decided to issue Show Cause Notice to the applicant.
