As per the decision of STA in previous meetings for encouraging and promoting electric vehicles for commercial purposes in Shaheed Dweep, Secretary (Transport) / Chairman STA has accorded in-principle approval to issue NOC/Permit for registration of the e-Cars TATA TIGOR XM+ Xpress T-EV (Electric Car) to ply in all routes of Shaheed Dweep.

In Order to promote E-mobility and non polluting vehciles in Shaheedj Dweep, STA ratified the decision of Chairman STA for issue of CC permits to the above two e-Cars to ply in all routes of Shaheed Dweep.

c) 40 ft Low Bed Trailer (TATA Make BS-VI)

STA was appraised that the firm M/s A&N Logistics Pvt. Ltd. earlier applied for NOC for purchase of 40 Feet Low Bed Trailer-Tata BSVI trailer without specifying route and time. During the STA meeting held on 02.12.2022, the applicant's request was not considered, and STA decided to obtain clarification from the firm about the route and the timing in which the firm intend to ply the vehicle. After being informed of the decision, the firm requested issuance of NOC for 40 Feet Low Bed Trailer-Tata BSVI Trailer to ply in a praticular route in between Haddo wharf to Jirkatang and vice versa with its operation during day/night except during school time.

STA decided to refer the case to DySP (Traffic) for their assessment on the route and timing and furnish report before the next meeting of STA.

2. CORRECTION IN THE NOC

STA was appraised that on the basis of the request dated 28/10/2022 of **Shri. RajenderLall** for purchase/registration of new vehicle (TATA XENON) to ply in all routes of North, Middle & South Andaman, NOC was issued on 13/01/2023 as per the STA approval in its meeting dated 02/12/2022. The validity of NOC is up to 01/12/2023.

It was informed that TATA XENON is a GoodsCarrier (N1 Category) vehicle and comes under Transport Category and to ply the vehicle **PC Permit is required.** However, due to typographical error, the application was wrongly entered for **CC Permit** to ply in all routes of NMS at the receipt stage and accordingly, NOC for **CC Permit** was issued.Now, applicant requested to make necessary correction in the NOC and issue NOC for **PC Permit** for purchase/registration of new vehicle (TATA XENON) to ply in all routes of **North, Middle & South Andaman**.

ISSUE OF NOC FOR TRANSFER OF COMMERCIAL VEHICLES PURCHASED FROM FINANCIER IN AUCTION PROCESS

STA was appraised that in the below 02 cases, the vehicles were registered under Transport Category with Hypothecation to various Financiers. The vehicle owners became defaulters due to non-payment of EMIs of loan. As such, the Financiers reposed the vehicles and sold the vehicles to the highest bidders through auction process. As per the request of Financiers, these cases have been initiated to transfer the vehicle in the name of financier after giving an opportunity to the registered owner for submitting his representation within 07 days as per Rule 51 (5) and 61 (3) of CMVR, 1989. Being Transport Category vehicles, NOC from STA would be required for transferring these vehicles. Hence, the purchasers have reqested to issue NOC from STA for transfer of these commercial vehicles in their name for its further use. Hence, STA decided to consider the request of both the 02 cases as given in TABLE 15 below and to grant NOC for vehicle transfer with permit cancellation, after imposing applicable penalty for permit violation as per Order I/8619/2023 dated 12/01/2023:

6.2 STA appraised that M/s RDS Projects Ltd. has applied for change of route of below **04 vehicles**in the existing route permit to ply in NMS to Car Nicobar on 14/12/2022. STA was informed that all the 04 vehicles are having valid permit to ply in all routes of **NMS**. To execute a contract work of MES at Air Force Station, Car Nicobar, the firm had obtained Temporary Permit for 03 vehicles bearing registration Nos. ANO1 N2592, ANO1 N0760, ANO1 N2614 (Reflecte at S.No.1 to 3) to ply in all routes of Car Nicobar for 04 months. The firm stated that the time line of contract has been extended till July, 2023, which would further extend considering the project requirement. In the meantime, the validity of Temperory Permits of the three trucks have been expired on 08.12.2022 and all the 03 trucks are lying idle for want of route permit. Now the firm is intending to send one more truck bearing Regn. No.ANO1 N2613 for timely execution of the awarded work. Accordingly, the firm on 14.12.2022, has applied for change of route in the existing permits (NMS) of four vehicles as mentioned in the table to ply in Car Nicobar.

STA approved the request of applicant for change of route in the existing route permit to ply in NMS to Car Nicobar for all the 04 vehicles as mentioned in TABLE 17 after imposing applicable penalty (01 month) for the three vehicles mentioned at S.No. 1 to 3 whose temporary permit got expired on 08.12.2022 for plying without permit.

- 7. APPLICATIONS FOR REPLACEMENT WITH NEW VEHICLE AFTER CONDEMNATION OF THE EXISTING VEHICLE
 - 7.1 STA was informed that **09 applications** have been received from permit owners for replacement with new vehicle after condemnation of the existing vehicle which have become old and the owners are willing to dispose it by condemning.

7.2 STA was appraised that Shri. Abhishek Sarkar has applied for issuance of CC Permit to the vehicle bearing registration No. ANO1 L5256 (Mahindra KUV 100) (BS-IV Compliant) against the condemned vehicle bearing registration No. ANO1 E0713 having permit to ply in all routes of Shaheed Dweep.

It was informed the applicant has earlier applied on 11/10/2019 for replacement with new vehicle bearing registration No. ANO1L5256 (Mahindra KUV 100) after condemnation of his old vehicle bearing registration No. ANO1 E0713. Accordingly, the

applicant was granted permission on 06/01/2020 to condemn the old vehicle and replace the same with AN01 L5256 (Mahindra KUV 100). Now, the applicant approached STA on 07/11/2022 after condemnation of vehicle No. AN01 E0713 i.e. after a period of 03 years approx. from the date of issuance of condemnation memo. The vehicle bearing registration No. AN01 L5256 (Mahindra KUV 100) is presently registered under **Non-Transport Category.**

Being the case of Shaheed Dweep, STA deferred the case.

7.3 STA was appraised that Shri. Abul Kaish has applied for issuance of CC Permit to the new vehicle against the condemned vehicle bearing registration No. AN01H9222 (Chevrolet Enjoy) having permit to ply in all routes of Swaraj Dweep.

STA was informed that the applicant has earlier applied on 29/12/2019 for replacement with new vehicle after condemnation of his old vehicle bearing registration No. ANO1 H9222. Accordingly, the applicant was granted permission on 14/02/2020 to condemn the old vehicle and to replace the same with new Maruti Ertiga Tour.

Now, the applicant approached STA on 14/12/2022 after condemnation of vehicle No. ANO1 H9222 on 02/12/2022. Applicant submitted the reason for delay that he has booked the vehicle Maruti Ertiga in Maruti Agency House but due to COVID 19, the dealer failed to deliver the same on time.

Now, the applicant requested to grantfresh permission for purchase of New Maruti Ertiga Tour and to obtain permit to ply in all routes of **Swaraj Dweep** against the condemned vehicle.

Being the case of Swaraj Dweep, STA deferred the case.

8. REQUESTS OF TAXI OWNERS/ UNIONS

8.1 REPLACEMENT WITH NEW VEHICLE AFTER CONDEMNATION OF EXISTING VEHICLE:

STA was informed that **07 applications** have been received from taxi permit owners for replacement old Taxi and Ambassodor Cars with new vehicle (Maruti Swift Dzire) for operating as metered Taxi after condemnation of the existing vehicles which have become old and the owners are willing to dispose it by condemning.

STA was further informed that most of the old taxies (Ambassador) have already covered more than 30 years of its life span. Due to an obselete model, the availability of spare parts for Ambassodar car is very rare and difficult to maintain the vehicle. The below taxi owners have got their bank loan approved and trained under PMEGP Scheme through Industrial department.

As replacement of vehicles after condemnation is permissible under Section 83 of MV Act, STA approved all the 07 cases subject to condition that the proposed vehicle for replacement should be of BS-VI compliant. List of applications is given in <u>TABLE 19</u> below:

8.2 REVISION OF TAXI FARES:

STA was appraised that an application dated 12/01/2023 received from the General Secretary, Andaman & Nicobar Taxi Union for revising the taxi fare as per the latest market price. The fare proposed by the Taxi Union is mentioned as under:

Rs. 45/- for first one kilometre.

Rs. 2000/- for one day booking (i.e. 08 hours & 80 KMs minimum and additional

Rs. 20/- per KM extra charge).

Rs. 200/- for waiting charge for one hour.

STA decided to constitute a Committee with the following compositios and refer the case for recommendation for revised fare of Taxi:

- 1. Dy. Superintendent of Police (Traffic)
- 2. Sr. Accounts Officer (Transport)
- 3. Assistant Director, Civil Supplies & Consumer Affairs.
- 4. Assistant Engineer (Purchase Section, Dte. Of transport)
- 5. Transport Officer (Bus Terminus, Port Blair)

The committee shall analyze the expenditure on all factors for the operation of taxis and submit its report on fare structure of Taxi before next STA meeting.

8.3 AMENDMENTS IN ANIMV RULES FOR MODIFICATION IN COLOUR CODING FOR NEW TAXI:

STA was appraised that an application dated 13/01/2023 received from the General Secretary, Andaman & Nicobar Taxi Union for modification in colour coding for new taxis. The Taxi Union has requested to change the colour coding of the new taxi. They have proposed the colour two coding:

- 1. Entire vehicle body is in white colour and the LHS & RHS Body shall have a navy blue stip mentioning TAXI at the centre.
- 2. Entire vehicle body is in blue colour and the LHS & RHS Body shall have a yellow stip mentioning TAXI at the centre.





As per rule 70 (5) (a) of ANIMVR 2006, existing colour of taxi: colour of the hood should be in cream yellow and rest of the body in black.

STA decided to constitute a committee with the following compositions and refer the case to the committee to recommend the color of taxi:

- 1. Dy. Superintendent of Police (Traffic)
- 2. Secreatray (STA)
- 3. Assistant Director, Directorate of Art & Culture.
- 4. Architect (PBMC)
- 5. Transport Officer (Bus Terminus, Port Blair)

The committee shall analyze the color-coding of taxies plying in other States & UTs and as per suitability of colours in terms of MV Acts and submit the recommendation before next STA meeting.

On the basis of the recommendation of the Committee and decision of STA, proposal will be submitted before the Competent Authority for obtaining approval to amend the ANMVR 2006. Final decision shall be on the outcome of the approval for amendment of A&N Islands Motor Vehicle Rules 2006.

9. SWAPPING OF VEHICLE ROUTE PERMIT/NOC

STA appraised that **M/s Coral Reef Resort Pvt.** applied on 09/12/2022 for transfer of permit to a new vehicle to ply in all routes of **Swaraj Dweep** and to issue NMS permit to their old vehicle bearing registration No. ANO1 M1679 (having route permit of Swaraj Dweep) with validity of route permit till **06/08/2027** which is old and develops repair most of the time causing difficulties for the smooth operations to their guests in Swaraj Dweep.

It was informed that the firm had applied for NOC on 08/04/2022 for purchasing new vehicle to ply in all routes of **Swaraj Dweep** but till date NOC has not been issued by STA due to which they are facing difficulties in running their hotels in Swaraj Dweep. The firm has also obtained a NOC for their new vehicle Mahindra Marazzo which was issued by STA on 17/05/2022 for plying in all routes of North, Middle and South Andaman.

Being a case of Swaraj Dweep, STA deferred the case.

10. DECISION ON NEW PERMIT/CHANGE OF ROUTE FOR STAGE CARRIAGE PERMIT

10.1 STA appraised that following cases in respect of NOC for operation of new stage carriage buses and change of routes in the existing routes of stage carriage buses were earlier placed in the STA meeting held on 02.12.2022, wherein STA decided to

submit the cases before the Committee constituted vide Order No. I/2359/2022 dated 03/11/2022 for its recommendation. Accordingly, the committee has submitted its recommendation.

STA after examination of the recommendations of the Committee, decided to accept it and approved the changes of routes in the Stage Carriage Permits as mentioned in the TABLE 20.

STA decided to refer all the 09 cases to the Committee constituted vide Order No. I/2359/2022 dated 03/11/2022 to examine and recommend with the direction to furnish the report before next STA meeting.

11. CHANGE OF VEHICLE TYPE FROM ELECTRIC TO FOSSIL FUEL IN LETTER OF INTENT

STA appraised that **Smti. S Bagawathi** has applied on 20/12/2022 for **Change of Fuel Type of Two wheeler from Electric to Fossil Fuel** in the letter of intent.

The applicant has earlier applied for purchase of 10 Two-wheeler (05 electric & 05 Fossil Fuel) to operate under Rent a Motor Cycle Scheme to ply in all routes of South



Andaman. Accordingly, with the approval of STA in its meeting dated 14.10.2022, Letter of Intent has been issued vide letter dated 18/11/2022.

Now, the applicant has submitted that Port Blair is mostly hilly area, Two-wheelers with low CC will not be useful for operating in commercial purpose and dealers for higher CC electric Two-wheelers are not available in Port Blair. So, maintenance issue of these electric Two-wheelers cannot be sorted out. As such, the applicant has requested to change of fuel type of motorcycle from their remaining 05 electric to fossil fuel in letter of intent.

It was appraised to STA that as per the draft A&N Islands EV Policy and as per the decision of STA, electric vehicles are to be encouraged and promoted in these Islands.

Hence, STA decided not to consider the request of the applicant for Change of vehicle from Electric to Fossil Fuel in the letter of intent.

12. CHANGE OF CLASS OF VEHICLE AND/OR EXTENSION IN THE NOC

12.1 STA was appraised that 41 applications have been received for the extension of NOC due to various reasons. STA observed that there are several applicants whose NOC has already been granted for more than one and half years but they are still applying for NOC extension by provising various reason. As such, STA decided to grant NOC extension to only those applicants whose NOC expired from 01.08.2022 and the applicants whose NOC expired prior to 01.08.2022 shall have to re-apply for NOC for consideration. Further, STA decided that extension may be given for the period requested by the applicant but not exceeding to 06 months. The decision for NOC extension is given in TABLE 22:

13. CHANGE OF ROUTE IN THE NOC

STA appraised that **Shri. Sushen Maitra**, the NOC holder of **Autorickshaw** having route permit to ply all routes in **North & Middle Andaman** requesting to **change of route** from all routes in North & Middle Andaman to all routes in **South Andaman**.

The case was approved in the STA meeting held on **03.08.2022**. Accordingly, NOC was issued on **28.10.2022** with the validity upto **15.08.2023** to ply in all routes of North & Middle Andaman.Now, the applicant has requested to change the route along with fresh parking area.

It is informed to STA that the applicant is not having any address proof related to South Andaman for change of route for PCC Autorickshaw. However, he has submitted the **Rent Agreement**showing that he is presently residing at Chouldari village.

STA after examination of the case, approved the request of the applicant for change of route in the NOC from all routes in North & Middle Andaman to all routes in South Andaman.

14. RENEWAL AND CHANGE OF ROUTE IN THE EXISTING PERMIT

STA was informed that at the time of issuing the permit of the above said vehicle, STA was issuing permit to 10 wheeler goods vehicle to ply with in a special special

STA decided to approve the request of the applicant to make change of route in the permit as 'All routes in South Andaman' without limiting the time of operation.

15. FIXATION OF FARE FOR EXPRESS BUSES (AC SLEEPER COACH)

STA appraised that **Smti. S Kaweri**, R/o New Pahargaon has applied for fixation of fare for **AC Sleeper Coach Buses** (20 Seater 20 Sleeper).

STA granted the applicant a NOC to operate two AC sleeper coach buses (20 seats and 20 sleepers) on the approved Port Blair-Diglipur route until 23/04/2023. A AC Sleeper coach bus has been brought and registered in this RTO on 02.11.2022, bearing the registration mark AN01R 9802, which would ply between Port Blair and Diglipur on the approved route.

STA has not yet fixed the fare for AC Sleeper-cum-Seater Coaches. Request for fixing the fare from Port Blair to Diglipur at Rs. 1400/- was submitted by the applicant with the proposal.

Upon STA decision dated 02/12/2022, a committee has been constituted via Order No. 4739 dated 13/12/2022 for the recommendation of a fare structure for sleeper berths in AC Buses by analyzing all the factors that influence the operation of AC Sleeper Coach Buses. Now, the committee has submitted its report dted 30/12/2022. The report compares sleeper bus fares in KSRTC, APSRTC & Kerala State Road Transport Corporation and recommends fares as follows:

STA appraised that the Committee has gone through the fares for sleeper buses operating by different STUs in mainland and considering the difference of fare of sleeper with the ordinary buses operating by these STUs, the Committee has recommended the average multiplication factor of 2.13 for the fare of sleeper over the fare of ordinary buses.

STA further appraised that the Committee has recommended the fares of AC Sleeper Coaches (in <u>TABLE 26</u>) by multiplying the existing fares of ordinary buses operating in this UT which notified in 2019. However, Transport Department considering the inflation and other factors, has already initiated a proposal for fare revision of Stage Carriage Buses.

As such, STA decided to accept the multiplication factor of 2.13 as evaluated by the Committee and directed to send a proposal for Sleeper Class fare of Stage Carriage Bus with the multiplication factor of 2.13% on the proposed revised fare of ordinary class buses which is under submission.

16. RELEASE OF FD TO APPLICANTS

STA was appraised that **09** local unemployed residents of UT have applied for NOC for obtaining different categories of permits for their livelihood by depositing security deposits to the Department. Due to various issues i.e. financial crisis, non-availability of intended vehicles etc., they are unable to purchase the vehicle and requested to release the Security Deposit. As such, **STA decided to release the Security Deposits of all the 09 applicants as given in TABLE 27 below:**

19. ISSUE OF NOC/PERMIT FOR MAINLAND REGISTERED NON-BS-VI COMPLAINT VEHICLE

19.1 STA was appraised that Shri. K Bhaskar Rao, S/o Shri. Katta Tatayya, R/o Phongy Chaung has applied on 16/12/2022 for issuance of NOC to ply in all routes of NMS for his already registered mainland registered vehicle bearing Registration No. AP39TE8666 (Tata 1613 Turbo) BS-II complaint.

On 03.10.2020, an NOC has been issued to RTO Port Blair for a vehicle registered in the applicant's name with RTO West Godavari, Eluru. A PMB document indicates that the vehicle was transported to this UT on 27/12/2020, which is well ahead of the 23.05.2022 press release.

The applicant sought an NOC for an already registered vehicle brought from mainland so that he could register it at RTO Port Blair and get a route permit from the STA. Fitness of the vehicle has already been expired on 31/03/2022.

Despite the fact that the vehicle owner imported his mainland registered Non-BS-VI vehicle well before the STA released their press release regarding the restriction on entry of non-BSVI compliance commercial vehicles, he did not approach the STA for the issuance of the permit until 16/12/2022. It appears that the vehicle owner has plied the vehicle without obtaing permit in the UT as such liable for the penalties as decided by STA for issuance of NOC from STA for further course of process of registration and route permit as detailed under:

STA observed that the applicant has made the request for issuance of permit after a long period of 24 months from the date of arrival of the vehicle in the UT. It appears that the applicant plied the vehicle without obtaining route permit and valid fitness. As such, STA directed to issue a Show Cause Notice for clarification on the delay in applying for Permit.

19.2 STA was appraised that Shri. C. Kartick has applied for issuance of regular permit on 02/01/2023 to ply in all routes of NMS for his already registered mainland vehicle bearing registration No. AR06A7531 (Tata LPK 1618) which is of BS-IV complaint. The vehicle was manufactured in the year 2018. The vehicle was brought in this UT on 30.04.2022 i.e. before the press release issued by the Transport Department on 23.05.2022 for not bringing mainland registered vehicles of Non-BS-VI compliant, whereas the said vehicles reached Port Blair before publication of the said 'Press Note'.

In this regard it is to submit that the said case alongwith two others namely Shri S. Srinivas Rao and Shri Kadali Veeramsetti were placed in STA meeting held on 03.08.2022 in which STA observed that the applicants are local unemployed youth of A&N Islands and they have brought the vehicles for their livelihood and decided to grant Temporary Permits to all the three applicants for four months subject to clearance of fitness inspection.

In the cases of Shri S. Srinivas Rao and Shri KadaliVeeramsetti, STA has issued regular permits on registration of their vehicles in the RTO, Port Blair. Fitness inspection of the vehicle bearing registration No. AR06A7531 (Tata LPK 1618) of Shri.

C. Kartickhas been carried out and on clearance to fitness, Temporary Permit for the above said vehicle was issuedw.e.f **12.09.2022 to 11.01.2023** for NMS Route.

In this regard, the applicant has now requested to give permission for registration of the vehicle in RTO, Port Blair and issue regular PC Permit for his vehicle to ply in all routes of NMS. For obtaining regular permit, the vehicle is to be registered in RTO, Port Blair for which permission from STA is required.

Hence, STA decided to consider the case of the applicant for the grant of PC Permit for his vehicle to ply in all routes of NMS.

19.3 STA was appraised that M/s. Mohan Mutha Exports Pvt. Ltd. has applied on 29/11/2022 for registration of vehicle and isuance of Permit to 04 Nos of Open Tipper Vehicles to ply in all routes of South Andaman to undertake Restoration & Rehabilitation of Road from Km 21.00 to km 28.00 on NH-4 (old NH-223)in the Union Territory of Andaman & Nicobar Islands. The details of vehicles are given below:

The firm had brought the vehicles from mainland in the month of **Jan, 2020** which was registered in the State of Tamil Naidu as per the document of TCI Seaways (Bill of lading). The vehicle has brought to this UT before the press release dated 23.05.2022 issued regarding not registration of non-BS-VI commercial vehicles.

The fitness validity of all the vehicles has expired and the firm has applied for permit to ply in all routes of **South Andaman** and re-registration of these vehicles after a period of about 03 years from the date of bringing the vehicle to this UT. For obtaining regular permit, the vehicles are to be registered in RTO, Port Blair for which permission from STA is required.

STA observed that the fitness of the all the 03 vehicles were expired in the month of Nov., 2020 and it appears that the firm has still plied unfit vehicles and without having route permits. As such, STA directed to issue a Show Cause Notice to submit its explaination for plying unfit vehicle and without having valid route permit.

19.4 STA was appraised that M/s S R Enterprises has applied for re-registration of vehicles in this UT and for issuance of Permit on 12/01/2023 for already registered mainland vehicle bearing registration No. UP44 AT7255 (Tata Ace BS-IV) which is of BS-IV complaint to ply in all routes of South Andaman.

The firm was issued with a NOC on 26/07/2021 to purchase/ register Force cargo King with validity upto 25/07/2022 and later permitted as **Tata Ace BS-IV.** STA has also issued No Objection Certificate dated 22/08/2021 to CPA, Port Management

Board to allow the vehicle bearing registration No. **UP44 AT7255** from Chennai to Port Blair. Accordingly, the firm has brought the said mainland registered vehicle to this UT on **11/09/2021**.

Now, the firm has applied for **PC Permit** on 12/01/2023 i.e. after a delay period of 28 months from the date of bringing the vehicle to this UT stating the reason for delay was due to incomplete documents issued by the RTO, Sultanpur. In this regard, it appears that the vehicle has plied without permit, as such liable for penaltyas prescribed in the Order I/8619/2023 dated 12/01/2023 as detailed under.

In the meantime, the fitness of the vehicle also got expired. Hence, the vehicle owner could not obtain the NOC from the concerned RTO yet.

In this regard, the applicant has requested to issue for regular PC Permit for his vehicle to ply in all routes of South Andaman. For obtaining regular permit, the vehicle is to be registered in RTO, Port Blair for which permission from STA is required.

STA approved the request of the firm for issuance of permit after reregistration of vehicle in RTO, Port Blair by imposing applicable penalty for plying without permit and fitness. A detailed order may be issued with proper warning not to ply the vehicle without permit, failing which the registration shall be suspended/ cancelled.

19.5 STA was appraised that **Shri. Rudra Raj Singh** has applied for re-registration of vehicles in this UT and for issuance of Permit on 09/02/2023 for already registered mainland vehicle bearing registration No. AR06 A3105 (Tata LPK 1613 BS-III/IV) which is of BS-IV complaint to ply in all routes of NMS.

The applicant has obtained NOC on 13/09/2021 to purchase/ register Truck with validity upto 12/09/2022 without mentioning the emission norms. Accordingly, the applicant has brought the said mainland registered vehicle to this UT on 13/04/2021(as per the document of PMB (Bill of lading)). The vehicle has brought to this UT before the press release dated 23.05.2022 issued on the matter of non-BS-VI commercial vehicles.

The applicant has also got his vehicle inspected for re-registration at STS Unit Mayabunder on 09/08/2021.

Now, the firmhas applied for PC Permit on 09/02/2023i.e. after a delay period of 22 months from the date of bringing the vehicle to this UT. It appears that the vehicle has plied without permit. In this regard, the applicant has requested to give permission for registration of the vehicle in RTO, Port Blair and issue regular PC Permit for his vehicle to ply in all routes of NMS.

STA observed that Transport Department has issued letter in the month of December, 2021 to all the Stakeholder Department for not allowing non-BS-VI vehicles to this UT and issued a press release 23/05/2022 regarding the restriction on entry of non-BSVI compliance commercial vehicles. 21. VIOLATION OF STAGE CARRIAGE PERMIT CONDITION

STA was appraised that Shri. S Anthony was issued Show Cause Notice vide SCN No. 56 dt. 04/01/2023 for not completing the route and not following the time specified in the stage carriage permit of his bus registration No. ANO1 A6073 (Bus). In response, the applicant has submitted his reply mentioning that due to layering of road from Garacharma to NTS Gate, the road was diverted and he was unable to cover the route as per the time schedule.

In this connection it is to submit that the said Bus was earlier had the permit for the route "Chatham to Shadipur via Bus Stand". On the request of the bus owner Shri. S fre

Anthony, the route was changed to "Chatham to Bimblitan via Garacharma, Tylerabad" with the approval of STA in its meeting held on 04/04/2022.

After the change the route, this office has been receiving number of several complaints against the Bus ANO1 A6073 for not plying in the allotted routes. Complaint was also received from one of the Bus Owner that Shri. S Anthony has threatened him to damage his bus when asked to ply in their scheduled time.

Further, in a normal case of such violation of permit condition, penal amount has been prescribed as per Order I/8619/2023 dated 12/01/2023 as under:

As per the decision of STA, electric vehicles are to be encouraged and promoted for commercial purposes in Shaheed Dweep in the previous meetings. As electric Two Wheelers are already registered and issued permits for its commercial use, Secretary (Transport) / Chairman STA has given in principle approval to issue license under Rent a Motorcycle Scheme. Now the same is required to be ratified by the STA.

As such, STA has approved the case and ratified the decision of Chairman STA regarding issuance of license.

24.2 CANCELLATION OF PERMIT AND VEHICLE CONVERSION TO NT CATEGORY

1. Shri Asim Bowali is the permit holder of 09 two wheelers for Shaheed Dweep route and he has requested on 21.09.2022 to cancel the route permit of all the 09 two-wheeler vehicles which he intends to sell to other person.

The case was approved in the STA meeting dated 02/12/2022 for cancellation of permits for converting the vehicles from Transport to Non-Transport Category.

While disposing the case, it has been observed that the applicant after obtaining permits of his 09 two wheelers on 02.09.2019, never approached STA for the license to rent out the two wheelers. Accordingly, STA vide Order No. 476 dated 30/01/2020 cancelled the permits of all the above two wheelers. The applicant did not surrender the permit till the date of his application for cancellation of permit. For disposing of the case, the cancellation order needs to be revoked.

STA examined the case and approved the following:

- 1. To impose a penalty of Rs. 1000 per vehicle per year for plying the vehicles without obtaining license under 'Rent a motorcycle' Sheme.
- 2. The Route permit of all the 09 vehicles may be cancelled by revoking the cancellation order No.476 dated 30.01.2020 and NOC be issued for conversion of vehicle to Non-Transport Category subject to remittance of penalty.

25. PERMISSION FOR OPERATING E-RICKSHAW AS STAGE CARRAIGE AND ITS FARE FIXATION

M/s Shree Gopal Enterprises has applied on 23/01/2023 for permitting to operate 02 E-Rickshaw (of capacity 01 D + 04 Passengers) from Chattam Jetty to Medical and other from Marina Park to Carbyn's Cove beach on full booking/share auto basis. The firm also requested to fix the fare per person for one way trip as Rs.15.00 from chattam to Medical (start to end) and from Maine Park to Carby's Cove beach as Rs.25.00 per person (Start to end).

The above permit comes under Stage Carriage Permit.

As per the draft A&N Islands EV Policy, Transport Department shall have to promote Electric Vehicles for shifting the vehicle users towards green mobility.

No buses are plying in the route which originates from Maine Park to Carby's Cove Beach. Further, E-Rickshaw on share basis will not only promote E-mobility & Shared mobility but also provide a convenient mean to the citizen to travel.

STA has not yet fixed the fare for E-Rickshaw on full booking/share auto basis for the desired route.

STA examined the matter and considering the topography with undulating terrain of A&N Islands, directed to obtain complete details of the proposed vehicle from the firm and approval certificates of testing agency for its suitability to ply in the topograpichal condition of UT to examine the case further.

26. FIXATION OF FARES FOR THE CABS AND COMMERCIAL TWO WHEELERS OPERATING IN SWARAJ DWEEP

STA was appraised in the meeting dated 02/09/2022 that due to absence of any fare regulation for the cabs and commercial two wheelers plying in Swaraj Dweep and Shaheed Dweep, regular reports on fleeing of tourists by the commercial vehicle drivers have been cropping up. This is not only creating inconvenience for the visiting tourists but also detrimental in the promotion of tourism activity in the Island. In order to maintain a check on the excess fare charging and to eliminate the chances of unhealthy practice by the vehicle owners, STA has decided to fix the fares of cabs and commercial two wheelers plying in Swaraj Dweep and ShaeedDweep under Section 67 of MV Act. A committee has been constituted vide order No. 3557 dated 14/09/2022 with the mandate of recommending fares for the cabs and commercial two wheelers plying in Swaraj Dweep and Shaheed Dweep.

The committee after analysing the present market rates, expenditure involved in operation of these commercial vehicles in these two Islands, demand of vehicles, tourists requirement etc has furnished its report/ recommendation for further examination & recommendation of STA.

STA in its meeting dated 14/10/2022 directed to send back the proposal to the Committee to re-examine the fares with reference to the discussion held in SOM chaired by Chief Secretary. Accordingly, two reminder letters dated 10/11/2022 and 10/02/2023 have been forwarded to the Chairman of the committee. The report is still awaited.

STA has directed to send DO letters to Committee members for early submission of their recommendations.

27. ISSUE OF NOC FOR CARAVAN VEHICLES

It is to submit that an application has been received before STA for obtaining NOC for the registration and operation of Caravan Vehicles in this UT.

As per Rule 2 (za) of CMVR 1989, a Motor Caravan is a "Special Purpose" M Category vehicle and therefore, if the same is registered under Transport Category, it should be covered by a Contract Carriage Permit under Section 74 of MVA 1988.

Accordingly, the case was placed before STA in its meeting held on 14/10/2022 wherein STA observed that there is no SoP or guidelines framed for operating caravan vehicles in this UT. As such, STA decided to obtain opinion from Tourism & Police Department and requested them to prepare SoP for operation of caravan vehicles for incorporation in the permit conditions.

Accordingly, letter No. MT/2-1/STA Meeting/2021/9168 dated 10.11.2022 submitted to Director (Tourism) and Dy.SP (Traffic) followed by a reminder letter No.M-17067/7/2022-STA/4505 dated 30.11.2022.

In response, the Tourism Department has submitted vide letter dated 13.12.2022 that the Department does not have any Policy/registration and technical expert for framing of SOPs for operation of Caravan vehicle in A&N Islands. Hence, they have informed No Objection for framing SOPs for operation of Caravan vehicle.

Dy. SP (Traffic), vide letter dated 04/01/2023 commented that the owner of caravan vehicle shall be directed to abide by all MV Rules and to provide the details of their parking spaces and to park the vehicle in their designated parking area.

STA decided to defer the case for further examination during the next STA meeting.
