MINUTES OF THE MEETING OF STATE TRANSPORT AUTHORITY HELD ON 15.09.2021 AT 5.00 PM IN THE CHAMBER OF SECRETARY (TRANSPORT)/ CHAIRMAN (STA), A & N ADMINISTRATION, PORT BLAIR

At the outset, the Chairman, STA welcomed all those present in the meeting.

The following agenda point came up for discussion in the STA:

1. Revision of Fare for Stage Carriage Buses

The fare for Stage Carriage buses was last revised in October 2019 (Annexure – I). The prevailing fare is Rs. 10/- for the 1st 4 Kms and thereafter approximately Rs. 0.65/KM for every additional Kms. In the past one year, a considerable increase can be seen in the price of essentials required for operating a Stage Carriage Bus. In order to make the operation viable it is felt necessary that the fares of stage carriage buses may be revised at regular intervals so that it will be viable for the operator as well as affordable for the commuters.

The State Transport Authority, A & N Islands was authorized to fix fares and freight (including minimum & maximum in respect of thereof) Stage Carriage, Contract Carriage and Goods Carriage by the Hon'ble Lt. Governor (Administrator) A&N Islands vide notification No. 32-90/2007-TR dated 08/03/2007 (Annexure – II)

A committee was constituted to analyse the present market and submit its comments before revising the fare of Stage Carriage. The report of the committee is detailed below:-

The committee has recommended for an increase of 20% for the existing fare in respect of ordinary local Non AC buses, AC local buses and ATR Express buses. Report of the committee may be seen at **Annexure –III**.

STA after exploring all the options decided to revise the fare of Local ordinary Non AC Stage Carriage buses and Express buses by increasing 20% over the existing notified fare. The fare may be rounded off to the nearest rupee.

As regards, revision of AC local buses including Electric buses, STA recommended to revise the fares in such a manner that the revised AC bus fare should be 25% more than the revised local ordinary Non AC Stage Carriage buses for all stages. The fare may be rounded off to the nearest five rupee.

2. Revision of fare for AC Bus with Bio Toilet:-

Smti. Madhu Lall, R/o Prothrapur, the permit holder of 02 Nos. of AC Deluxe Luxury Coach with Bio Toilet bearing Regn. No. AN01/P 9950, AN01/P 9590 having route permit to ply between Port Blair and Diglipur and vice versa has requested to fix the fare of AC Deluxe Luxury Coach with Bio Toilet plying between Port Blair and Diglipur & vice versa as the construction of Bio Toilet in the buses reduces a total of 05 seats in the bus and there is no existing fare for such type of buses plying in the ATR.

As per the Notification No. 248/2019/F.No. 2-3/STA/Fare/Revision/2018-19/9215, dated 9th October 2019, the existing fare of Air Conditioned Express buses from Port Blair to Diglipur (310 Kms) is Rs. 520/- and the fare from Port Blair to other destinations are given below:-

The seating capacity of the AC Deluxe luxury Coach with bio toilet is 37 + Driver. The total fare for all the 37 seats from Port Blair

to Diglipur comes to Rs 23,125/-(37 x 625). The total fare of 05 removed seat from Port Blair to Diglipur comes Rs. 3125/- (5 x 625). The total seating capacity of the bus, if not compromised for construction of bio toilet will be 42 + 1. In order to get full fare of 42 seats from Port Blair to Diglipur to the permit holder, the fare is to be revised on the basis of the present seating capacity of 37 seats. Thus the fare from Port Blair to Diglipur comes $Rs.709/-\{37x625+3125\} = Rs.709/-$

STA has approved and recommended the fare proposed for AC Deluxe luxury Coach with Bio Toilet.

3. Grant of NOC/Permit:-

As per the present guidelines issued by STA, the following conditions are prescribed for obtaining permit:-

I. FOR GOODS CARRIAGE VEHICLE

- 1. Vehicle to be owned by the applicant,
- 2. Should submit copy of Local Certificate/Islander Card/Voter ID Card/Aadhar Card/Ration Card/ Registration certificate of Firm.
- 3. Requirements of parking place would be compulsory for all kinds of commercial vehicle.

- 4. Parking area certificate.
- 5. Original Registration Certificate and Insurance paper.
- 6. NOC of the Tenant in affidavit if the applicant doesn't possess own parking area.
- 7. Photo of vehicle on the parking area.
- 8. Records of Rights and Map of the Land

II. FOR CONTRACT CARRIAGE VEHICLE

- 1. Vehicle to be owned by the applicant, and
- 2. Should submit driving license of the driver, and
- 3. Should submit address, and
- 4. Requirement of parking place would be compulsory for all kinds of commercial vehicles, and
- 5. Affidavit showing that the applicant is unemployed,
- 6. Should submit Parking area certificate, and
- 7. NOC of the tenant if the applicant does not possess own parking area, and Photo of parking area, and copy of record of rights and Map of land.
- 8. Copy of Local Certificate/Islander Card/Voter ID Card/Aadhar Card/Ration Card/ Registration certificate of Firm.

III. FOR PARTICULAR CONTRACT CARRIAGE (AUTO)

- 1. Vehicle to be owned by the applicant, and.
- 2. Should submit own PSV (Autorickshaw) driving license, and
- 3. Should be below 60 years of age.
- 4. Should submit Parking area certificate, and
- 5. NOC of the tenant if the applicant does not possess own parking area, and Photo of parking area, and copy of record of rights and Map of land.
- 6. Copy of Local Certificate/Islander Card/PAN Card / Address Proof.

IV. FOR STAGE CARRIAGE (BUS)

- 1. Vehicle to be owned by the applicant,
- 2. Should submit copy of Local Certificate/Islander Card/Voter ID Card/Aadhar Card/Ration Card.
- 3. Requirements of parking place would be compulsory for all kinds of commercial vehicle.
- 4. Parking area certificate.
- 5. Original Registration Certificate and Insurance paper.
- 6. NOC of the Tenant in affidavit if the applicant doesn't possess own parking area.
- 7. Photo of vehicle on the parking area.
- 8. Records of Rights and Map of the Land

STA decided that the respective permits may be issued to the above applicants subject to fulfilling all the conditions and guidelines fixed by the STA.

4. A request from Smti Simran Bibi, R/o Nayagaon was received to issue her PCC (Auto) permit by considering the paid parking issued by contractor managing the PBMC parking area.

The STA in its meeting held on 28.08.2019 had decided to make a stringent parking policy for new permits as well as for existing permits may be made to overcome one of the major violations of roadside parking. It was also decided not to accept the parking area certificate/receipt issued by contractors managing Government parking area like PBMC, Panchayat or APWD either for new NOC/ permits or renewal/transfer of existing permits.

As Smti. Simran Bibi was not possessing Islander Card which is an essential document required for issuance of Autorickshaw permit in the UT, STA has considered her request as a special case on humanitarian ground and approved the issuance of NOC for Autorickshaw permit. After receipt of NOC, when she applied for permit it was observed that the parking area details which she submitted at the time of NOC became invalid on account of two reasons:-

- **a.** STA discontinued the acceptance of PBMC owned parking area which were being issued by the contractors.
- **b.** The tender for management of parking area owned by PBMC has expired now and the parking area certificate issued by the tenderer has now become invalid.

Now she has requested that she may be exempted from providing another parking areas as she is unable to furnish a fresh parking area and she has requested to issue the permit on the basis of the previous parking area furnished by earlier.

STA examined the case and decided that since furnishing of parking area details is one of the mandatory conditions for obtaining Autorickshaw permit, the applicant may be directed accordingly.

5. Parking Area

As per the present practice followed by STA, every applicant has to furnish parking area details alongwith land record and map while applying for NOC/ permit. On receipt of application officials of Transport Department (Road safety officials for Port Blair & Departmental officials for outstation) undertake the verification of parking details to ensure land availability and its approach. Verification of land is a cumbersome procedure but often it is found that even after furnishing of parking area by the applicants followed by verification by Transport officials, the vehicles are parked on the roadside creating traffic congestion.

A decision in the STA meeting held on 15.04.2021 was taken on the parking details submitted by the applicant that the parking furnished by the applicants may be allowed upto 05 kms outside the municipal limits if the applicant is a resident of municipal area. This is being ensured by STA while verification of parking details but it is found that the applicants state that they park the vehicle outside the city limits which is closer to the residence of the drivers engaged by them. Most of the owners do not drive their vehicles but prefer to do it by engaging professional drivers which frequently gets changed.

It is also observed that sometimes after the death of the land owner, the legal heirs of the deceased land owner permit the applicants to park vehicle on the land though the land is not transferred in the name of legal heirs in Revenue records.

STA has decided to take up the matter of parking area with PBMC to identify the places under their jurisdiction so that parking of commercial vehicles can be explored by charging nominal fee from the vehicle owners.

6. FARES FOR SPECIAL TYPE OF SERVICES

STA was informed that Transport Department is planning to introduce tourist specific bus services in Port Blair and Swaraj Dweep as mentioned below:-

a. GO-GO Service:

Transport Department will be inducting GO-GO service on a particular route from Bus Terminus to Carbyn's Cove connecting Cellular Jail, Fisheries Museum, Marina Park, Flag Point, Science Centre, Horn Bill Nest. The service will be such that the commuter can get on and get off at any point in the circuit on the day of journey by purchasing a single ticket. Department has informed that the service will be operated by Electric buses on OPEX model. Hence, considering the expenditure involved in operation of electric bus , STA recommends that a flat fare of Rs.150/- per passenger per day may be charged.

b. In similar lines of GO-GO service in Port Blair, Transport Department informed that for improving the public transport service in Swaraj Dweep Island especially targeting the tourists, special service will be introduced in Swaraj Dweep by operating Electric buses. The circuit for this bus will be between Swaraj Dweep jetty, Radhanagar Beach and Kalapathar Beach. STA recommends that a flat fare of Rs. 100/- may be charged from the commuters for a whole day and the commuter can get on and get off at any point on the day of journey. STA further recommends that this service in Swaraj Dweep in addition to the flat fare of Rs. 100/- per person, the commuter may be given the opportunity of travelling in the bus at the fare fixed by STA for AC Electric local buses. This will also encourage the local people to avail the bus service.
