ORDER No.

Whereas, it has been observed by State Transport Authority (STA) that many commercial vehicle owners are plying the commercial motor vehicles without permits which is violation of Section 66 of Motor Vehicle Act, 1988. Such vehicle owners approach STA for grant of permits after substantial use of vehicle for commercial purpose which are registered under Transport Category. Moreover it is also found that many permit holders do not adhere to the permit conditions prescribed in the route permits which attract penalty under MV Act.

And Whereas, Section 86 (1) (a) of Motor Vehicle Act, 1988 provides that the transport authority which granted a permit may cancel the permit or may suspend it for such period as it thinks fit on the breach of any condition specified in Section 84 or of any condition contained in the permit.

And Whereas, Section 86 (5) further provides that where a permit liable to be cancelled or suspended under Section 86 (1) (a) and the transport authority is of opinion that having regard to the circumstances of the case, it would not be necessary or expedient so to cancel or suspend the permit if the holder of the permit agrees to pay a certain sum of money, notwithstanding anything contained in subsection (1) of Section 86, the transport authority may, instead of cancelling or suspending the permit, as the case may be, recover from

the holder of the permit, the sum of money agreed upon.

And Whereas, by exercising the power under Section 86 of Motor Vehicle Act, 1988 STA in its meeting held on 14.10.2022, has finalized the quantum of suspension period or sum of money to be recovered from the permit holder in lieu of suspension for breach of various conditions contained in the permit and also for violation of the provision of MV Laws.

Now therefore, STA has decided to take penal action against the permit holders by way of suspension or recovery of sum of money as detailed under for breach of permit condition or for violation MV Laws:

The penalty amount for violation of plying a commercial vehicle without obtaining permit shall be calculated as under:

- a. Rs.1000/- per month or part thereof in respect of Light Vehicles and Two Wheelers.
- b. Rs.2000/- per month or part thereof in respect of Heavy Vehicles
- c. The period for imposing penalty shall be calculated for the delay

period from the date of registration of vehicle in Transport Category to the date of application made for obtaining permit.

- d. Registered owner shall apply for permit within 30 days from the date of commercial registration of the vehicle. There will no penalty if the application for permit is made within 30 days of registration.
- e. In the event of sale / purchase of such commercial vehicles for which permits have not been issued, the penalty will be calculated as mentioned at point (c).

The permit holder shall have the liberty to file review along with complete justification against the order imposing penalty to State transport Authority.
