

**MINUTES OF THE MEETING OF STATE TRANSPORT

b. Contract Carriage for Swaraj Dweep: STA observed that since 2018, commercial permits for vehicles have not been issued with a view to reduce automotive pollution by encouraging non polluting vehicles, as Swaraj Dweep is one of the most sought after tourist destination and ecologically fragile and sensitive place. Now various representations are being received from the stakeholders for issuance of permits stating various reasons such as old age vehicles, unhealthy competition etc. STA is of the view that a policy decision in this regard needs to be taken considering the overall situation and the interests of stakeholders. Hence the Transport department is directed to initiate a proposal in this regard and device a policy after taking the approval of competent authority. **Hence applications are deferred for the next STA meeting for consideration.** The list of application is placed as **Annexure-I**

c. Contract Carriage for Shaheed Dweep: STA observed that for the last 2 to 3 years, commercial permits for vehicles have not been issued with a view to reduce automotive pollution by encouraging non polluting vehicles as Shaheed Dweep as it is also another sought after location by the tourists. Now various representations are being received from the stakeholders for issuance of permits for fossil fuel vehicles. STA is of the view that a policy in this regard needs to be taken considering the overall situation and the interests of stakeholders. Hence the Transport department is directed to initiate a proposal in this regard and device a policy after taking the approval of competent authority. **Hence applications are deferred for the next STA meeting for consideration.** The list of application is placed as **Annexure-II**

STA approved the cases of vehicles bearing **Registration No-AN01N8539 of Shri Sharuque Ahesan and AN01F7138 of Shri. N K Ramanathan** for Transfer of Ownership with Change of route. Since the case of vehicles bearing **Regn. No. AN01K0179 and AN01J8808 of Shri Bablu Biswas** are for Transfer of ownership and Change of permit jurisdiction from South Andaman to Shaheed Dweep, **STA decided to defer the cases till the next meeting for consideration.**

Agenda Point No. 3

Replacement of vehicle on Condemnation

STA was informed that 28 applications have been received from permit owners for replacement of existing vehicle with a new vehicle as the existing vehicles have become very old and the owners are willing to dispose it by condemning.

As replacement of vehicles after condemnation is permissible under Section 83, **STA approved 27 applications appearing at Sl. No. 1 to 27** as given in Table-8 below:

STA was further apprised that Shri. S K Rafik Rehman requested to grant permission for replacement by condemning his vehicle bearing Regn. No.AN01G1026 (Tavera) manufactured in 2010 with an already registered BS-IV vehicle bearing Regn. No. AN01L8868. **STA decided defer the case to the next meeting as it relates to replacement of vehicle of BS-IV in Swaraj Dweep and the same will be considered after framing of its policy by the Transport Department.**

Agenda Point No.4: Change of Permit

a. Stage Carriage Jeep to Contract Carriage Jeep

Smti Sumati Sarkar owner of vehicle No.AN01 D 1263 (Jeep) having a Stage Carriage permit wants to convert the permit into a Contract Carriage Permit. It is gathered that the Stage Carriage permit for this vehicle was issued on 14.02.2022 and prior to that the vehicle was having a Contract Carriage permit. STA is of the view that if the permit is reverted back to Contract Carriage Permit then this vehicle will indulge in violation of permit by operating a Stage Carriage Permit with a Contract Carriage Permit which is a common practice in their

jurisdiction. Hence, **the request is not approved by STA.** Action in all such cases of permit violations is being taken in the form of imposition of penalty and facilitating the vehicle owners for conversion of Contract carriage into Stage Carriage permits

b. Contract Carriage to Stage Carriage Jeep

1. Smti. Saummayya, D/o Shri. M Hassan applied for changing the Contract Carriage permit of Jeep bearing vehicle registration No.**AN01/C-9530** into Stage Carriage Jeep permit to ply from Bathu Basthi to Tushnabad. The permit was issued for Contract Carriage Jeep on 29.05.2006 and the vehicle was manufactured during the year 2005. STA was informed that most of the jeeps plying on this route are involved in transportation of passengers as Stage Carriages which is a violation if performed by a Contract Carriage vehicle. Hence, **to streamline the process, the request of applicant to change the permit from Contract Carriage to Stage Carriage is approved by STA.**

2. Request received from Shri. Sidaquat Ali, S/o Shri. Rahat Ali for changing the Contract Carriage permit of Jeep bearing vehicle registration No.**AN01/D-9288** into Stage Carriage Jeep permit to ply from Tushnabad to Bathu Basthi. The permit was issued for Contract Carriage Jeep on 01.05.2009 and the vehicle was manufactured during the year 2008. STA was informed that most of the jeeps plying on this route are involved in transportation of passengers as Stage Carriages which is a violation if performed by a Contract Carriage vehicle. Hence, **to streamline the process, the request of applicant to change the permit from Contract Carriage to Stage Carriage is approved by STA.**

c. Swaraj Dweep

1. Request received from Shri. Mahananda Mondal, R/o Krishna Nagar, Swaraj Dweep for changing the Contract Carriage permit of Jeep bearing vehicle registration No.**AN01/D-7566** into Stage Carriage Jeep permit to ply from Swaraj Dweep Jetty to Radha Nagar to Kala Pathar and vice versa. The permit was issued for Contract Carriage Jeep on 21.09.2009 and the vehicle was manufactured during the year 2007. Now the applicant intends to convert the permit from Contract Carriage Jeep to Stage Carriage Jeep without any time table. STA was informed that most of the jeeps plying on this route are involved in transportation of passengers as Stage Carriages which is a violation if performed by a Contract Carriage vehicle. Hence, **to streamline the process, the request of applicant to change the permit from Contract Carriage to Stage Carriage is approved.** The permit will be issued indicating the route and operational time table.

2. Request received from Smti. Arati Rani Shil, W/o. Shri. Parimal Shil, R/o Shyam Nagar, Swaraj Dweep for changing the Contract Carriage permit of Jeep bearing vehicle registration No.**AN01/E-5235** into Stage Carriage Jeep permit to ply from Swaraj Dweep Jetty to Radha Nagar to Kala Pathar

and vice versa. The permit was issued for Contract Carriage Jeep on 10.09.2013 and the vehicle was manufactured during the year 2009. Now the applicant intends to convert the permit from Contract Carriage Jeep to Stage Carriage Jeep without any time table. STA was informed that most of the jeeps plying on this route are involved in transportation of passengers as Stage Carriages which is a violation if performed by a Contract Carriage vehicle. Hence, **to streamline the process, the request of applicant to change the permit from Contract Carriage to Stage Carriage is approved.** The permit will be issued indicating the route and operational time table.

Agenda Point-5: Change of Class of Vehicle in NOC

The requests received from three applicants are for change of type of permit in the already issued NOC from Contract Carriage to Public Carrier. Since there are no changes in the documents to be furnished for these two categories of permits, **STA approves the request for change of type of permit in the NOC for all the three cases.** The list of applications is given in Table-9 below:

Agenda Point-6: Issuance of permit for already registered commercial vehicles brought from mainland.

a. 25 (Twenty Five) already registered commercial vehicles have been brought from other states into the Islands before 01.12.2021. STA was informed that in the meeting of STA held on 24/12/2021, it was observed that the tendency of the people is to bring old vehicles from mainland for participation in the tender or any project works which results in causing heavy automotive pollution and thereby damaging the environment of the UT. Hence, it was decided that a letter be send immediately requesting all the stakeholders departments to make provisions in their tenders for usage of vehicles only complying with BS-IV emission norms if these vehicles are required to be brought from mainland. Accordingly a letter was sent to all major stake holder Departments with the request to incorporate such condition while floating tenders. STA was further apprised that all these vehicles were brought during the last two years and lying idle in the absence of route permit. **Since the vehicles were brought earlier than the decision of STA taken in the month of December, 2021, STA approved the request for grant of permit for 12 individual owners subject to clearing the fitness inspection test by Committee constituted for the purpose followed verification by Committee consisting**

Registering Authority, Mechanical Engineer and Assistant Engineer (Tech). The list of applications is given in Table-10.

- c. Requests have been received from the following transporters for according permission to transport back their pre-registered commercial vehicles other States / UTs to mainland which were brought in this UT for execution of different developmental projects. In response to letter No. 1-2/STA/Genl.Corr./2014 (P)/ dtd. 29.12.2021 & 17.5.2022, PMB has issued a Circular dated and restricted the transportation of Non BS VI compliant Commercial Vehicles to / from this UT.

These vehicles have been brought to the UT after the decision of STA to permit only BS-VI complaint already registered vehicles and sending letters to the Stakeholder Departments. STA was further apprised that out of these 13 vehicles, 10 vehicles are owned by the under mentioned mainland based firms:

- (i) M/s Lalbaba Enterprises - 07 vehicles
- (ii) M/s Bansal Constructions – 03 vehicles

In the case of the vehicles of M/s Lalbaba Enterprises, STA was informed that in compliance to the direction of Hon'ble High Court, Temporary permits were issued for a period of four months which expired on 18.06.2022. In the meantime, Honble High Court vide order dated 28.07.2022 has directed the Department to consider the application for fitness of vehicles and subsequent re-registration as per the rules within four weeks. **STA, therefore directs the Registering Authority to dispose of the application submitted by M/s Lalbaba Enterprises by conducting the fitness inspection by 18.10.2022 in compliance to the direction issued by the Hon'ble Court and submit the report to STA for consideration of the case in the next meeting.**

STA was further apprised that M/s Bansal Construction has brought 03 already registered commercial vehicles from

Rajasthan out of which two vehicles were blacklisted and the fitness of the third vehicle expired in 2017. The firm also approached the Hon'ble High Court but no relief was granted in respect of these illegally brought old & unfit BS-II complaint vehicles. Moreover the firm has not submitted any document related to the vehicles to STA. **STA has therefore not considered the request for grant of permit in respect of these unfit vehicles.**

STA was informed that the applications appearing at S. No. 11, 12 and 13 are belonging to local, unemployed islanders. These unemployed persons have brought already registered BS-IV complaint vehicles from other States for their livelihood. It was also informed that the press note for the information of general public was issued by the Transport department on 23.05.2022 whereas these three vehicles reached Port Blair before publication of press note. Moreover, it is also seen that UT Administration has taken up the matter with GoI for phasing out commercial vehicles which are more than 20 yrs old. In the instant case, none of the vehicles is more than 05 years old. In a similar case involving M/s Lalbaba Enterprises, as per the direction of Hon'ble High Court, Temporary Permits were issued by the STA for four months. Hence **STA decides to grant Temporary permits for four months to the individual applicants as they are local unemployed youth of A&N islands and they have brought the vehicles for their livelihood subject to clearance of fitness inspection test of vehicles.** The list of application is given in Table-12 below:

- d. 03** Firms have brought 20 motor vehicles and many construction equipments to this UT for executing different projects of GoI. The firms requested to grant permission to transport back these motor vehicles & equipments to mainland on completion of the projects. STA was apprised that some of the vehicles in the list are registered under Non-Transport Category whereas the remaining vehicles are registered under commercial (Transport) category and plied without permits and fitness violating the provisions of MV

Laws. **STA decides to permit the firms to take back the vehicles by imposing the fines applicable on each vehicle as per MV Rules.** The list of application is given in Table-13 below:

Agenda Point-8: License under 'Rent-a-Motorcycle Scheme' for Two Wheelers

- a. STA was apprised that Smti Dipti Biswas R/o Swaraj Dweep has obtained Contract carriage permits for 05 (Five) two wheelers from STA in the year 2019 for commercial operation and applied for License under 'Rent-a-Motor Cycle' Scheme on 06.12.2021 i.e. after a span of 02 years. The facilities required for obtaining License under the scheme has been verified and found to be in order. From the odometer reading of the vehicles, it was observed that the vehicles have operated for rental purpose without obtaining License. **STA decides to grant License to the applicant under 'Rent-a-motorcycle Scheme' by imposing penalty of Rs.5000/- i.e.@Rs.1000/- on each vehicle.**
- b. STA was apprised that Smti Sadhna Gain R/o Swaraj Dweep has obtained License under 'rent-a-Motorcycle Scheme' for her 15 vehicles on 13.07.2015 bearing License No. MT/1-21/STA License/2015/27 dt 13.07.2015 with the validity up to 12.07.2020. The applicant submitted the application for renewal of License on 14.02.2022 i.e. approximately after 1 ½ years. The facilities required for hiring out the vehicles under the scheme has been verified and found to be in order. **STA decides to renew the License to the applicant under 'Rent-a-motorcycle Scheme' by imposing penalty Rs.15000/- i.e.@Rs.1000/- on each vehicle.**
- c. (1) STA was apprised that Shri Kumeresh Halder R/o Diglipur has obtained License under 'Rent-a-Motorcycle Scheme' for 05 Two-Wheelers in the year 2018 bearing License No. MT/1-21/STA License/2018 dt 24.05.2018. The applicant purchased 06 more two-wheelers and obtained permits from STA and requested to include these vehicles under the License obtained by him. **STA approves the inclusion of 06 two-wheelers having permits issued by STA in the existing License.**

(2) STA was apprised that Shri Ashish Mondal R/o Swaraj Dweep has obtained License under 'Rent-a-Motorcycle Scheme' for 15 Two-Wheelers in the year 2018 bearing License No. MT/1-21/STA/License/2018 dt 22.10.2018. The applicant purchased 05 more two-wheelers and obtained permits from STA and requested to include these vehicles under the License obtained by him. **STA approves the inclusion of 05 two-wheelers having permits issued by STA in the existing License.**

(3) STA was apprised that Shri A Santosh Kumar has obtained License under 'Rent-a-Motorcycle Scheme' for 05 Two-Wheelers in the year 2019 bearing License no. MT/1-21/STA License/2019/1 dt 24.05.2019. The applicant made application for NOC for purchase of 05 more two-wheelers to include in the existing License. In the meantime, the License of the applicant was cancelled vide Order No.479 dated 30.01.2020 on the ground of shortcomings in the facilities maintained by the applicant. Shri A Santosh Kumar has rectified the shortcomings and requested to revoke the cancellation order. Accordingly, the facilities were re-inspected

and found that the required facilities are maintained by the applicant under the Scheme. **STA decides to revoke the License and subsequent to revocation, issue NOC for purchase of 05 two-wheelers.**

d. Transfer of Two-Wheelers:

(1) STA was apprised that Smti Sita Laxmi Mandal R/o Swaraj Dweep made request for transfer and issue of License under 'Rent-a-Motorcycle' Scheme for 13 two-wheelers owned by her deceased husband namely Nibir Mandal. She has submitted Death Certificate, Legal Heir Certificate, Form-31, parking details, permits of vehicle etc. and found to be eligible for transfer of permits. The facilities have been inspected and found that the required facilities are maintained by the applicant under the Scheme. **STA decided to grant permission for transfer of permits in respect of the 13 vehicles and issue License under 'Rent-a-Motorcycle' Scheme as she is the eligible legal heir.** The list of vehicles is given in the Table-15 below:

(2) STA was apprised that Shri Abdul Hamid Mallick purchased 05 motor cycles and obtained permits for all 05 vehicles in January, 2019. On 12.08.2021, he made a request to give permission to sell these vehicles on the ground of his ill health as he could not start the business to rent these vehicles and kept idle. For selling the vehicles he has to convert the vehicle to non transport after cancelling the permit. **STA decided to cancel the permits of all the 05 vehicles to enable the applicant to convert the vehicles to non-transport so that he can sell the vehicles.**

Agenda Point-9

STA was apprised that the Letter of Authority (LOA) issued to M/s Fumo, Teylrabad and M/s Annex Engineers, Dollygunj have been suspended for indefinite period on 03.03.2022 and 05.02.2022 respectively on the ground of charging over the rate fixed by the Administration during camping at different places. **STA observed that the cases are not covered under the purview of STA, hence STA has the view to take up the matter with the appropriate Authority.**

Agenda Point-10: Issue of permits to the applicants on whom penalty already imposed or cancelled RCs for plying without permit:

a. Penalty imposed

(1) Shaheed Dweep

STA was apprised that during the visit of DoT in Shaheed Dweep in December 2020, many non-transport vehicles were found operating illegally as Contract Carriage in Shaheed Dweep. Accordingly, Registration Certificates of 15 Non Transport vehicles were cancelled vide Order No.5359 dated 05.12.2019 & No.5360 dated 05.12.2019 for violations of the provisions of M.V.Act 1988. On further scrutiny of each case, it was observed that out of the 15 vehicles, 12 vehicle owners have already applied for issue of NOC/ CC Permit for operating their vehicles in Shaheed Dweep. As such, considering the period of illegal operation, the Director of Transport imposed different amount of penalties on each vehicles and directed to issue NOC subject to deposit of penalty. Accordingly the cancellation of RCs of the 12 vehicles has been revoked. The vehicle owners at Sl. No. 3,4,5,6,7,8,9,10 & 12 have paid the penalties and they have been issued with NOC/CC permit. The vehicle owners at S.No.3, 4, 5, 7 & 12 have paid the penalty later on different dates, but the NOC/permits are yet to be issued to them.

In this regard, STA observed that since 2018, commercial permits for vehicles have not been issued with a view to reduce automotive pollution by encouraging non polluting vehicles as Swaraj Dweep. **STA is of the view that a policy in this regard needs to be taken considering the overall situation and the interests of stakeholders. Hence the Transport department is directed to initiate a proposal in this regard and device a policy after taking the approval of competent authority. Hence applications are deferred for the next STA meeting for consideration.** The list of application is placed as **Annexure-VII**.

(2) South Andaman

(i) STA was apprised that Shri Amit Kumar Das R/o Pathergudda applied for Public Carrier Permit to ply in all routes of North, Middle and South Andaman (NMS) for his vehicle bearing Registration No.AN01 N 9707. RC of the vehicle was suspended for 03 months in February, 2022 for plying the vehicle without permit and later revoked with the imposition of fine Rs.10,000/-. The applicant deposited the fine amount on 13.05.2022. **STA decides to issue Public Carrier Permit to ply all routes in North, Middle and South Andaman for the vehicle bearing Registration No.AN01 N 9707.**

(ii) STA was apprised that M/s Surendra Infrastructure Pvt. Ltd. purchased trucks (Tipper/ concrete mixer) bearing Regn. No. AN01K-1464, AN01K-1443, AN01K-1426 and AN01K-1471 and obtained NOCs on 19.03.2020 &

06.11.2020 with the validity up to 06.05.2021 and got transferred the vehicles in favor of the firm. Due to late submission of application for permits i.e. 11.02.2022 and 09.02.2022 a penalty of @Rs.40,000/- was imposed on each vehicle and collected the fine vide DD No.241717 dated 03.01.2020, DD No.238799 dt 05.06.2020, DD No. 238800 dt 05.06.2020 & DD No.238715 dt13.03.2020. **STA decides to issue Public Carrier Permit to ply in all routes of North, Middle and South Andaman for all the 04 vehicles.**

b. Registration suspended for 21 vehicles in Shaheed Dweep.

STA was apprised that during the visit of DoT in Shaheed Dweep in December 2020, many non-transport vehicles were found operating illegally as Contract Carriage in Shaheed Dweep. Accordingly, Registration Certificates of 21 Non Transport vehicles were suspended for one year. These 21 vehicle owners have applied for issue of NOC/ CC Permit for operating their vehicles in Shaheed Dweep.

In this regard, STA observed that since 2018, commercial permits for vehicles have not been issued with a view to reduce automotive pollution by encouraging non polluting vehicles as Swaraj Dweep. STA is of the view that a policy in this regard needs to be taken considering the overall situation and the interests of stakeholders. Hence the Transport department is directed to initiate a proposal in this regard and device a policy after taking the approval of competent authority. **Hence, STA decided to defer the applications till the next meeting for consideration.** The list of application is placed as **Annexure-VIII.**

Agenda Point No.11: Decision on Penalty for violation of Permit Conditions

- a.** STA was apprised that Shri Ashim Mondal R/o Nimbudera and Shri Jag Jeevan Das R/o Bimblitan obtained NOC from STA on 25.10.2018 and got their vehicles bearing registration No.AN01 Q 2755 (Maruti Ertiga) and AN01 N 6374 (Datsun Go+) on 24.10.2020 and 27.10.2018 respectively. Shri Ashim Mondal applied for permit on 08.02.2022 i.e. after a gap of one and half years whereas Shri Jag Jeevan Das applied for permit 14.03.2022 i.e. after a gap of three and half years. **STA approves the issuance of CC permits to the applicants with the imposition of fine@Rs.2000/- in each case.**
- b.** STA was apprised that a surprise inspection was carried out in the Office of the 10 License holders under the 'Rent-a-motorcycle' Scheme at Swaraj Dweep in which many shortcomings were noticed and liable to be imposed fine. **STA decides to impose fine @Rs.2000/- in each case.** The list of License holders is given in Table-16 below:

c. (1) STA was apprised that Smti Rentnavathy, W/o Late A Joseph, R/o Pathergudda was served with a Show Cause Notice for road side parking at Pathergudda in the night as reported by Police Department. The vehicle owner in her reply stated that she's 65-years-old widow woman and livelihood is fully dependent on the earning of the vehicle. She further stated that her vehicle was parked in front of Ganesh Temple at Pathargudda due to the renovation of her house which is just 5 meters away from the Temple. **STA decides to issue a warning in this matter.**

(2) STA was apprised that Show Cause Notices to 62 commercial vehicle (Auto-rickshaw, LMV and HGV) owners have been issued for unauthorized parking as reported from Police Department. **STA decides to impose penalty of Rs.500/- for auto-rickshaws, Rs.1000/- for LMVs and Rs.2000/- for HGVs.** The details of vehicle owners are given in the Table-17 below:

f. Suspension Revocation:

The vehicle was initially registered on 22.11.2017 and operated without permit by the previous owner. **STA decides to impose penalty of Rs.10,000/- and issue permit to ply the vehicles in all routes of North, Middle & South Andaman.**

Agenda Point No.17

STA was apprised that Shri B Mohan, owner of vehicle bearing Registration No.AN01 D 7440 having CC permit, has been imposed penalty of Rs.5,000/- for violation of permit condition as he operated the vehicle as stage carriage. The vehicle owner requested to exempt the penalty amount on the ground of financial crisis. **STA decides not to consider the request of exemption. However, STA grants 03 months time to the vehicle owner for payment of fine amount in three installments and during the period, the applicant may be given Temporary Permit.**

Agenda Point No.18

STA was apprised that Shri P Dhanpal R/o Indira Nagar, Manglutan, the stage carriage permit holder of vehicle bearing registration No. AN01E-6540 plying in the route from Mohanpura Bus Stand to Manjery via Bathu Basthi requested for replacement

of his bus having seating capacity 44+1 in his existing stage carriage permit with a new bus of seating capacity 55+1 and using his old bus as reserve stage carriage. **STA approved the case.**

Agenda Point No.19

STA was apprised that Shri K Unnikrishna Pillai requested for Change of route of Public Carrier permit for his vehicle bearing registration No.**AN01 D 9734** (BS-IV) having the permit to ply in all routes of Campbell Bay to all routes of Shaheed Dweep for undertaking & developmental project of ALHW. In this regard, STA observed that since 2018, commercial permits for vehicles have not been issued with a view to reduce automotive pollution by encouraging non polluting vehicles as Shaheed Dweep. STA is of the view that the case may also be included in the list of cases of Shaheed Dweep for which **STA decided to defer the case for next meeting and directed Transport Department to initiate a proposal to devise a policy granting permits in Swaraj Dweep and Shaheed Dweep with the approval of Competent Authority.**

Agenda Point No.20

STA was apprised that M/s Pristine Andaman is a registered vendor to the Govt. organizations for supply/ hiring of vehicles on official use and also a main vendor to supply vehicles during VVIP visits. The firm has a fleet of 20 vehicles presently. The firm intends to augment the fleet adding 20 SUVs (Mahindra Scorpio/ Maruti Ertiga) and 05 Premium SUVs (Toyota Innova Crysta/ Tata Hexa) vehicles. The firm requested to issue NOC for the above fleet to enable the firm to get the Banker's approval for the purchase of vehicle. **STA approved the case.**

Agenda Point No.21

STA was apprised that Federation of Automobile Dealers Associations (FADA) has requested to remove the stringent parking requirement for electric vehicles. The dealers of EVs have approached FADA with the request to take up the matter with STA to remove the parking norms to propagate EVs for commercial use especially in Swaraj Dweep and Shaheed Dweep. Further they requested to accept the undertaking from people affirming that they won't park their vehicles on road side instead of submitting land documents. **STA decides to accept the request to promote EVs in the UT.**

Agenda Point No.22

STA was apprised that a request has received from the Neil Island Tourist Vehicles Association issuance of Contract Carriage permit to the unemployed youths of Neil Island who had applied for NOC in 2019 and have already purchased vehicle before COVID-19 pandemic and their application are pending with the STA. In this regard, STA observed that since 2018, commercial permits for vehicles have not been issued with a view to reduce automotive pollution by encouraging non polluting vehicles as

Swaraj Dweep. **STA is of the view that a policy in this regard needs to be taken considering the overall situation and the interests of stakeholders. Hence the Transport department is directed to initiate a proposal in this regard and device a policy after taking the approval of competent authority. Hence applications are deferred for the next STA meeting for consideration.**

Agenda Point No.23

STA was apprised that a request has been received from Auto Union Association for increasing Auto-rickshaw fare due to hike in fuel prices and other goods. The fare of Auto-rickshaws was revised in the year 2019. The Auto-rickshaw Union requested to revise the base fare from Rs. 25/- to Rs. 35/- and Rs. 13/- to Rs. 25/- per extra KM. **STA decides to constitute a committee under the Chairmanship of Dy. SP (Traffic) with the following composition:**

- (i)** Dy. SP (Traffic), A&N Administration – Chairman
- (ii)** DD (Admin), Directorate of Transport – Member
- (iii)** Assistant Director, Civil Supplies – Member

The committee shall analyze the present market rates of all components responsible for the operation of Auto-rickshaw by comparing it with the situation in 2019 when the fares were last revised. The committee shall also meet the representatives of all the major Auto-rickshaw union and take their feedback. Based on the quantum of increase/ change in the expenditure due to the stated price rise, the committee shall analyze all aspects and recommend the fare revision accordingly. **The report shall be furnished by the committee before the next meeting by STA.**

Agenda Point No.24

STA was apprised that in the present system to issuance of NOC/ Permit designated parking details are being obtained and before issuance of NOC/ Permit the parking is verified by the Officials of Road Safety Cell. The parking area verification seems to be an unfruitful exercise because in spite of parking area verification, it is observed that the vehicles are unauthorisedly and obstructively parked on road side during night hours. As such it is proposed to discontinue the process of parking verification. However an undertaking / self declaration to this effect may be obtained and exercise stringent enforcement for unauthorized and obstructive parking.

STA is of the view that discontinuation of existing parking verification is a policy decision hence the final decision in this regard may be taken with the consent of UT Administration. Hence the Transport Department is directed to initiate a proposal in this regard to obtain the approval of Competent Authority. Hence, the case is deferred for the next meeting for consideration.

Agenda Point No.25

STA was apprised that various transactions are being carried out on daily basis in the STA Section. The case of fresh NOC/ Permits and the cases in which policy decisions are required, are only being placed in the STA meeting. The STA since its inception, delegated powers to Secretary (STA) and Director of Transport to dispose of the normal cases in different STA meetings. No formal orders in this effect have been issued so far which makes confusion for the authority during approval of the cases. Hence, it has been proposed to define the powers of STA, Secretary (STA) and Director of Transport in each case of transactions in the STA and issue formal order.

STA is of the view that delegation of powers is a policy decision, hence the final decision in this regard may be taken with the consent of UT Administration. Hence the Transport Department is directed to initiate a proposal in this regard to obtain the approval of Competent Authority. Hence, the case is deferred for the next meeting for consideration.

It was decided that STA meetings for applications received in given month will be held on 1st working Friday of next month.
