- i. **Shri. M. Muthu Pandian**, a local unemployed youth had initially applied for NOC for the purchase of Contract Carriage vehicle (TATA Hexa) on 04.02.2019 to ply in all routes of North, Middle and South Andaman. The applicant vide his application dated 26.06.2023 had again applied for grant of permit for the said vehicle. Hence, STA decided to approve all the 09 cases in respect of Strong Hybrid Electric Vehicles (SHEVs) as mentioned in the TABLE: 09 in view of the decision of STA to promote Hybrid vehicles.

e) Electric Vehicles (CC-4W):

M/s. Prince Holiday Inn Pvt. Ltd, Garacharma vide application dt.27/10/2023 has requested to issue route permit for their vehicle bearing Registration No. AN01 Q-8741 (TATA Tigor EV XM+) to ply in South Andaman district.

On scrutiny of the records it is observed that M/s. Prince Holiday Inn Pvt. Ltd, Garacharma purchased one Electric vehicle TATA Tigor and requested to register the vehicle under transport category. Accordingly the electric vehicle was registered under transport category vide Registration No. AN01Q-8741 on 29.10.2021. Thereafter the firm applied for contract carriage permit for the said vehicle on 13.12.2021.

From the records it has been further observed that the case was initially dealt in the file for issuance of CC permit, however on later stage the same was placed before STA and got approved in its meeting dt. 24/12/2021 for issuance of fresh NOC to ply in South Andaman

District. Accordingly, FD letter was issued dated 27.12.2022 instead of issuing permit to the above said vehicle for mentioned route.

Now, the firm has again applied for grant of permit for the above said vehicle to ply in all routes of South Andaman.

STA approved the request of the firm for grant of permit to ply in all routes of South Andaman.

STA ratified the approval of the Secretary (Transport) for grant of NOCs for the above 02 electric vehicles mentioned in TABLE: 10 as contract carriages in Swaraj Dweep.

1.2 CONTRACT CARRIAGE PERMITS (2-W)

a) Fossil Fuel Two Wheeler (CC-2W) SOUTH ANDAMAN

STA was informed that 07 (Seven) applicants have applied for NOC to purchase 40 fossil fuel driven Two wheelers for obtaining Contract Carriage (2-W) permits under Rent a Motorcycle Scheme.

However, to promote E- Vehicles in the UT, STA in its previous meetings, decided that the number of a maximum of five fossil fuel driven two wheelers would be permitted in the License under Rent a Motor Cycle Scheme as the minimum number of two wheelers to obtain the license is five. Any additional requirement would have to be with EVs only.

As contract carriage permits are a pre-requisite to apply for license to rent out Two wheelers under Rent a Motorcycle Scheme 1989, the applications have been considered by STA and approvals are given on case to case basis as mentioned in the TABLE: 11 below:

1.3 AUTORICKSHAW PERMITS

As per section 73 of Motor Vehicle Act 1988, STA has prescribed the following conditions for obtaining a Particular Contract Carriage permit/ NOC:-

1. Type of the vehicle to be mentioned in the application
2. Vehicle to be owned by the applicant.
3. **Should possess own driving license to drive LMV/ 3 Wheeler.**
4. **Only one autorickshaw permit will be issued to one person.**
5. Should submit address proof.
6. Requirement of parking place would be compulsory for all kinds of commercial vehicles.
7. Affidavit showing that the applicant is unemployed.
8. Should submit Parking area certificate.
9. NOC of the land owner if the applicant does not possess own parking area. Photo of parking area, copy of record of rights and Map of land.
10. Copy of **Local Certificate/Islander Card.**
11. Proof of age showing that the age of applicant is **below 60 yrs.**

a. Various applications have been received during the period from 30.08.2023 to 31.10.2023 under Section 73 of the MV Act in the STA for grant of NOC/Permit for plying Particular Contract Carriage (PCC) Autorickshaw. The route wise details are as under:

As regards to issuance of NOC for Autorickshaw permit / NOC, it is to apprise that in order to ensure proper implementation of the decisions taken by the STA during its previous meetings, STA in its meeting dated 09.06.2023 decided that the applications received for grant of NOC / Permits for passenger autorickshaw may be got verified independently by two level Committees i.e. 1st Committee at STS Unit level and 2nd Committee at Directorate of Transport level. Accordingly, the two level Committees were constituted vide Order No. 2498, dated 03/07/2023.

It is further to apprise that **147 applications** (101 South Andaman + 43 North & Middle Andaman + 03 Little Andaman) which were received till 07.06.2023 were placed in the STA meeting held on 09.06.2023 and STA decided to get the applications examined by the 2nd level Committee at Directorate of Transport for independent verification of applications particularly with respect to the conditions of the permits and also whether the change of ownership does not lead to violation of the conditions. The details of applications is minitized at Table-10, 11 & 12 under point No. 1.3(I), (II) & (III) of minutes of STA meeting held on 09.06.2023.

Complying with the direction of STA, the 2nd level Committee examined the documents of 147 applications furnished by individual applicants with reference to the guidelines / conditions of STA vide minutes of the meetings dated 2007, 2017, 2018, 2021 & 2023 and pointed out that the definition of 'local unemployed people' needs more clarity. It needs to be clarified which specific documents required to be submitted by the applicant to prove that he / she is a local and unemployed. Many applicants submitted undertaking stating that the applicant is unemployed but they might be employed by some private organisation or owns own business or work as daily rated / contractual employee in any Govt. / PSU/ LSG. Committee also observed that some of the applicants do not own any Autorickshaw permit but they own other types of commercial vehicles like goods carrier or passenger carrier. Further, in the above decisions, it is not clear whether the conditions imposed will apply in the case of transfer of ownership of Autorickshaw too. Hence the Committee kept the cases pending with the recommendation to place the matter in STA meeting for issuance of proper clarification on the above points so as enable the Committee to examine the applications properly.

Accordingly the report of the 2nd level Committee was placed in the STA meeting held on 30.08.2023 in which STA examined the report and decided to obtain legal opinion from the Law Department by framing specific query as raised by the Committee pertaining to the guidelines/ conditions mandated by the STA vide its minutes of the meetings dated 2007, 2017, 2018, 2021 & 2023.

Thereafter, 157 applications were received for issuance of NOC/permit in respect of passenger Autorickshaw during the period 09.06.2023 to 28.08.2023 which were placed in the STA meeting held on 30.08.2023. Since, these cases couldnot be examined and scrutinized by the second level committee in the absence of clarification, all the 304 applications were also kept pending. Now, 58 more applications have been received for issuance of NOC/permit for the period 30.08.2023 to 31.10.2023 in respect of passenger Autorickshaw.

Similar to fresh case of applications related to NOC / permits of passenger Autorickshaw applications, all the transfer applications of passenger autorickshaw and replacement against condemnation are also kept pending by 2nd level Committee in the absence of clarification.

STA was apprised that in the cases for issuance of fresh autorikshaw and transfer of permit NOC in respect of passenger, the guidelines / additional conditions prescribed by STA shall apply. Since the legal opinion from Law Department on the guidelines / additional conditions mandated by STA in respect of passenger autorikshaw is yet to receive, STA decided to keep the all the cases of fresh NOC and Transfer of permit in respect of passenger autorikshaw under consideration and the decision on these cases will be taken on receipt of legal opinion from Law Department.

STA further observed that in the case of replacement of vehicle against condemnation, the vehicle owner already possesses a valid route permit for a passenger autorikshaw in his name, hence in such case, the guidelines / additional conditions prescribed by STA shall apply. Hence STA approved the 16 cases of 'replacement against condemnation' received during the period 09.06.2023 to 28.08.2023 mentioned in the Annexure-O of agenda. List of applications is given in TABLE:14 below:

b. ELECTRIC AUTORICKSHAW

Shri. Premananda Roy, S/o. Late Tarini Roy, R/o. Vivekananda Pur, Little Andaman vide his application dated 11.10.2023 has requested to grant NOC for purchase of **Electric Autorickshaw** to ply in all routes of **Little Andaman**.

It is to apprise that in order to accelerate adoption of Electric Vehicles in the UT and to promote shared mobility, clean transportation, ensure environmental sustainability, pollution reduction, energy efficiency and conservation, the Electric Autorickshaws have been included in the Draft Andaman and Nicobar Electric Vehicle Policy vide Point No. 7.2 by providing purchase incentives.

Further, STA in its earlier meetings has decided to encourage and promote electric vehicles in the UT of A & N Islands and also by giving relaxation in the mandatory parking requirement for obtaining permits.

STA approved the request of the applicant for issue of NOC to purchase electric Autorickshaw to ply in all routes of Little Andaman.

c. Penalty Exemption

Shri. Satya Raj S/o Late J K Arul Das R/o Buniyadabad, Port Blair, vide letter dated 28.09.2023 stated he is the registered owner of passenger autorickshaw bearing Registration **AN01E-0385** having a route permit to ply in South Andaman. The aforesaid vehicle route permit has been expired on **21.07.2015** and due to his deteriorated health condition, he had to proceed Chennai for medical treatment and could not renew his permit. He also submitted medical documents in support of his statement. He further stated that during the treatment period, the autorickshaw was kept idle in the garage and now borrowing loan from outside, he made the autorickshaw roadworthy but there is no money left with him to pay the fine to renew the permit. As such he requested to exempt / relax the late fine on account of delay in renewal of permit.

As per the documents furnished by the applicant, he undergone medical treatment continuously at Chennai during the last few years. His father was a govt. employee in DSS and after death of his father, his old age mother is getting family pension for the survival of their family.

In the instant case, the applicant did not surrender the RC and permit to this Department and therefore liable for penalty. As the permit of the vehicle got expired on 21.07.2015 and to renew it, the applicant has to pay a delay fine of Rs.14/- per day as fixed by STA. However, the late fine for the period 01.02.2020 to 31.10.2021 (COVID period) shall not apply as per Order No.8196 dated 10.01.2023.

Accordingly, the late fine applicable after exempting for the period 01.02.2020 to 31.10.2021 is worked out as under:

STA examined the case and observed that the applicant is a local unemployed youth of this UT and the daily earning from his autorickshaw is the only source of income for survival of his family. The applicant has already spent good amount on his treatment in private hospitals at Chennai and considering his financial condition, STA decided to give relaxation in the fine amount and impose penalty of Rs.4000/- on account of the delay in renewal of permit.

d. Exemption from production of Islander Card for calibration of fare meter

Smti Simran Bibi, R/o Shadipur, Port Blair vide her letter dated 27.10.2023 for grant of permission for calibration of fare meter without producing Islander card / Local Certificate. Recently STA has mandated the personal appearing and production of Islander Card / Local certificate for calibration of fare meter.

STA was apprised that Smti Simran Bibi, R/o Shadipur, Port Blair had applied for issuance of NOC to ply Autorickshaw on 02.12.2019. On scrutiny of documents it was found that she does not possess Islander Card which is one of the mandatory document/criteria Issued by STA in its meeting held on 27.03.2018. She has furnished PBMC paid parking area as parking space. Due to non fulfillment of eligibility criteria, her case was rejected and informed vide Letter No. 686 dt 10/10/2019. Smti Simran Bibi again placed a request on 10.01.2020 stating her pathetic condition and requested to consider her case on humanitarian ground for issue of NOC for Autorickshaw (Ref Para 22-24/n). Considering her financial condition and being a female autorickshaw driver, her request was considered by chairman (STA) as special case exempting the mandatory requirements of Local Certificate. Accordingly NOC was issued to her on 17.03.2020.

The permit for her Autorickshaw bearing Regn. No.AN01Q3660 to ply in route of South Andaman was issued to Smti Simran Bibi, R/o Nayagaon, Port Blair on 01.04.2022 with validity for from 01.04.2022 to 31.03.2027.

STA observed that the NOC / permit to Smti Simran Bibi for purchase of passenger Autorickshaw bearing Regn.No.AN01Q3660 was allowed by STA 'as an exception' on compassionate ground exempting the mandatory requirements of Local Certificate. Hence STA decided to consider the request the rerquest of Smti Simran Bibi and directed Secretary, STA to issue letter to Legal Metrology Department for calibration of fare meter of autorickshaw bearing Regn.No.AN01Q3660 without producing Islander card / Local Certificate.

1.4 PUBLIC CARRIER PERMITS (GOODS PERMIT)

a. ISSUE OF NOC/ PERMIT FOR PUBLIC CARRIER

STA examined **33 applications** received for grant of NOC to ply the vehicle as Public Carrier (Goods Permit) for the jurisdiction of North, Middle & South Andaman. As the applicants fulfil the guidelines prescribed for grant of NOC/ Permit of Contract Carriage Permits, **STA approved all the 33 applications in the undermentioned TABLE: 15 subject to the condition that the vehicles should be BS-VI compliant.**

Since the above application is for issuance of NOC/ permits to ply in Swaraj Dweep for fossil fuel driven vehicle, STA decided to defer the case till next meeting.

- b. **Shri. Rashid Yusoof**, S/o. of Late Yusoof Ismail Malim, R/o. Kamorta vide his application dated 16.10.2023 requested to extend the validity of the NOC for purchase of Mahindra Bolero Camper (Goods Vehicle).

In this regard, on scrutiny, it was observed that the applicant had applied for grant of NOC for purchase of Mahindra Bolero Camper on 20.02.2020 to ply in all routes of Nancowry Islands. The firm stated that they have been awarded a new project by NHIDCL and considering the current and future requirements to execute the NH works. Hence the firm has requested to re-register the vehicle no. TN68BD4942 in the RTO, Port Blair. The firm has submitted the copy of contract dated 12.08.2022 executed with NHIDCL.

In this connection, it is to apprise that the STA in its meeting held on 24.12.2021 had decided not to allow any registered vehicle into this UT which is not of BS-VI compliant. However, in the instant case, the vehicle under consideration was brought in January 2020 i.e. prior to the decision of STA in this regard.

The case was placed in the STA meeting held on 30.08.2023 wherein **STA after examination of the case, decided to get the status of all the vehicles of the firm plying in the UT and place the same in the next STA meeting to take a decision on the request of the firm to re-register and issue permit to their mainland brought vehicle bearing registration number TN68BD4942.**

Accordingly, the firm vide their letter dated 13.10.2023 has furnished the status of all their vehicles plying in the UT which are detailed as under:

As per the above report, the firm had brought 08 commercial vehicles, out of which 03 vehicles have sent back and 04 vehicles got registered and obtained permit from STA. For the remaining 01 vehicle, the firm requested to issue permit.

STA decided that the vehicle bearing Regn. No.TN69BD4942 may be got inspected thoroughly by the Committee for its road worthiness and resubmit the case with the road worthiness report in the next STA meeting.

f. Issue of NOC/Permit for Trailers

- M/s Sakthi Shipping Pvt. Ltd. has applied for NOC along with all the required documents for purchase of 40 Feet Trailer-Tata Signa 4025.S BSVI to ply in all routes of South Andaman. The firm has submitted that the Trailer is required for transportation of heavy goods and machineries. Accordingly, NOC has been applied to ply in all routes of South Andaman with its limited operation during night timing between 09.00 PM to 05.00 AM or the timing as preferred by STA.
- M/s Sakthi Shipping Pvt. Ltd. has applied for NOC along with all the required documents for purchase of 24 Feet Trailer-Tata Signa 2823.T BSVI(04 Nos.) to ply in all routes of South Andaman. The firm has submitted that the Trailer is required for transportation of heavy goods and machineries. Accordingly, NOC has been applied to ply in all routes of South Andaman with its limited operation during night timing between 09.00 PM to 05.00 AM or the timing as preferred by STA.

Being trailers, STA decided to refer the both the above two cases of M/s Sakthi Shipping Pvt. Ltd. to DySP (Traffic) for examination and to furnish report before the next STA meeting meeting for further consideration.

2. CONSIDERATION OF RESIDENT CERTIFICATE INSTEAD OF ISLANDER IDENTITY CARD/LOCAL CERTIFIACTE FOR GRANT OF NOC FOR PLYING AUTORICKSHAW -PCC

Applications have been received by the STA wherein, the applicants who do not possess the Local Certificates/ Islander Identity Cards have requested to consider the Resident Certificates and Election Identity Cards issued in their name as they have been living in the Islands for many years instead of Local Certificates.

In the above context, it is to submit that in order to control the increasing number of vehicular traffic and to streamline the auto rickshaw operation in the town, STA in its

meeting held on 23.04.2007 mandated the following conditions mentioned below for issuance of NOC to ply an auto rickshaw:

1. The permit will be issued only to the local unemployed people below 40 years of age.
2. Vehicle should be owned by the applicant.
3. Should submit his or her own driving license.
4. Should submit **Islander Identity Card or Local Certificate**.
5. However the condition of driving license may be exempted in case of physically handicapped and Tsunami affected people.
6. Not more than one permit to be issued to one person.

As such, the NOC/ Permits for auto-rickshaws are only granted to the applicants who possess Islander Identity Card or Local Certificate in their name.

It is seen that applications have been received by the STA wherein, the applicants who do not possess the Local Certificates or Islander Identity Cards have requested to consider the Resident Certificates issued in their name by the Tehsildar in place of Local Certificates/ Islander Identity Cards as they have been living in the Islands for many years instead of Local Certificates. In some cases, it is mentioned in the Resident Certificate that the applicant has been staying in the UT for 30 years.

In this regard, the Deputy Commissioner, South Andaman has been requested vide this Directorate's 'Note' dated 25.07.2023 and letter dated 09.10.2023, to clarify that whether the applicant possessing Resident Certificate issued by the District Administration can be treated equivalent to Islander Identity Card or Local Certificate. The clarification from District Administration has not been received so far.

STA decided that SDM (South Andaman) may take up the matter with Deputy Commissioner and clarify the matter without any further delay to dispose off the applications wherein the applicants, possessing Resident Certificate in place of Local Certificate / Islander Card, have requested to consider permit for autorikshaw.

3. VIOLATION OF PERMITS

- i. It is to apprise that in the matter of unauthorized aggregation for passenger Autorickshaw, STA in its meeting dated 09.06.2023 had directed to Traffic Police to conduct enforcement drive against any kind of violation of permit conditions and submit fortnightly report to STA. Accordingly, DySP conducted enforcement drive and stated in the letter that during the enforcement drive, the above vehicles (Autorikshaws) were found violating the condition of permits as the vehicles were not driven by the person whose name is entered in the permit. The details are as under:

Since all the above mentioned 54 permit holders have violated the permit conditions of Autorickshaws, Show Cause Notices under Section 86 of MV Act, 1988 were issued to all the 54 permit holders dated 20.10.2023 giving 07 days time to represent as to why their autorickshaw permits should not be suspended as decided by STA in its meeting held on 30.08.2023. Out of the 54 permit holders, 03 persons have responded and their submissions are briefed as under:

a. Shri. Fagu Prasad, appearing at Sl.No.16 of the above table stated that he was suffering from some health issues on 07.07.2023 and took rest after taking medicine from private medical shop and he allowed his brother Shri.Munna Verma possessing DL.No.AN01 20130000153 to drive his autorickshaw bearing Regn. No.AN01E-4993 on the said day. He apologised for the incident that led to violation of permit condition and assured that such incident will not repeat under any circumstances in the future.

b. Shri. Mohasin Mondal, appearing at Sl.No.19 of the above table stated that on 08.07.2023 one of his friend (Autorickshaw driver) took his autorickshaw in medical emergency of his father. He added that the autorickshaw bearing Regn.No. AN01F-8304 is driven by himself and the incident that took place on 08.07.2023 in which other person was driving, happened due to some unabovidable circumstances and in medical emergency only for one time. The permit holder requested to consider the matter sympathetically as the said autorickshaw is only source of income for his livelihood.

c. Smti. Masudan Bibi, appearing at Sl.No. 40 of the above table stated that on 19.07.2023 that her son was the one riding the vehicle for his personal purpose as the person whose driving licnese was submitted for driving of the said vehicle has got job. She further stated that the said vehicle is being ride by her own son named Shri.Mohammed Noor Alam for their family livelihood. The permit holder requested to consider the matter sympathetically as the said autorickshaw is only source of income for his livelihood.

STA was further apprised that some more replies have been received against the show cause notices.

STA, after examining the cases, decided the following:

- Secy, STA to check each case to verify whether the permit was issued prior to/ after framing of guidelines / additional conditions in the year 2007.**

- b. In case, the permit has been issued prior to framing of guidelines / additional conditions, the permit holder shall be asked to furnish details of driver to be entered in the permit.
- c. In case, the permit has been issued after the date of framing guidelines / additional conditions, a stringent warning may be issued and the permit holder shall be asked to furnish details of driver to be entered in the permit.
- d. In case, the permit has been issued after the date of framing guidelines / additional conditions, and the permit holder did not respond to the show cause notice, permit may be suspended for 02 months with the direction to the permit holder to make representation, against the suspension order if he wishes to. The permit holder may be further asked to furnish details of driver to enter in the permit.
- e. Traffic Police to enforce the suspension order with immediate effect.
- ii. DySP (Traffic) vide letter dt. 20.10.2023 has furnished the list of 39 Passenger Autorickshaw in which the vehicles were found to be driven by other person whose name is not entered in the permit thus violating the permit condition of passenger Autorickshaw. The Details are as under:

STA was further apprised that 248 similar cases have been received from DySP (Traffic) on 01.11.2023. **STA, after examining all the cases, decided the following:**

- Secy, STA to check each case to verify whether the permit was issued prior to/ after framing of guidelines / additional conditions in the year 2007.**
- In case, the permit has been issued prior to framing of guidelines / additional conditions, the permit holder may be asked to furnish details of driver to enter in the permit.**
- In case, the permit has been issued after the date of framing guidelines / additional conditions, 'Show cause notice' may be issued and put up such cases in the next STA meeting for taking decision.**

4. MATTER RELATED TO SUSPENSION OF PERMITS / CANCELLATION OF NOCS OF AUTORICKSHAW (PCC)

- Suspension of Permits & cancellation of NOCs as per the decision taken by STA in its meeting 09.06.2023:**

In compliance with the decision of STA in its meeting held on 09.06.2023 in the matter of plying multiple autorickshaws by single person after obtaining permits in the name of different eligible persons, STA suspended 27 permits passenger Autorickshaw and cancelled 07 NOCs. The individuals were given opportunity to make representation before STA with proper evidence that the vehicle is self financed and operated by him / her and that the vehicle is a single vehicle which is owned by them in these category, within a period of 15 days from the date of issuance of the individual orders.

Aggrieved by the decision of STA for **suspension of 27 permits**, 21 permit holders filed writ petitions before Hon'ble High Court at Calcutta in which the Hon'ble Court set aside all the 21 suspension orders with the direction to STA to give the petitioners an opportunity to hear in person and consider or reject their representations in accordance of law.

Complying with the above direction, all the petitioners were heard in person and given opportunity and after careful examination of records, submissions of petitioners in their representations dated 07.08.2023, 08.08.2023 & 09.08.2023, oral & material evidences produced by individual petitioners during their personal hearing on 16.08.2023, evidence furnished by the petitioners against the final opportunity vide orders dated 18.08.2023 and consideration of all the facts & circumstances of the case as per the provisions under Section 86 of MV Act, 1988, the brief of individual 21 cases were placed in the STA meeting held on 30.08.2023. STA in the said meeting examined all the 21 cases carefully and decided to cancel 07 permits with immediate effect as the allegation of misusing the guidelines

prescribed by STA for issuance of autorickshaw permit and given it to unauthorised person for driving the vehicle was clearly established.

To take appropriate decision in respect of the remaining 14 cases, STA decided to obtain additional information from the dealer, Financier and Traffic Police on each case.

The information / report received from Financier, Dealer and Traffic Police was placed before STA and the decision taken by STA in each case is detailed in the **Table:23** below:

STA was apprised that Smti Jansi Rani had been issued route permit vide No. P.St.C STA/TPT/SC/2018/104 dated 18/01/2018 for her Stage Carriage bus bearing registration number AN01/M-8811 to ply the said vehicle in the route **Quarry Basthi Carbyn Chowk to GB Pant Hospital via Aberdeen Bazaar, Goal Ghar, BathuBasthi, Austinabad.**

Smti. Jansi Rani vide her application dated 06.09.2021 requested for change of route from 'Quarry Basthi Carbyn Chowk to GB Pant Hospital via Austinabad, BathuBasthi, Goal Ghar, Aberdeen Bazaar and vice versa to Brookshabad Tsunami Shelter I' to 'Bus Stand via Carbyn Chowk, Austinabad, BathuBasthi, Goal Ghar and vice versa'. The request was not considered by STA on the comments of TO, BT and AD(T) that for the residents of Quarry Basthi, it was the only bus which ply upto Quarry Basthi. Accordingly, the decision of STA was communicated to the permit holder on 27/09/2021.

Later, Smti. Jhansi Rani vide her application dated 18.03.2022, again made the same request for change of route and her request of the permit holder was referred to the Committee constituted vide Order No. I/2359/2022 dated 03.11.2022 and the Committee recommended to consider the request of permit holder stating that **"functioning of Quarry at Quarry Basthi, Carbyn Chowk has been reduced to some extent due to which, post COVID population has been shifted from there which has resulted less occupancy in bus"**. On the basis of the recommendation of the Committee, STA in its meeting held on 02.12.2022, considered the request of the permit holder accordingly, change of route entered in the permit and issued on 03.04.2023.

On 03.05.2023, a joint representation has been received from the residents of the Quarry Road raising concern on the decision of STA on route changes for stage carriage bus AN01/M-8811. The residents have stated that no buses are plying in the Quarry Basti route and they are forced to walk about 01 kilometer till Kamraj English Medium School, Brookshabad or upto 02 kilometer till Carbyn Junction to commute in a bus for travelling. They demanded to change the route of the stage carriage bus (AN01/M-8811) to their previous route along with additional bus service in the said route.

The joint representation was placed in the STA meeting held on 09.06.2023 wherein STA was apprised that AN01M-8811 was the only bus providing public transport in the said route i.e Quarry Basthi, Brookshabad and the local residents have demanded for plying of the said Stage Carriage bus in the route. Therefore, STA decided to review its decision on the change of route in respect of the Stage Carriage bus no. AN01/M-8811 which was allowed vide Point No. 8.1 of the STA meeting dated 02/12/2022 and decided that the bus shall ply in its original route i.e. "Quarry Basthi

Carbyn Chowk to GB Pant Hospital via Bus Stand, Goalghar, Bathu Basthi, and Carbyn Chowk”.

Accordingly, the decision of STA was communicated to the permit holder through speed post on 23.06.2023 with the request to surrender permit to make entry in the permit. Since the permit holder did not surrender the permit, a Show cause Notice was issued on 15/09/2023 for not obeying the direction of STA which is a violation of permit conditions under section 68 & 72 [2 (i) & (iv)] of MV Act 1988 and which is liable for suspension or cancellation of permit.

Aggrieved with the decision of the STA, the permit holder approached the Hon'ble Court in which the Hon'ble Court has passed an order on 21.09.2023 stating that *“the minutes of the State Transport Authority meeting held on 09.06.2023 does not reveal that any opportunity was given to the petitioner before cancelling the route permitted on a conscious decision before cancelling the route permitted on a conscious decision taken in the meeting held on 2nd December, 2022. Even there was a dissent amongst the local residents and, therefore, the reason was accepting the demand of the local residents is a question to be gone into. In view of the fact that the decision has been taken without adhering the principles of audi alteram partem, therefore, the said decision cannot be sustained. The decision of the cancelling the route allowed by the authority in a meeting held on 09th June, 2023 is hereby quashed and set aside. The State Transport Authority is directed to give an opportunity of hearing to the petitioner before it proceed to take a decision and it goes without saying that the petitioner shall be provided with all the documents placed before the said State Transport Authority and must be afforded an opportunity to deal with the same.”*

Complying with the direction of the Hon'ble Court, the permit holder was given opportunity to appear in person on 31.10.2023 before the Chairman, STA. During the personal hearing, the authorised representative of permit holder of stage carriage bus bearing Regn. No. AN01M8811 stated that he had operated the bus for last 05 years on the initial route i.e. Quarry Basthi and no passenger were availed the bus from Quarry Basthi which lead to huge financial loss. He further stated the so called representation from the Quarry basthi village is a letter with fake signatures and fabricated by his rivalry bus owners from the same route. The permit owner was informed that his request for route permit from Bus Terminus to Quarry basthi Carbyn Scove was considered initially only on the ground that no stage carriage bus was available connecting Quarry Basthi to other place. Though as of now there is no activities of quarry at that place due to which passenger movement are very less but there are few families residing at quarry Bsthi and in view of the representation, it is necessary to provide bus servicen there. Considering the financial loss of the permit holder and the requirement of bus service upto Quarry Basthi, Chairman (STA) decided that the Bus may be operated in the existing route i.e. Bus Terminus to Tsunami Shelter Camp-I but all the trips should be passing through quarry Basthi by which only 1 Km distance would be added in the route length. To cover the additional route length, adequate time may also be given in time table. The permit holder agreed to the decision of Chairman (STA). The decision taken during the personal hearing is placed for ratification by STA.

STA ratified the decision of the Secretary (Transport) / chairman (STA) for change of route in respect of the stage carriage bus bearing Regn. No. AN01M8811.

5. ISSUE OF NOC FOR TRANSFER OF COMMERCIAL VEHICLES PURCHASED FROM FINANCIER IN AUCTION PROCESS

- a. In the undermentioned case, the vehicle was registered under Transport Category with Hypothecation to Financier. The vehicle owner became defaulter due to non-payment of EMIs of loan. As such, the Financier reposed the vehicle and sold the vehicle to the highest bidders through auction process. As per the request of Financier, the case has been initiated to transfer the vehicle in the name of financier after giving an opportunity to the registered owner for submitting his representation within 07 days as per Rule 51 (5) and 61 (3) of CMVR, 1989. Being Transport Category vehicles, NOC from STA would be required for

transferring the vehicles. Hence, the purchaser has requested to issue NOC from STA for transfer of the vehicle in their name as detailed under:

The applicant applied for NOC for purchase of 06 petrol driven two wheelers to obtain permits and to include in his license under RAMS. The case was placed in STA Meeting held on 13.02.2023 in which STA approved 05 fossil fuel two wheelers and 01 Electric two wheeler. Accordingly, the NOC for purchase of 05 fossil fuel and 01 Electric two wheeler was issued to the applicant.

Against the NOC, the applicant purchased 05 fossil fuel driven two wheelers and obtained permits. Now, vide his letter dt 19/10/2023 he has requested to include these 05 two wheelers in his license under RAMS.

STA approved the request of the applicant to include 05 more two wheelers in his existing license.

16. APPLICATIONS FOR REPLACEMENT WITH NEW TWO WHEELER AFTER CONDEMNATION OF THE EXISTING VEHICLE

Shri. Sushil Kumar Kerketta has made an application dated 18.09.2023 stating that he has 24 two wheelers (moped) for hiring under RAMS License. Out of 24 mopeds, 08 two wheelers are haing fitness certificate, 08 two wheelers are presently under repair in workshop and the condition of the remaining 08 two wheelers are beyond economical and he requested to grant permission for condemnation of these 08 two wheelers (AN01/E-2493, AN01/E-2499, AN01/F-4935, AN01/G-3895, AN01/H-8753, AN01/H-9029, AN01/H-8761 & AN01/H-8774).

In this regard it is to apprised that the applicant has been issued with the license No. **MT/1-21/STA LICENSE/2013/3949 dated 13.09.2013** (which expired on 04.09.2018) under RAMS with the authorization for renting 24 two wheelers. The applicant vide his application dt 18.07.2022 requested for conversion of his two wheeler bearing Regn.No. AN01H-8766 from Transport to Non Transport for personal use. While examining his requested it was observed that the RAMS License in which the said vehicle was included, has already been expired from 04.09.2018. Accordingly a SCN was issued to the applicant and inresponse, the applicant represented that he had tried to condemn all the 24 vehicles but due to lockdown, he couldnot able to condemn the vehicle and at the same time the License under RAMS and the fitness certificate were also not renew due to his financial and health issues.

His case was placed in the STA meeting held on 10.04.2023 in which the STA decided to consider the case of renewal of License under RAMS by imposing penaty @Rs.1000/- per vehicle per year for delay in renewal of License. As regards to the renewal of permits STA decided to impose penalty as per the order No. I/8619/2023 dt 12.01.2023. Accordingly, the applicant was informed to submit valid fitness certificates of the vehicles so as enable the STA Section to process his case for renewal of permit and thereafter renewal of License by imposing the penalty as decided by STA.

Now the applicant vide his letter dt 18.09.2023 requested to grant permission for condemnation of his 08 two wheelers. He is intending to purchase new vehicles against these the 08 old vehicles.

Now, Smti. Sita Laxmi Mandal has requested to renew and transfer the permit of one more two wheeler bearing Regn.No. AN01M-7325 which is presently registered in the name of deceased husband.

On scrutiny of the records it has been observed that permits for altogether 14 two wheelers were issued in favour of Late Nibir Mandal out of which 13 two wheelers have already been transferred in the name of Smti. Sita Laxmi Mandal. The fitness of the vehicle bearing Regn.No. AN01M-7325 is valid up to 08.02.2024.

At the time of making request for transferring the 13 vehicles and issue of License thereof, the applicant did not disclose the matter of 14th two wheeler bearing registration No. **AN01M/7325** which also registered in her deceased husband's name. The applicant stated that after sudden demise of her husband, the business was looked after by the brother of her deceased husband and she was not at all aware of the fact that her deceased husband was having 14 two wheelers.

STA approved the request of the applicant.

The applicant submitted that due to COVID-19 she couldn't apply for license for renting two wheelers. Now, she requested to grant license for two wheelers.

It appears that Smti. Bijali Sikder has **rented the motorcycles without having valid license** and thereby violation of the provision contained under rent-a-motorcycle scheme 1997/MV Act.

Though, there is **no penalty clause** exists in the Scheme for penal action for renting motorcycle without having valid license but the STA can suspend the permits of the vehicles or can impose mutually agreed penalty as the vehicles were rented without License under the scheme.

In a similar case, STA in its meeting held on 13.02.2023, considered the case of Shri Waseem Ramzan for issuance of License under RAMS by imposing penalty amount @rs.1000/- per vehicle per year.

STA approved the request of the applicant by imposing penalty amount of Rs. 1000/- per vehicle per year.

20. TRANSFER OF PERMIT OF 02 OLD TWO WHEELER (BS IV VEHICLES) TO NEW 02 NOS. TWO WHEELER BSVI VEHICLES

It is further to apprise that the applicant vide letter dated 14/12/2022 had applied for issue NOC of 10 Nos Fossil fuel two wheelers. On his request, STA in its meeting held on 13/02/2023, granted NOC for purchase of 05 Fossil Fuel and 05 Electric two wheelers. Against the NOC, the applicant has purchased one fossil fuel driven two wheeler and obtained permit.

Moreover, Shri A. Santhosh Kumar vide his two applications dated 17.10.2023 has also requested to issue NOC for purchase of 05 Electric Scooter for Swaraj dweep and 05 electric scooters for Shaheed Dweep for obtaining permits for renting under RAMS. The applicant did not submit any supporting documents along with the request letter.

STA rejected the request of the applicant for purchase of 02 BS VI fossil fuel two wheelers and advised to apply for electric two wheelers.

As regards to the request of applicant for purchase of 05 electric two wheelers, STA decided to obtain all the requisite documents from the applicant for obtaining NOC for purchase of e-Scooters for renting under RAMS at Swaraj Dweep.

21. ISSUE OF NOC FOR ELECTRIC TWO WHEELER VEHICLES UNDER RAMS.

Shri M Nagarajan, R/o Aberdeen Bazar, Port Blair vide his two applications dated 17.10.2023 has requested to issue NOC for purchase of 05 Electric Scooter for Swaraj dweep and 05 electric scooters for Shaheed Dweep for obtaining permits for renting under RAMS. The applicant did not submit any supporting documents along with the request letter.

STA decided to obtain all the requisite documents from the applicant for obtaining NOC for purchase of e-Scooters for renting under RAMS .

22. CASES OF SWARAJ DWEET & SHAHEED DWEET

A. CONSIDERATION OF CASES FOR GRANT OF PERMITS FOR SWARAJ DWEET AND SHAHEED DWEET

i. Considering the recommendations in the study report received from DBRAIT and to meet the immediate requirement of commercial vehicles for the tourism activities of the two Islands of Swaraj Dweep and Shaheed Dweep, the STA in its meeting held on 30.08.2023, in the first instance, decided to grant NOC/ permit in respect of M2 and M3 category of vehicles.

Based on the above decision, 15 applications for M2 category vehicles pertaining to Swaraj Dweep and 09 applications pertaining to Shaheed Dweep had been taken for consideration for grant of NOC/ Permit for different categories of vehicles to ply in Swaraj Dweep and Shaheed Dweep respectively in the meeting of the STA held on 30.08.2023. However, before granting NOCs, STA decided to obtain willingness/ requirement of the applicants as on date and to place the same in the next meeting as the applications in these cases had been made 1-5 years back.

Complying with the above decision, letters were issued to all the 24 applicants with the request to furnish the willingness/ requirement as on date for the NOC to purchase different M2 categories of vehicles.

Accordingly, 10 applicants pertaining to Swaraj Dweep and 06 applicants pertaining to Shaheed Dweep have furnished their willingness/ requirement as on date. The details are as under:


