c. Shaheed Dweep-Two Wheeler

Requests have been received from Shri Uttam Kr Das and Shri Ashit Baran Roy of Shaheed Dweep was for issuance of NOC for operating two wheelers (Fossil fuels) under 'Rent-a-Motorcycle Scheme'. While analyzing the vehicle dimensions and the route proposed, STA decided to forward the case to Traffic Police to obtain thier views & comments on the feasibility of the route and timing proposed by the applicant. The views may be submitted by 31.10.2022 to place the same before STA in its next meeting scheduled on 14.11.2022.

V. Issue of NOC for Stage Carriage Permit

STA was appraised that Ms. V Anita has applied for issue of NOC to purchase of Stage carriage bus for any of the below mentioned routes:

- (i) Chatham to Garacharma; or
- (ii) Chatham to Calicut; or
- (iii) Chatham to Carbyn Chowk

Ju

As per the request, the Assistant Director (T) has analyzed and recommended to allot the route 'Chatham to Carbyn Chowk via Shadipur'.

It has come to notice of the STA that there are many routes and timings in which buses are required for the convenience of the local citizens. Due to non-availability of Buses in some of the routes, general public has to walk long distances to reach to the nearest bus stands to board the buses. STA further observed that there are many routes in which sufficient buses at required frequency are not available. In view of the above, STA decided to defer the case till the next STA meeting with the direction to constitute a Committee comprising officuials from Police & Transport. The Committee shall examine the present demands of stage carriage buses in Port Blair and recommend the routes in which buses are required and subject to the decision of STA, the list shall be published for the general citizens allowing the applicant to apply for NOC for Stage Carriage permit for such routes.

Agenda Point No. 2

Transfer of Permit:

STA was informed that the cases that **36 vehicle owners** have requested for transfer of permits from one owner to another owner and there is no change in the jurisdiction of permits already issued. As it is permitted under Section 82 of MV Act, **STA approved the transfer of permit in respect of 36 applications without change in the Route/Jurisdiction of permit.** List of applications is given in table-11 below:

STA was appraised that **Shri. P Mukunda Rao**, the NOC holder of Autorickshaw to ply in all routes of South Andaman has applied for change of vehicle from Autorickshaw (PCC) to Cargo Auto (PC). The NOC was issued on 20.09.2022 which is valid upto 15.08.2023.

The conditions prescribed by STA for the both the classs of permits i.e. PCC and PC are same except the additional requirement of own driving License in the case of Autorickshaw (PCC). The applicant fullfills all the condition prescribed by STA for obtaining NOC / Permit for a cargo Auto (PC permit) and found to be eligible.

Hence, STA approved the case of Shri. P Mukunda Rao for change of vehicle from Auto-rickshaw (PCC) to Cargo Auto (PC).

Agenda Point No. 9

Change of class of vehicle and route:

- i. STA was appraised that **Smti. Rajwathi** applied for change of vehicle in the NOC from Mahindra Pickup to Tata 1918 Truck. The applicant had applied for NOC on 19.10.2020 for Mahindra Pickup and the same was approved in the STA meeting held on 15.04.2021. Accordingly, a letter to the applicant for submission of security deposit was issued on 06.09.2021. However, the applicant did not submit the security deposit yet. After a span of 01 year, she requested to change the vehicle in the existing application. **Hence, STA did not consider her request and directed to obtain fresh request from NOC from the applicant.**
- vehicle & route from Cargo Auto (South Andaman Route) to Tata Yodha 1700 (Pick up- BS-VI) (NMS Route). The applicant has applied for NOC on 07/07/2022 for Cargo Auto (South Andaman Route) and the same was approved in the STA meeting held on 03/08/2022. Accordingly, Shri Liton Mondal was requested vide letter dated 06.08.2022 to deposit security deposit but he did not furnish the Security Deposit yet. Now, he has

requested to change the vehicle and route in the existing application to Tata Yodha 1700 (Pick up- BS-VI) (NMS Route). Since, the applicant did not furnish the Security Deposit yet, STA has decided not to consider the request.

The applicant had applied for NOC on 07.06.2022 for Scorpio (CC) and the same was approved in the STA meeting held on 03/08/2022. Accordingly, the applicant was requested vide letter dated 01.09.2022 to furnish Security Deposit which has not been furnished so far. **Since, the applicant did not furnish the Security Deposit yet, STA has decided not to consider the request.**

STA was apprised that 04 local unemployed residents of the UT have applied for NOC for obtaining different categories of permits for their livelihood by depositing Security Deposits to the Department. Due to various issues i.e. financial crisis, non-availability of intended vehicles etc., they are unable to purchase the vehicle and requested to release the security Deposits. **STA decides** to release the Security Deposits of all the 04 applicants. Delay in submission of Challan fee for obtaining New Permit:-

i. STA was appraised that M/s TSG Hotels and Resorts applied for issuance of permit on 25.07.2017 to register **Bolero Pickup BS IV** for

- Pec

Public Carrier permit to ply in all routes of Swaraj Dweep. The case was appoved in the STA meeting held on 22.11.2017. Meanwhile, the firm had purchased the vehicle Bolero Pickup BSIV bearing Registration No. ANO1/M 2109 and got it registered on 05.06.2017. After obtaining approval, the vehicle owner was informed over phone to pay requisite fee of Rs. 1510/- towards issuance of permit. But the applicant failed to remit the permit fees at that time. Now the firm intends to pay the permit fee with the request to issue permit for the above mentioned vehicle. From the above, it is clear that the firm was plying the vehicle bearing Regn.No. AN 01/M 2109 without permit since its registration on 05.06.2017 thus violating Section 66 & 79 of MV Act 1988. In view of the above, STA decided to defer the case for the next meeting and in the mean time, the report / recommendation of Committee on quantum of amount for various kind of violations of permit may got examined on circulation by the members of STA to take a uniform decision to impose penalties in all such cases.

Shri N Krishna Rao has applied for issuance of permit for the already ii. registered Transport vehicle bearing registration No. AN 6552 to ply in all route in all routes of Little Andaman. The applicant has applied for transfer of ownership along with renewal of permit on 01.01.2020. during the time of submission of application he has submitted the original permit alongwith with other documents. The vehicle was registered in his name on 24.12.2021 through transfer of ownership. Later he didn't apply for issue of permit for the said vehicle. The registered owner has applied for issue of permit on 29.07.2022. The permit of the above vehicle is valid upto 22.05.2023. From the above, it is clear that applicant was plying the vehicle without permit from 24.12.2021 thus violating Section 66 & 79 of MV Act 1988. STA decided to defer the case for the next meeting and in the mean time, the report / recommendation of Committee on quantum of amount for various kind of violations of permit may got examined on circulation by the members of STA to take a uniform decision to impose penalties in all such cases.

Agenda Point No. 12

Issue of permit for already registered non BS-VI complaint vehicles.

i. STA was appraised that **M/s Murugan Store** has applied for issuance of permit 27.09.2022 for their already registered commercial vehicle bearing Regn. No. **AN 01 P 4640** (Tata LPT 1109 BS IV) which is of BS-IV complaint registered in the RTO, Port Blair on 27.11.2018. The firm obtained temporary permits in two occasions from 12/12/2018 to 12/02/2019 (02)

months) and 07/03/2019 to 06/04/2019 (01 month). The firm did not apply for regular permit at that time. The firm has plied the vehicle for more than 03 years without permit violating Section 86 of MV Act.

STA decided to defer the case for the next meeting and in the mean time, the report / recommendation of Committee on quantum of amount for various kind of violations of permit may got examined on circulation by the members of STA to take a uniform decision to impose penalties in all such cases.

- ii. STA was appraised that **M/s Essentials** has applied for issuance of permit 01.08.2022 for the vehicle bearing registration No. **ANO1/D-3639** (Tata Ace-Load Body) which is of BS II complaint registered in the RTO, Port Blair on 05.12.2006. The vehicle was initially registered in Transport Category. Later, the vehicle has been converted to Non-Transport category and later extended its registration validity upto 17/01/2027 at the time of renewal of registration. **STA has deferred the request of M/s Essentials in the next meeting for further decision.**
 - iii. STA was appraised that **Shri. Bhaskar Bagchi** has applied for PC Permit for his already registered vehicle bearing Regn. No. **AN 01 N 6745** (Maurti Super Carry BS IV) which is of BS-IV complaint vehicle registered in the RTO, Port Blair on 16.11.2018. The vehicle has been registered in Transport Category. The vehicle owner did not apply for route permit at the time of his registration. The request of the applicant was placed along with other cases of NOC/Permit in the STA meeting held on 03/08/2022 and got approved. The matter of making late apply for permit was not brought into the knowledge of STA. It appears that the applicant has plied the vehicle without permit for more than 03 years violating Section 86 of the MV Act.

STA decided to defer the case for the next meeting and in the mean time, the report / recommendation of Committee on quantum of amount for various kind of violations of permit may got examined on circulation by the members of STA to take a uniform decision to impose penalties in all such cases.

iv. STA was appraised that M/s O P Kandoi and Co. (P) Ltd. has applied for PC Permit for his already registered vehicle bearing Regn. No. AN O1 E 6042 (Bolero LX 4WD) which is of BS-II complaint registered in the RTO, Port Blair on 17.06.2009. The vehicle has been registered in Non Transport Category. The applicant has requested for issue of permit for all routes in NMS. The said vehicle is a goods carrier and it appears that the applicant has plied the vehicle without permit for more than 13 years violating Section 86 of the MV Act.

STA decided to defer the case for the next meeting and in the mean time, the report / recommendation of Committee on quantum of amount for various kind of violations of permit may got examined on circulation by the members of STA to take a uniform decision to impose penalties in all such cases.

- v. STA was appraised that **Shri. Bishnu Mondal** has applied for CC Permit along with required documents on 26.09.2022 for his already registered vehicle bearing Regn. No. **AN 01 P 6498** (Maruti Ertiga) which is of BS-IV complaint registered in the RTO, Port Blair on 29.11.2019. The vehicle has been registered in Non Transport Category. The applicant has requested for issue of permit for all routes in NMS. As, STA has mandated the condition of BS-VI for NOC / permit and in the instant case, the applicant requested for NOC for conversion of already registered Non-Transport vehicle which of BS-IV compliant, **STA did not consider the request of the applicant.**
- vi. STA was appraised that **Shri. D Paul Raj** has applied along with required documents for issuance of CC permit on 21.09.2022 for the route NMS for their already registered vehicle bearing Regn. No. **AN 01 M 1714** (Bolero Plus) which is of BS-IV complaint registered in the RTO, Port Blair on 17.05.2017. The applicant obtained NOC for purchasing the new BS-VI vehicle on 04.05.2022, but he has now applied for permit for his already registered BS-IV compliant vehicle bearing registration No. AN 01 M 1714. As, STA has mandated the condition of BS-VI for NOC / permit and in the instant case, the applicant requested for NOC for conversion of already registered Non-Transport vehicle which of BS-IV compliant, **STA did not consider the request of applicant.**
- vii. STA was appraised that **Shri. G Kalidas** has applied along with required documents for issuance of NOC on 26.07.2022 for the route South Andaman for their already registered vehicle bearing Regn. No. **AN 01 K3004** (Maruti Omni) which is of BS-IV complaint registered in the RTO, Port Blair on 26.05.2015. The vehicle is presently registered in Non-Transport Category. As, STA has mandated the condition of BS-VI for NOC / permit and in the instant case, the applicant requested for NOC for conversion of already registered Non-Transport vehicle which of BS-IV complian, **STA did not consider the request of the applicant.**
- viii. STA was appraised that **Shri. Probin Kumar Das** has obtained NOC dated 03.03.2022 for purchase of new vehicle Ertiga VXI (CC) to ply in all routes of NMS with the validity upto 16.01.2023. Now he has represented that Maruti Ertiga is not available for purchase in the market and purchased a Non-Transport Maruti Ertiga bearing Regn. No. **ANO1P3618** from one Shri

Sudesh Kr. Mondal which is a BS IV complaint vehicle and intending to use the NOC for converting the vehicle into Transport Category for obraning permit. As, STA has mandated the condition of BS-VI for NOC / permit and in the instant case, the applicant requested for NOC for conversion of already registered Non-Transport vehicle which of BS-IV compliant, **STA did not consider the request of applicant.**

STA was appraised that **Shri. M S Sanjay** has applied for NOC for obtaining Cargo Permit to ply in all routes of NMS for the already registered BS-IV compliant vehicle bearing registration No. **ANO1 N 9744** (Maruti Eeco). The vehicle is presently registered in Non-Transport Category. As, STA has mandated the condition of BS-VI for NOC / permit and in the instant case, the applicant requested for NOC for conversion of already registered Non-Transport vehicle which of BS-IV compliant, **STA did not consider the rerquest of the applicant.**

Agenda Point No. 13

Issue of permit for mainland registered Non BS-VI complaint vehicle.

(i) STA was appraised that Shri. Subrat Kumar Singh has applied for issuance of PC permit for already registered mainland vehicle bearing registration No.UP60AT4983 (Maurti Super Carry BS IV) which is of BS IV complaint. The vehicle was manufactured in the year 2019.

As per the application and documents, the vehicle is registered in favour of the applicant in RTO Ballia, UP and NOC has been issued to RTO Port Blair. The vehicle is presently lying at Kolkata wharf for its further transportation to these Islands. As, STA has in its meeting has decided not to issue fresh permits to Non BSVI complaint commercial vehicles brought from mainland and in the instant case, the request of the applicant is to issue NOC for transportation of already registered vehicle to the UT for its commercial operation, STA did not consider the request of the applicant.

(ii) STA was appraised that **M/s Lal Baba Enterprises** has applied for issuance of PC permit for already registered 07 mainland vehicles (Oil Tankers). The details are mentioned as under:

In compliance to the direction of Hon'ble High Court, Temporary permits were issued for a period of four months which expired on 18.06.2022. In the meantime, Honble High Court vide order dated 28.07.2022 has directed the Department to consider the application for fitness of vehicles and subsequent re-registration as per the rules within four weeks. STA in its meeting dated 03/08/2022 directed the Registering Authority to dispose of the application submitted by M/s Lalbaba Enterprises by conducting the fitness inspection by 18.10.2022 in compliance to the direction issued by the Hon'ble Court and submit the report to STA for consideration of the case in the next meeting.

As per the report dated 23/08/2022, the registering Authority has conducted the fitness and re-registered all the 07 vehicles in this RTO.

Now, the firm has re-applied for the PC permit for all the 07 vehicles. In this regard, Temporary permits have also been issued for these 07 vehicles for a period of two months with the validity upto 05.12.2022. STA has deferred the request of M/s Lal Baba Enterprises in the next meeting for further decision.

Agenda Point No. 14

Decision on delay in submission of application for permit after obtaining NOC & registration of vehicle.

(i) STA was appraised that **M/s Annex Marine Engineers** has applied for PC Permit along with required documents on 26.09.2022 for their already registered commercial vehicle bearing Regn. No. **ANO1 Q 7111** (Bolero Camper-BS-VI).

The firm obtained the NOC from STA on 16/10/2020 and registered their vehicle in the RTO, Port Blair on 20.10.2020. However, the firm did not apply for regular permit at that time. Now the firm applied for permit stating the reason that they were not aware about applying of Permit.

It appears that the firm has plied the vehicle without permit for more than 01 year violating Section 86 of the MV Act. STA decided to defer the case for the next meeting and in the mean time, the report / recommendation of Committee on quantum of amount for various kind of violations of permit may got examined on circulation by the members of STA to take a uniform decision to impose penalties in all such cases.

(ii) STA was appraised that M/s Prasur Electrical & Engineering Co. had purchased Tipper bearing Regn. No. ANO1 L 3708 from Girdharilal Construction Pvt. Ltd. on 25.04.2019. After observing that the vehicle was plying without

permit since its registration on 11.08.2016, the registration of the vehicle was suspended for 03 months vide order No. 5383, dated 09.12.2019 which has been revoked vide Order no. 42, dated 02.01.2020 by imposing fine for Rs. 40,000/-which the firm had remitted vide DD No. 241716, dated 03.01.2020.

The NOC was then issued to the firm on 19.03.2020 which was valid till 19/09/2020. Based on the NOC the vehicle was transferred in the name of M/s Prasur Electrical & Engg. Co. on 06.11.2020 but the firm had applied for permit on 11.02.2022 i.e after a span of 02 years.

The case was placed in last STA meeting held on 02.09.2022 and it was decided to defer the case in next STA meeting with the direction to constitute a committee to Standardize the quantum of penal amount for various categories of violations in terms of fixed criteria covering all kinds of violation.

STA decided to defer the case for the next meeting and in the mean time, the report of Committee on the recommendation of quantum of amount for various kind of violations of permit may be got examined by the members of STA on circulation to take uniform decision to impose penalties in all such cases.

(iii) STA was appraised that **Shri. Sujit Kumar Das** has applied for PC Permit for North & Middle Andaman along with required documents on 10/05/2022 for their already registered commercial vehicle bearing Regn. No. **AN 01 Q 6427** (Bolero Pick up- BS-VI).

The applicant obtained NOC from STA on 15/11/2019 and registered his vehicle in the RTO, Port Blair on 22/04/2021. However, the applicant did not apply for regular permit at that time.

It appeared that the applicant has plied the vehicle without permit for more than 01 year violating Section 66 & 79 of the MV Act. Accordingly, a Show Cause Notice has been issued to the applicant vide Order No. 6929 dated 31/08/2022.

The applicant has now submitted his reply mentioning that due to non availability of spare parts, the vehicle was kept in the workshop and the vehicle was plying for its maintenance and not for any commercial purpose. Thereby, requested to issue PC permit for the said vehicle.

STA decided to defer the case for the next meeting and in the mean time, the report of Committee on the recommendation of quantum of amount for various kind of violations of permit may be got examined by the members of STA on circulation to take uniform decision to impose penalties in all such cases.

Revocation of Suspension/Cancellation of Permit

STA was appraised that **Shri. P Tamil Selvam** has applied for revocation of the cancelled 'reserve stage carriage permit' of vehicle bearing registration No. **ANO1 A8848**, which was cancelled vide Order No. 538 dated 22/02/2021.

The bus registration No. ANO1 A 8848 was given permit for 'reserve' against the bus bearing registration No. ANO1 P 8848 with the route from Bus Stand to Habdipur. But, the applicant was found plying said reserve stage carriage bus ANO1 A 8848 in other route 'Bus Stand to Manjeri' against the bus No.ANO1E6540, thereby violating Section 86 of MV Act. Accordingly, the permit of the vehicle bearing registration No.ANO1 A8848 was cancelled vide order No. 538 dt. 22/02/2021.

The applicant has submitted his request twice for the revocation of cancellation of permit vide letter dated 26/03/2021 and 08/11/2021, but his request for revocation has not yet been considered. STA observed that by cancelling the permit so the bus, the bus owner has already penalized due to non operation of the bus for more than 2 ½ Years, hence decided to revoke the cancelled permit.

Agenda Point No. 25

Fixation of fares for the cabs and commercial two wheelers operating in Swaraj Dweep:

STA was appraised in the meeting dated 02/09/2022 that due to absence of any fare regulation for the cabs and commercial two wheelers plying in Swaraj Dweep and Shaheed Dweep, regular reports on fleeing of tourists by the commercial vehicle drivers have been cropping up. This is not only creating inconvenience for the visiting tourists but also detrimental in the propmotion of tourism activity in the Island. In order to maintain a check on the excess fare charging and to eliminate the chances of unhealthy practice by the vehicle owners, STA in its meeting on 02.09.2022 decided constitute a Committee to examine all aspects and recommend the fares of cabs and commercial two wheelers plying in Swaraj Dweep and Shaeed Dweep under Section 67 of MV Act. The committee after analysing the present market rates, expenditure involved in operation of these commercial vehicles in these two Islands, demand of vehicles, tourists requirement etc has furnished its report/ recommendation for further examination & recommendation of STA. STA has examined the proposal and decided to send back the proposal to the Committee to re-examine the fares for the Cabs and commercial Two Wheelers with reference to the recent discussion held in SOM chaired by Chief Secretary.

Issue of NOC for Caravan Vehicles:

STA was appraised that Motor caravan means a "Special Purpose Vehicle (SPV)" of category M with living accommodation space which contains the following equipment as a minimum

- (a) Seats and table;
- (b) Sleeping accommodation which may be converted from the seats;
- (c) Cooking facilities;
- (d) Storage facilities.

This equipment shall be rigidly fixed to the living compartment. However, the table may be designed to be easily removable.

Quantum of penalties for various Permit Violations:

Many cases of various kinds of violations of permits by the commercial vehicle owners such as driving under the influence of alcohol, unauthorized parking, delay in applying for permit after registration, etc are being placed before STA for imposition of penal amount.

In order to standardize the quantum of penal amount for various categories of violations in terms of some criteria, with the decision of STA in its meeting

02.09.2022, a Committee has been constituted to analyze various aspects of violations. The Committee has furnished its report / recommendations which has been placed before STA for further consideration.

STA has decided that the report / recommendation of Committee on quantum of amount for various kind of violations of permit may be got examined by the members of STA on circulation to get it approved. Subsequent to the obtaining of comments/ approval, the report be placed in next STA meeting for acceptance.

Due to time constraint in the meeting for examination of other cases, STA decided to defer agenda points No.16, 17, 18, 19, 20, 21, 22, 23, 24 & 27.

It was decided that the next STA meeting will be held on 14.11.2022 at 5:00 PM.
